In its renewal application, Cyrano's Crepes and Books did not provide information showing it met the minimum operating requirements found in 3 AAC 304.170(j). Information provided indicates there are potential issues with number of hours opened, the business name under which alcohol is being served, and whether or not they are a restaurant. See memo from Investigator Whiteman.

Recommendation:

Deny the renewal application for lack of meeting minimum operational requirements per AS 04.11.330(a)(3) and 3 AAC 304.170(j), or require a waiver of operations application for 2016.

In early February 2017, Business Registration Examiner Shilo Senquiz had exchanged information with Lynn Murphy, bookkeeper for Cyrano's Crepes and Books, regarding minimum operation requirements for 2015 and 2016, Cyrano's Crepes and Book, LLC operated under the minimum operating requirements of 3 AAC 304.170 & AS 04.11.330.

On February 24, 2017, Enforcement Supervisor James Hoelscher advised me that Cyrano's Crepes & Books LLC, License 2724 did not provide the adequate documentation of minimum operation to the Licensing department.

On February 24th, 2017 I did contact Lynn Murphy through email and advised that documents were needed to confirm Cyrano's Crepes & Books complied with the minimum operating requirements.

Lynn replied by sending a revised application, a letter addressing each point of 3 AAC 304.170 and an excel spreadsheet of combined food and alcohol sales. These items did not meet the minimum operating requirements. On the revised application it was written "we ar (sic) open only on show day – usually 6 hours".

On February 27th, 2017 James Hoelscher and I did go to Cyrano's Crepes and Books to speak with Proprietor Sandy Harper and Bookkeeper Lynn Murphy. At 1:00 pm the Store front was closed and it was also noted:

There were several different business names besides their DBA.

They did advertise alcoholic beverages for sale in the Ghost Light Café, also Cyrano's. A Facebook page advertising food and alcoholic beverages sold by the Ghost Light café.

Photos were taken of the advertisements and storefront, during the meeting with Ms. Harper and Murphy a tour of the license premises was done and again it was noted: Their license was on display but there was not an RDP. Cyrano's Crepes & Books LLC 3/31/2017 Page 2

There was alcohol being stored behind the POS area.

The Kitchen did not have a working stove or ventilation hood required for an RDP. There was a question of the correct address for the DBA.

During a discussion of what was required it was mentioned by Ms. Harper and Murphy that there was an agreement to have Ms. Murphy operated the Ghost Light Café sales and another party operate the theater and sales, lease agreements are an item of interest should there be any.

Lynn was given a list of items needed for renewal – sales receipts and diagram, updated menu and the RDP if found, change the Facebook advertising.

On 3/2/2017 Lynn Murphy sent in an updated menu with a wine and beer list. Calls were made to Lynn and were not answered; messages were left requesting sales receipts and an updated diagram.

By 3/17/2017 the receipts of sale for 2015 & 2016, new diagram or diagram had not been received an email was sent requesting those items.

On 3/26/2017 Lynn emailed a transaction sheet with a diagram that did not meet requirements for 30 eight hour day operation for 2015 & 2016.

Cyrano's Crepes and Book, LLC operated under minimum operating requirements.



I have attached the revised application and look forward to hearing from you soon.


