Ms. Bayley applied for a restaurant or eating place – public convenience license under 3 AAC 304.335. This section of regulation requires that the license applicant show community support for the issuance of a license over population limits by submitting a petition signed by a majority of the residents 21 years of age or over who reside within one mile of the proposed premises. The local governing body must also approve the application.

According to the City of Homer, there are no residences within one mile of the proposed licensed premises, so there were no signatures required on the petition. The Homer City Council approved the license on May 30, 2017, and all other reviewers did not object. A temporary license was issued on June 1, 2017.

Recommendation:

Approve the license.


