DIRECTOR BRIEFING

Erika McConnell briefs the Board of AMCO updates.

She talks about theatre licenses with the Board members and asks if they would be supportive of staff's interpretation of 3 AAC 304.105(b) where it says "as appropriate" to not include the requirement under (b)(6) for theatre license applications.

Erika McConnell apologizes to the Board members that the packet was not available in advance of the meeting. She requests that the Board amend the agenda to address tabs 1-30 and 57-58 today, and have the remainder of the tabs be considered during a meeting next week. Steve Mitchell provides testimony regarding caterer's permits at Fairbanks Drama Association. He states that they work through Bobby's Downtown and that the ideal solution would be a theatre license. He passes out documents to the Board members.

Patty Burley asks if she will be able to talk about tabling of agenda items.

Representative Zach Fansler voices concerns about tabling the Bethel applications, as the City of Bethel has paid to fly people here today and made time to speak with the Board about the applications.

Beth McEwen, Juneau Deputy City Clerk, welcomes new members to the meeting and states that she will be following SB 76.

Leif Albertson, Bethel City Councilman, states that he flew here today to discuss specific items and that the City Council has worked very hard to have a systematic process, as alcohol has been a very controversial issue. He states that he doesn't know what the right thing to do is at this point, as far as moving forward, as he isn't clear when things will be heard.

Bobby Evans states that now would be a good time to talk about the agenda.

Steve Chung, applicant for Tundra Liquor Cache in Bethel, asked if the Board could squeeze one more tab in today.

Ellen Ganley states that at this point, most of the people who would provide testimony are assuming that it's not going to happen today.

James Hoelscher states that all of the recommended changes are there to make sure that there isn't any misinformation given out regarding Title 04. Joe Hamilton states that the course does hit all of the points outlined in the statute.

Dale Fox, President and CEO of Alaska CHARR, provides testimony regarding the TAP course, stating that he would need to appeal some of the requested changes. He passes out copies of the Title 04 book, copies of the TAP course books, and a memo to the Board with CHARR responses to the requested changes. He states that there are two issues that were brought up that are contrary to the law: "Adulteration or Misbranding of Alcohol" and "How to Calculate BAC", and then he goes through each of the requested changes one at a time.

Tom Manning asks if Mr. Fox has spoken with Investigator Hamilton about these issues. Dale Fox states that he has not and recommends that he appeal to the director. Ellen Ganley states that Investigator Hoelscher should be involved in that discussion.

Tom Manning moves to have Mr. Hoelscher, Mr. Fox, and anyone else who the director feels should be involved should get together on this to make sure that there's clarity. Rex Leath seconds the motion.
