Investigator was emailed a photograph of a Facebook post for the F.O.E. 162, club license #338, the post reads "Karaoke at the eagles @8pm everyone welcome even non members...we will have someone sign you in...", This is a violation of the club license Sec. 04.11.110. Club license.

(a) A club license authorizes a club or organization to sell alcoholic beverages for consumption only on the licensed premises.

(b) A club license may only be issued to a club, fraternal organization, patriotic organization, or social organization that has been (1) chartered by a state or national organization for a period of two consecutive years before application for a license under this section; or (2) chartered by a national organization and the national organization has maintained a chartered club or organization within the state for a period of at least 20 years. The organization licensed under this section must be operated for social, recreational, political, benevolent, or athletic purposes and not for profit. A club license may only be issued to an organization if none of the income from the sale of alcoholic beverages is distributed to its members, directors, or officers. Soliciting of public patronage of the club premises except as approved by the board is a violation of this section.



As requested, I am responding in writing to the Notice of Violation that we received on December 11, 2017. We received the request for records of sales to Klutina Lodge from your office on December 4, and immediately forwarded the invoices to your attention on December 7. As you can see, we did sell items to the account (18 total bottles of liquor; 7 on November 6, and 11 on November 14), but these sales were not approved by the sales manager or the President of the company as indicated in the complaint.

Our system of invoicing has the ability to open and close accounts based on seasonality, inability to pay, etc. This account was not closed in our system on October 31, as it should have been.

As a result, the account made some purchases in November to take advantage of some highly allocated bourbons and whiskeys that we had made available to our customers in November. Reviewing this issue, I have found some procedure areas in our company that need to be addressed so that seasonal accounts get properly closed at the conclusion of their season as listed on their license, so that we can not physically invoice or sell to them. I have since addressed these areas in our organization to insure that our route accounting system is updated and in compliance with the accounts' license (see attached procedure).

The complaint indicates that these sales were initially denied and then approved by the sales manager and the President of the company. This is not true, and is clearly an assumption that was made by one of our employees. We sell a large amount of spirits legally to our licensed customers in the State of Alaska and we would not risk our ability to do that over 18 bottles of whiskey. I can assure you that I did not approve this sale nor did the sales manager.

Our organization has some areas of clarification on seasonal accounts that I wanted to explore with the Alcohol & Marijuana Control Office to insure that we understand our responsibilities with our license:

"Can we sell to seasonal accounts prior to their opening date, if they do not plan on re-selling the product to the public prior to their opening and what period of time would be allowed?"

"If you can sell to a seasonal account prior to the opening date, can we sell to a seasonal account after their closing date if there is no intent to re-sell?"

"Finally, at one time, the Alcohol & Marijuana Control Office provided the seasonal opened and closing dates of the license on its website, is this data possible in the future?"

With these new procedures in place, we feel confident that this type of incident will not occur in the future at our company.

RE: Account Maintenance Procedure

It has come to my attention that our account profile in our VIP system has not been properly maintained and as a result, we have sold product to a customer with an expired seasonal license. This is a violation of our license under Title IV. In reviewing our systems and communications, it has become apparent through time that the roles and the responsibility of account maintenance has become unclear in our organization.

This memo will serve to clarify those roles and to institute new procedures to ensure that sales to non-licensed or seasonal accounts does not happen in the future.

New Procedure

The responsibility and duty for opening and closing accounts in our system is the sole responsibility of the Credit Manager for the Anchorage Market and the Fairbanks Office Manager for Southeast and Fairbanks accounts. A reminder system needs to be put in place to make sure seasonal accounts are unchecked as open and checked as closed in our system based on the dates on their issued license. This responsibility extends to managing account expiration dates and renewals. No one in the organization has the authority or ability to manage this process in our system.

The responsibility of opening new accounts is also the sole responsibility of the individuals listed above. New account license setup in our system needs to be verified by personnel listed above with direct contact to the Alcohol and Marijuana Control Office or a photo of the license obtained through the field.

A thorough review of our account files needs to be conducted in each market immediately to ensure that correct coding, license dates, license types and license numbers are properly entered in our system. This review needs to be conducted annually in February to ensure that our processes and procedures are being correctly implemented. This review can be assisted and managed by other administrators, but the above listed personnel need to be included.



On 10-11-2017 at approximately 1615 hrs. I conducted a routine inspection at the International Hotel & Bar, a beverage dispensary licensee, license number 556 at 122 N. Turner Street, Fairbanks, AK. When walking into the premises I saw a large sign posted on top of the building naming the business as "the BIG-I PUB & LOUNGE." I checked the liquor license posted in the premises to see what the Doing-Business-As (DBA) for the premises was as indicated on the liquor license. The liquor license listed the DBA as the "International Hotel & Bar."

In addition to the large sign mounted on the front of the building with the name "the BIG-I PUB & LOUNGE" I saw a banner displayed along the Illinois Avenue facing fence of the property with the business name "the BIG-I PUB & LOUNGE" printed on it. On the back side of the building was a banner with "the BIG-I PUB & LOUNGE" printed on it along with "International Hotel" printed in smaller font below "the BIG-I." I visited the licensee's Facebook page and saw the DBA on the Facebook page is "the BIG-I PUB & LOUNGE." I have also heard local radio station ads for events at the premises and it announces the premises as "the BIG-I PUB & LOUNGE." A check of licensing files revealed the listed DBA is the "International Hotel & Bar."

This is a violation of 3 AAC 304.185:

(a) A license is issued for a specific place which is the licensed premises and which must be clearly designated in a line drawing accompanying an application. The licensed premises must be one area, but may include separate rooms if the rooms are adjacent to one another or if they are rooms described in AS 04.11.090(d). On Monday November 13th I signed a certified letter receipt# 7016 0910-0000 9694 4040, from our mail carrier. Upon immediately opening and reading my first ever (Notice of Violation) per 3 AAC 304.525, listed under 3 AAC 304.185: Licensed Premises (a). I was still unclear as to what might have arisen that I might have inadvertently violated this specific regulation. First let me apologize for any lack of understanding on my part of this regulation. Currently my DBA: International Hotel & Bar is listed and accompany all city, state, Federal & permit applications up to and including catering permits. I believe sections (a) & (b) I am following, however section (c) indicates AMCO provides form# AB-13 for "Business Name Change". My request and hopes are to keep my current DBA listed as the International Hotel & Bar. This premise and its landmark has a long history here in Fairbanks as one of the oldest Beverage Dispensary Licenses issued by our State of Alaska Alcohol Control office back in 1956, but the International Hotel dates back to 1920. I would like to request an appearance before the director and be heard regarding the notice of this violation.

My averseness to this request to a change my DBA from International Hotel & Bar to The Big-I Pub & Lounge is simply reasoning to the following explanation listed in the next paragraph.

In essence, a DBA is the business version of "a/k/a" (also known as). For example, International Business Machines Corporation is known as IBM. As far back as 1971 over 45 years ago the aka: Big-I took the form of a nick name for the International Hotel & Bar because of the letter "I" in International was bigger than all the other letters. I did not initiate this aka only followed suite as to not rock the boat on a long-established tradition of identity and the following business characteristics.

under a rumored name for a variety of reasons:

- A Hotel no longer exists on the 2nd floor,

In closing please let me state by no means had I known that AMCO viewed the use of The Big-I as a violation of my Licensed premises, I have read and seen hundreds of articles, stories, biographies', sport trophy's dating back to early 80's listing our establishment as The Big-I. I had only hoped that on Oct 11th I would have been onsite to meet with the issuing Investigator Mr. Michael Chiesa and asked that he use at his discretion the NOV verses and advisory notice as is stated in 3 AAC 304.525 D2. My on-duty bartender indicated that Mr. Chiesa acknowledge everything was fine and left my premises. I had been alerted by my Insurance carrier days later as I was binding a new Liquor Liability policy 2017-2018 that I was under investigation by AMCO, much to my astonishment I was dismayed that my Insurance carrier knew before me that I was under an investigation. This does not speak well to the relationship I thought I had with AMCO after 11 years, 5 months and 6 days. I also followed up with a call to inquire about his visit and if I could assist in answering any questions. I did not receive a call back. Now I'm between a rock and a hard place I only hope that my insurance carrier has bonded my Liquor Liability! I look forward to your response and openness from here forward. My reputation and respect for this industry and my business is above all relentless.

Your response to the issued violation is not consistent with the reason why the violation was written.

I want to make sure that you understand that during a catered event, you can't sell alcohol from your license.

A caterers permit allows the BDL to sell or dispense alcoholic beverages, essentially temporarily creating an licensed premises for an approved event and time period. The caterers permit does not allow for a manufacturer license to sell alcoholic beverages on their premises during that time. Once the permit is issued, the licensee that is catering the event is responsible for the premises until the event is over.

Your license type does not allow for sales after 8pm or entertainment and would need to stop operating in anyway, to include serving from the tap and/or selling alcohol from your point of sale.

I appreciate your willingness to work with us and understand. If you have any questions, please contact me.

Sec. 04.11.230. Caterer's permit.

(a) A caterer's permit authorizes the holder of a beverage dispensary license to sell or dispense alcoholic beverages at conventions, picnics, social gatherings, sporting events, or similar affairs held off the holder's licensed premises. The permit may only be issued for designated premises for a specific occasion and for a limited period of time.

(b) The written approval of a law enforcement agency having jurisdiction over the site of the occasion for which the permit is sought must be obtained and accompany the application.

(c) A caterer's permit may not be transferred or renewed.

(d) A caterer's permit must be surrendered to the board, its agent, or the law enforcement agency approving the permit within 48 hours of its expiration time. Failure to surrender the permit is cause, in the discretion of the board, for denial of applications for permits made in the future by the permittee.

(e) The fee for a caterer's permit is \$50 and shall accompany the application for a permit.

Sec. 04.11.130. Brewery license.

(a) A brewery license authorizes the holder to operate a brewery where beer is manufactured and bottled or barreled for sale.

(b) The holder of a brewery license may sell beer in quantities of

(1) not more than five gallons a day to an individual who is present on the licensed premises for consumption off the premises;

(2) more than five gallons a day to a person who is licensed under this title, or in another state or country.

(c) The holder of a brewery license may permit a person to sample small portions of the brewery's product free of charge unless prohibited by AS 04.16.030.

(d) The biennial brewery license fee is \$1,000.

(e) Unless prohibited by AS 04.16.030, a holder of a brewery license may sell not more than 36 ounces a day of the brewery's product to a person for consumption on the premises if

(1) the brewery does not allow live entertainment, televisions, pool tables, dart games, dancing, electronic or other games, game tables, or other recreational or gaming opportunities on the premises where the consumption occurs; (2) the brewery does not provide seats at the counter or bar where the product is served; and (3) the room where the consumption occurs is not open before 9:00 a.m. and serving of the product ends not later than 8:00 p.m.

Can you please confirm by way of a separate response that we know you understand the reason for the violation.

The behavior noted in the violation notice is not tolerated by myself nor my business. The employee in question was immediately suspended for a 3 week period to get his personal life in order and decide if he could conduct business like a professional.

To ensure this conduct does not occur again, my wife and I are regularly monitoring an 8 camera surveillance system for the establishment and doing periodic unannounced drop ins to the bar on all shifts for all bartenders. I have purchased a home breathalyzer and every bartender is required to submit a breath sample at any time during their shift upon request.

We are working closely with all of our neighbors to keep our corner well maintained and safe for all of our customers.

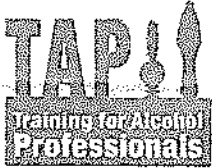

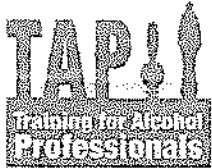
