**Background:** The Duck Inn is a dining and lodging facility in the Kenai Peninsula Borough (KPB) that holds a beverage-dispensary tourism license. The facility has 20 rental rooms and dining facilities. The current population of the KPB is 37,986; beverage dispensary – tourism licensees in the KPB are required to provide 40 rental rooms in accordance with AS 04.11.400(d).

Research on beverage-dispensary tourism licenses found that The Duck Inn was first licensed in 1985, which was the same year that the rental room requirement was changed from a flat 10 room requirement to a sliding scale based on population. The changes to AS 04.11.400(d) became effective on June 6, 1985. Our files indicate that The Duck Inn was first issued a license on November 21, 1985, but it is not clear whether or not that is the date that the board approved the license or the date that the license was issued to the licensee. The Duck Inn had 20 rooms in 1985, and a rough estimate of the population of the Kenai Peninsula Borough in 1985 (not including municipalities within the borough) is 23,500, which means 35 rental rooms would have been required at the time. Five license transfers have been approved for The Duck Inn since 1985; the latest one was approved in 2011.

ABC Board meeting documentation (agendas, minutes, etc) from 1985 is not kept in our office. We are seeking this information in our archives, but the archived material is not well-labeled so these efforts are taking some time.

I recommend that the board renew this license for six months (authority for a shorter licensing period is in AS 04.11.680(a)) to give the staff time to find board meeting documentation from 1985.

Should the board accept this recommendation, we would bring this license back to the board at the June meeting.
