**Requested Action:** Move to authorize North Pacific Auctioneers, acting on behalf of Best

Storage, Inc., to conduct a public auction to sell 2,450 bottles of wine and

liquor as listed for the board, without a license, as allowed by AS

04.11.020(a).

Statutory Authority: AS 04.11.020(a) states, "license or permit is not required to authorize

sales made by a person under a judgment and decree of foreclosure, under the bankruptcy law of the United States, or under order of the

board or a court under AS 04.16.220." (emphasis added)

Staff Recommendation: Approval

**Background:** As noted in the attached letter, Best Storage, Inc., is foreclosing on property stored at one of their facilities by a past licensee, including a substantial collection of wine and spirits. Best Storage, Inc. is looking to sell the collection by auction to recoup some of the money owed to them by the customer who originally stored the property. Details of the proposed auction are in an attached email.

Title 4 requires a license or permit to sell alcohol (AS 04.11.010(a)) but provides an exception in AS 04.11.020. This section of statute states that a license or permit is not required to authorize sales under order of the board.

Other options considered to address this situation were:

- 1) A wine auction permit under 3 AAC 304.699. A wine auction permit cannot be used for this situation as only nonprofit fraternal, civic, or patriotic organizations are eligible for a wine auction permit, and the organization must be the beneficiary of all profits of the auction.
- 2) A retail stock sale license under AS 04.11.200. A retail stock sale license cannot be used for this situation as it can only be used to sell the remaining stock of a package store when the owner wishes to close out or terminate the business of the store.

Dear Erika McConnell,

I represent Best Storage, Inc. which operates a number of self storage facilities in Anchorage. One of Best Storage's customers is Daniel G. Jacobsen. Jacobsen owned the Corsair Restaurant, which was located in the basement of the Voyager Hotel in Anchorage. Approximately five years ago, a water line broke in the building and flooded the restaurant. The restaurant closed and never reopened. Jacobsen moved his restaurant equipment, including the Corsair's substantial wine and liquor collection, into a number of Best Storage storage units. Attached to this letter as Exhibit A is an inventory of that wine and liquor inventory. For years, he paid his rent timely. About a year or so ago, Jacobsen got behind. He now owes in excess of \$38,000.

Alaska law, specifically AS 34.35.220 et seq, grants liens to entities such as Best Storage that keep or store personal property at the request of the owner of that property. There is a process under which those liens may be foreclosed: the process includes giving notice and sale by public auction.

Best Storage desires to sell the wine and liquor that the Jacobsen storage units, in a manner consistent with ABC Board requirements. AS 04.11.020(a) provides that a license or permit is not required to authorize sales made by a person under a judgment, under the bankruptcy laws, or under order of the board.

Best Storage requests that the ABC Board authorize the sale, by public auction, of the items listed in Exhibit A. The auction will be conducted by North Pacific Auctioneers, and will be scheduled once the ABC Board grants approval of the sale. Best Storage's lien law rights are very similar to what its rights would be as a judgment holder, and the sale process is essentially identical to the process that would occur if a bankruptcy trustee were to conduct the sale.

As I do not practice regularly before the ABC Board, I am unclear as to whether the ABC Board can approve this request administratively, or if this request must be decided at a formal meeting of the board. Accordingly, I request that this request be granted administratively without a hearing. Alternatively, I request that this matter be put on the agenda for the January 23, 2018 meeting of the Alcoholic Beverage Control Board, and that I be permitted to attend that meeting telephonically.

If you need any additional information in order to rule on this request, please advise.
