**Staff Recommendation:** Approve new license with delegation; instruct licensee to apply for a

duplicate license at next renewal period instead of renewing this license.

**Background:** This application is for a new beverage dispensary – tourism license in the Denali Borough. The Denali Borough does not protest. Approvals from the Department of Environmental Conservation and from the Fire Marshal are pending. Background investigations are pending.

The population of the Denali Borough is 1,810, which requires a tourist facility with at least 20 rental rooms. The Denali Bluffs Hotel provides 176 guest rooms.

The applicant already has a beverage dispensary – tourism license at the Denali Bluffs Hotel (#4280 Mountaineer Grill & Bar), but the hotel has more than twice the number of guest rooms required for a single license. However, statute provides for situations where one facility has alcohol service in two different locations through the duplicate license provisions at AS 04.11.090(e). The licensee should have been directed to apply for a duplicate license.

#### Tourism Statement - Denali Bluffs Hotel - Perky Moose

- 1. Explain how issuance of a liquor license at your establishment has/will encourage tourism. The Denali Bluffs Hotel is a 176 Room, Seasonally Operated, Full-Service Hotel property located within a mile of the entry to Denali National Park, Alaska's premier Tourist Destination. Many Visitors to Alaska, and certainly to Denali, require both appropriate and desired Hotel accommodations and amenities as part of their itineraries, to include Food & Beverage services, including the opportunity to purchase adult style beverages. The Denali Bluffs Hotel provides such services to approximately 35,000 guests, the majority of which are tourists, each Season.
- 2. Explain how the facility was/will be constructed or improved in accordance with this application.

  The Perky Moose, at the Denali Bluffs Hotel, is a 35 seat restaurant that will provide breakfast, lunch, dinner, snacks, coffee and espresso. As a very large percentage of our patrons at the Mountaineer are adults, on vacation, their ability to order adult style beverages to accompany their dining choices ensures a high level of service and satisfaction for their stay at the Hotel. The only alcoholic beverages to be sold in this location will be beer and wine.

  Grande Denali, LLC will be the operator of the Denali Bluffs Hotel and the Perky Moose.




