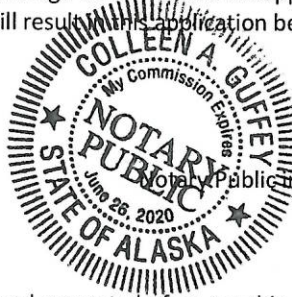

- 1.) Located outside of Denali National Park the McKinley Denali Salmon Bake operated from May-September during the busy tourist season. Located across from the Princess hotel properties "The Salmon Bake" offers tourists and locals alike one of only a few local Alaskan owned and operated businesses located in the busy "Glitter Gulch" area. Operating for lunch and dinner service and the only full service late night dining area serving food past 11pm "The Bake" has been a steadfast provider of Alaskan Hospitality for over 25 years in the area.
- 2.) Over the years "The Bake has had continuous improvements made to the facility. Because of the historic nature of the restaurant, the building had undergone constant renovation and repairs to ensure that while it still holds its historic Alaskan charm it also can be kept clean and sanitary from year to year.
- 3.) The facility is operated by and has been operated by Denali Visions 3000 and Alaskan corporation established in 2004.
