She informs the Board and public that the next ABC Board meeting is scheduled for April 3 in Nome. Applications must be complete and any other documents for the board must be submitted to our office by March 16 to be on the April agenda.

Erika McConnell informs the Board that this bill was introduced by Rep. Tuck and would amend AS 04.11.170 by adding two new subsections which would add clarification to acts permitted by distillery licenses.

Bob Klein states that because two new Board members will start at the next meeting, that a vice chair should be elected at that time. He recuses himself from discussion and voting and passes the gavel to Ellen Ganley.

E. Beverage Dispensary – Tourism License Report

10:00am TAB 8

Erika McConnell reminds the Board that in September, 2017, there were 34 licenses that did not meet statutory requirements under AS 04.11.400(d)(1), and nine were undetermined. She informs the Board that before June 6, 1985, the room requirement across the Board for tourism licenses was 10 rooms, regardless of the population. On June 6, 1985, a graduated scale was implemented. She adds that many of those seemed to be in compliance at the time of issuance, but that a grandfathering provision does not exist in the statute. She recommends that a legislative solution be pursued for those licenses that were compliant at the time they were first issued. She states that the staff will continue to bring tourism license applications to the Board to consider on a case-by-case basis.

Pete Hanson, Alaska CHARR, states that there are multiple proposals being drafted in the legislature right now, and he does not believe that HB 265 will be the one that moves forward. He recommends that the Board make a more general resolution of support, versus one for a specific bill.

Ellen Ganley moves to support a statutory change that would grandfather the hotels that met the number of rooms at the time of issuance.

Rex Leath seconds the motion.

Motion carries unanimously.

Tracy LaBarge, Genuine Ventures, requests clarification regarding the section of restaurant or eating place renewal license applications, which require the applicant to provide gross and food sales receipts. She states that she feels like that information is proprietary.

Mary Jackson, Kenai Elks Lodge, informs the Board that she received a temporary license yesterday, and she states that the application should be on the delegated consent agenda. Bob Klein reminds her that this public testimony time is only for items that are not on the agenda.

Don Cotogno, Homer Elks Lodge, states that he received a notice of violation and asks whether he should speak during Tab 15.

Bob Klein states that he should.

Patty Burley, City of Bethel, states that the City has been getting inundated with applications for special events permits from nonprofit corporations that aren't clearly nonprofit fraternal, civic, or patriotic organizations.

Erika McConnell states that Ms. Burley seems to be requesting that the Board define "nonprofit fraternal, civic, or patriotic organizations" for purposes of AS 04.11.240.

Bob Klein requests that the staff bring more information to the next meeting.

BOARD INTERPRETATIONS

A. Interpretation of "Controlling Interest"

Erika McConnell briefs the Board on how the staff has been determining when a transfer of controlling interest would be necessary. She requests that the Board formally support the staff's interpretation or provide alternative guidance.

The Board members discuss the issue and seem to generally agree that they are not concerned with percentages held if new people are not coming in.

Erika McConnell requests the Board to form a subcommittee to discuss the issue and come up with a policy.

Rex Leath volunteers to participate on the subcommittee.

B. Guidance for Package Stores in Relation to Events with On-premises Consumption

10:28am

TAB 10

Erika McConnell briefs the Board on what the staff has been determining is an appropriate role for package store licensees to play at events where on-premises consumption is permissible.

The Board members agree that they would prefer a licensee who has alcohol server education to pour at the event, rather than someone who does not have the education.

Erika McConnell states that public perception that a license type that is not authorized to serve for onsite consumption is actually doing that is a major issue.

Bob Klein states that he does not care about public perception.

James Hoelscher states that the issue is the perception that the package store has a mobile premises and is holding the event, rather than the permit holder or licensee. He adds that he does not have an issue with the package store licensees or employees pouring.

Bob Klein states that if a civic organization invites a retailer to help them serve and explain the wine at an event, he is has no problem with that.

James Hoelscher adds concerns about wine memberships for the package store being sold at the event.

Bob Klein states that the transaction occurs at the time that the actual alcohol changes hands.

No action.

C. Other Manufacturing License Issues

10:42am TAB 11

Erika McConnell informs the Board that staff is requesting guidance regarding a definition of entertainment. She requests that the Board open a regulations project.

Bob Klein states that he is not going to recuse himself because the Board is just determining how to proceed.

Ellen Ganley moves to open a regulations project to add clarity to "entertainment" and "other recreational opportunities" regarding permitted acts by manufacturing licensees.

Rex Leath seconds the motion.

Bobby Evans states that in the meantime, staff should use it best judgement on how the law is written.

Tom Manning states that he would support the regulations project, but he does not support manufacturing licensees offering entertainment.

Ellen Ganley states that she would like to know how the staff intends to enforce the statute. Erika McConnell states that her recommendation is in her report with this tab.

Ellen Ganley states that it looks like too strict of an interpretation. She states that there is no danger to the public or public safety here.

Harriet Milks reminds the Board that some years ago, the Board struggled with a similar issue regarding recreational site licenses and what acts would be permitted. On that issue, the Board ultimately adopted a recommendation from the OAH (Office of Administrative Hearings) to stick to a strict interpretation of the statute.

Bobby Evans states that he supports staff in following the strict interpretation of statute until the rules are changed.

Tom Manning states that he agrees with Bobby, in that manufacturing licensees are not allowed to provide entertainment; that is restricted to BDLs (beverage dispensary licenses).

Motion to open a regulations project carries unanimously.

Bobby Evans moves to follow staff recommendations on the memorandum from the director regarding other manufacturing license issues.

Tom Manning seconds the motion.

Bob Klein recuses himself and hands Ellen Ganley the gavel. Motion carries, 3-1 (Ellen Ganley votes No).

Ellen Ganley passes the gavel back to Bob Klein.

D. Pricing and Marketing of Alcoholic Beverages

11:04am TAB 12

Erika McConnell informs the Board that staff is requesting guidance regarding pricing and marketing of alcoholic beverages, and whether advertisements for beer drinking contests using non-alcoholic beer would be violations.

Rex Leath asks James Hoelscher to clarify whether these events are occurring on licensed premises.

James Hoelscher states that these events are occurring on licensed premises. He cites AS 04.16.015(a)(6) and (b).

Rex Leath states that AS 04.16.015(a)(6) does not prohibit use of nonalcoholic beer or water in games, which means that AS 04.16.015(b) does not prohibit the advertisement of such.

Erika McConnell states that licensees are advertising beer pong, with an asterisk and fine print stating that nonalcoholic beer is being used.

James Hoelscher states that at the next Board meeting, there will be an NOV with an example of an advertisement that violates that section.

Rex Leath states that if a licensee wants to falsely advertise that it will have alcohol at an event, when it does, the issue will be self-regulating.

Tom Manning states that his interpretation of the intent is to prevent promotion of excessive drinking, and that he agrees with Rex.

Ellen Ganley states that she also agrees with Rex.

Bobby Evans states that he does not think it is a good practice for the Board to weigh in on these things when the Board has bigger things to deal with. He states that the Board has to trust the enforcement staff and director to do their job and enforcement the law. He does not want to micromanage the Board's enforcement agency and take up valuable time.

Bob Klein states that he agrees with Rex, Tom, and Ellen that the statute is clear – that it regulates alcoholic beverages, not nonalcoholic.

James Hoelscher informs the Board that a Criminal Justice Technician, Jason Davies, started with AMCO on January 2, 2018. He adds that he has been working with the Department of Health & Social Services to reinstate the compliance check program. He updates the Board on enforcement statistics for calendar year 2017.

B. Notices of Violation Issued and Licensee Responses

1. Unreported Ownership Changes

11:44am

TAB 14

Erika McConnell informs the Board that these NOVs were issued for unreported ownership changes that came to light through renewal applications. She adds that she does not plan on pursuing additional disciplinary action for any of these.

2. All Other Notices of Violation

11:45am

TAB 15

Erika McConnell informs the Board that she has not yet had a chance to review these NOVs to determine whether she plans to pursue additional disciplinary action. These may come back to the Board with a recommendation at a later meeting.

Don Cotogno, representing Homer Elks Lodge and AJ's Steakhouse, provides testimony regarding an NOV issued and historical business practices between the two licensees. He states that AJ's Steakhouse has been pulling caterer's permits for the Homer Elks Lodge for years so that the Elk's Lodge could hold events that are open to non-members, and that the Elk's Lodge has been serving its own alcohol at all of the events. He adds that it is unreasonable for AJ's to cart down alcohol to the Elk's Lodge every time there is a catered event.

Erika McConnell informs the Board that this NOV is not included in the packet because the licensee response was not received in time to make it into the Board packet. She reads AS 04.11.110 and AS 04.11.230 for the record, and articulates that the latter clearly states that a caterer's permit authorizes the holder of the beverage dispensary license to sell or dispense alcoholic beverages at the events, not the club licensee. She adds that the staff considered whether the club licensee could purchase the alcohol from the beverage dispensary licensee, but that AS 04.16.172 prohibits it.

Don Cotogno states that the Elk's Lodge will have to stop making the charitable donations that it makes because it will no longer be able to hold those events.

Bob Klein states that during events for which AJ's receives caterer's permits, AJ's would have to provide the alcohol.

Bob Klein states that he has a problem with the NOV that was issued to K & L Beverage Company for selling alcohol to Klutina Lodge during times that are not included within Klutina Lodge's seasonal dates.

Erika McConnell states that AS 04.11.680 states the times when a seasonal license is effective, and that during times when the license is not effective, the licensee does not have the privilege of performing activities limited to licensees.

Bob Klein states that he disagrees, and that he thinks that just because a licensee has a seasonal license, and as long as no sale to customers takes place, it should not be prohibited from doing other licensed activities.

Ellen Ganley and Rex Leath state that they agree.

Erika McConnell states that it poses an enforcement challenge.

Rex Leath asks whether seasonal licensees would be required to remove all alcohol from its premises once its season is over.

The Board members voice and nod in agreement that this would not constitute a violation.

Bobby Evans states that at the last Board meeting, he had requested that the staff provide recommended actions regarding NOVs.

Tom Manning asks whether seasonal licenses are surrendered at the end of a season.

Erika McConnell reads 3 AAC 304.195 regarding surrender of a license.

Paul Thomas reads part of AS 04.11.680 for the record, stating that licenses are effective for two years ending on December 31.

Sarah Oates reads AS 04.11.680 in its entirety, which clearly states that those effective dates pertain to licenses that are not seasonal.

Bobby Evans states that the staff used to bring lists of pasts sanctions that were implemented by the Board for violations and requests that that start happening again.

Sarah Oates clarifies that those lists were brought to the Board when the Board was considering sanctions in response to a conviction under AS 04.11.370(a)(4). Because there have not been any Title 4 convictions for quite some time, that list of sanctions has not been brought back before the Board. She states that the staff can start bringing a similar list for the Board's reference when staff is recommending sanctions for violations through the accusation process.

Bob Klein states that he has an issue with the NOV issued for the International Hotel & Bar for having its sign say "Big I".

Bob Klein recommends a form change that would have the licensee put the name it plants to place on the building.

Request for reinstatement and renewal

Erika McConnell informs the Board that the Elks Lodge, license #368, submitted a license renewal application on December 15, 2016. Multiple incomplete letters were sent to the licensee via email and mail, but the application was never completed. The license was expired on July 31, 2017, yet during an inspection on December 12, 2017, it was discovered that the establishment was selling alcohol without a license. A request to reinstate and renew the license is before the Board.

Mary Jackson, representative for Kenai Elks Lodge, provides testimony regarding her history with the Elks Lodge and her knowledge of the license renewal application. She references the documents in the tab and addresses the director's recommendation for denial due to lack of proof of good cause. She states that she disputes the phone call messages and adds that there is a communication problem between the staff and the bartender.

Rex Leath states that it is apparent that numerous contacts were made by staff to attempt to get the license in good standing, granted that some of the dates may be in disagreement, and that it is the responsibility of the licensee to ensure that everything is in order. He adds that he feels that the State did a reasonable job of notifying the licensee, and that it's the licensee's due diligence to ensure everything is in order.

Bob Klein states that he is hard-pressed to allow for reinstatement, especially considering there are new club licenses available.

Mary Jackson asks about her refund for the \$1400.

Bobby Evans moves to deny the request for reinstatement and renewal. Rex Leath seconds the motion. Motion carries, 4-1 (Tom Manning votes No).

Sarah Oates clarifies that the refund will be for \$1200, as the application fee is non-refundable.

Erika McConnell informs the Board that The Duck Inn is a license that the staff is not sure was in compliance when it was first issued. The Duck Inn had ten rooms when it was first issued the license, but the change in the statute on June 6, 1985, would require twenty rooms. The license was issued on November 21, 1985, but it is unclear at which Board meeting the application was considered and approved. She requests that the Board renew the license for six months, as authorized under AS 04.11.680(a), to provide staff time to obtain records from 1985 and determine at which Board meeting the license was approved.

Pete Hanson, Alaska CHARR, states that he is afraid that a six-month renewal would be setting a precedent, and that he is unsure why the Board is treating The Duck Inn differently.

Ellen Ganley states that the licensee has been operating for 33 years and that the Board should respect how long the license has been operating.

Ellen Ganley moves to renew the license for two years.

Tom Manning seconds the motion.

Rex Leath states that it is reasonable to look at the six-month recommendation, and that the licensee is as obligated as the state to operate in compliance with the laws.
