Statutory3 AAC 304.185(c): "A licensee may not alter the functional floor plan, reduce orAuthority:expand the area, or change the business name of the licensed premises without the<br/>prior written approval of the director."

Staff Rec.: Table the premises change request


**Background:** The licensed premises for the Alaska State Fair includes eight distinct and separate areas. This appears to be out of compliance with 3 AAC 304.185 which states:

The licensed premises must be one area, but may include separate rooms if the rooms are adjacent to one another or if they are rooms described in AS 04.11.090(d).

The state fairgrounds are large, and licensing the entire area is not a viable option, as minors frequent the fair without adult accompaniment. Requiring the fair to apply for and maintain eight recreational site licenses is not a viable solution as only three recreational site licenses are possible in the City of Palmer, and two of the three are issued.

Staff has proposed that the board consider a regulations change that allows recreational site licenses to maintain non-contiguous licensed premises with board approval. This proposal is on the agenda for board consideration at Tab 180.

# Waterin' Hole FKA Chili COOK OFF


