## Tourism Statement

### # 3823 Resurrection Roadhouse

Resurrection Roadhouse is located at Seward Windsong Lodge and is owned by CATC Alaska Tourism Corporation (CATC). CATC maintains excellent working relationships with cruise ship companies and many tourism industry businesses to sell its services to.

Seward Windsong Lodge and Resurrection Roadhouse are located just minutes from downtown Seward on Herman Leirer Road in scenic Resurrection Valley. The lodge features 180 well-appointed rooms that include small refrigerators. Ten suites include microwave ovens in them as well. None of the rooms are stocked with food or alcohol.

In addition to the dining room, deck and lounge where food and beverages are served, the Resurrection Roadhouse includes meeting space to accommodate groups up to 60 guests.

The hotel lobby provides a tour desk to book a variety of local tours that include glacier and wildlife day cruises, fishing, guided hiking at Exit Glacier, sea kayaking and zipline tours. The lodge provides shuttle services to town for guests to shop or get to the tours they have chosen.

While there have not been any recent construction projects, work has been done to keep furniture and fixtures in top working order.
