The Community Council field only should be verified/completed by licensees whose establishments are located within the Municipality of Anchorage or outside of city limits within the Matanuska-Susitna Borough.

This form must be completed correctly and submitted to the Alcohol & Marijuana Control Office (AMCO)'s main office, along with all other required documents and fees, before any renewal license application will be considered complete.





We are pleased to report that this Beverage Dispensary-Tourism license, which is located at the Ted Stevens Anchorage International Airport, has reported ongoing successful seasons of promoting tourism in Alaska through our focus on 'Made in Alaska' beer, wine and spirits products, as well as enhancing the experience of the traveling public (tourists) on their journeys during the preceding license period by making these 'Made in Alaska' beer, wine and spirits available at Alaska's major air transportation hub for both on- and off-premise consumption (via adjacent Package Store License# 5121).

In the previous license period (2016-2017), we have served approximately 500,000 patrons in a full-service establishment which includes a full food menu, for which the majority of our sales have actually been for food or other non-alcohol items. The entirety of our patrons are behind TSA security screening checkpoints, either enplaning or deplaning, with the vast majority being tourists or air travelers to/from the State of Alaska (with the remainder being badged airport employees).

There have been no changes in ownership or operation of the license since the previous renewal period. We look forward to continuing to promote tourism in the Anchorage Airport location, and to provide responsible alcohol service to the traveling public in the future license period.
