This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will received an Accusation and Notice of your right to an Administrative Hearing.

You are now receiving another notice of violation for failing to communicate with the Alcohol & Marijuana Control Office. A violation of 3AAC304.525: Communication with licensees.

**VIOLATION:** This office received e-mail from DOL Investigator J. Hartlieb that they had received a complaint of under 21's working on a licensed premises without work permits. A spot check by DOL Investigator revealed two persons under 18 were identified as working without permits. This is a violation of Title IV.

**You are directed to respond to the Director of the Alcohol & Marijuana Control Office in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a reoccurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD OF DIRECTORS AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.**


