Requested License renewal Action:

StatutoryAS 04.06.090(b): "The board shall review all applications for licenses made under
this title and may order the director to issue, renew, revoke, transfer, or suspend
licenses and permits authorized under this title."

Staff Rec.: Approve the renewal

Background: This recreational site license appears to meet the statutory requirements of the license type:

Sec. 04.11.210. Recreational site license.

(a) The holder of a recreational site license may sell beer and wine at a recreational site during and one hour before and after a recreational event that is not a school event, for consumption on designated areas at the site.

(b) The biennial fee for a recreational site license is \$800.

(c) In this section, "recreational site" includes a location where baseball games, car races, hockey games, dog sled racing events, or curling matches are regularly held during a season.

The board should clarify with the licensee that "special events" where alcohol is served under this license must be limited to competitive sporting events in order to comply with AS 04.11.210. This is consistent with direction the board provided to License #4895, AK Tuesday Night Fights, where the licensed premises (the Curtis Menard Sports Complex in Wasilla) can be used for non-sporting events such as concerts.

In addition, the licensed premises of this facility is regularly used for youth sports (as stated in the recreational site statement), and it is likely that minors are regularly on the premises without a parent or guardian, in violation of AS 04.16.049. In his statement, the licensee hints at the concept of alternating premises under 3 AAC 304.225, but an alternating premises diagram has never been

approved by the board. The board should require the licensee to submit a written request for alternating licensed premises under 3 AAC 304.225 before the next time alcohol is served at this licensed premises, or submit information showing that no unaccompanied minor is ever permitted on the licensed premises.

The "Gardens" located within the O'Malley Sports Center



O'Malley Ice and Sports Center the Licensee, has operated the "Gardens" within the 45, 000 square foot O'Malley Sports Center since January 1,2007. The O'Malley Sports Center is a multi- recreational facility hosting youth and adult sports including basketball, volleyball, dodgeball, badminton, pickle ball, martial arts and other. The facility is open 350 days per year, usually opening at noon and closing at 12:00 pm. The O'Malley Sports center experiences about 250,000 visitations on an annual basis. Presently about half of the building area within the Center is leased to the "Get Air Trampoline Park".

The "Gardens" operates only during special events hosted in the facility that are adult oriented with the spectator volumes sufficient to support the beer and wine sales. Snack foods and concession style foods are also sold at these special events. The Premises of the Gardens is a designated area within the recreational space that is cordoned off and managed for beverage service during special events. During the special events and tournaments, the operating hours of the Gardens follows the special event and tournament activity times opening one hour before and closing not later than one hour after the event ceases.

The Gardens alcoholic beverage sales activities are managed by a food and beverage professional. All beverage service personnel receive "TAPs" training. Inventory purchases and sales are continuously recorded and reported as a component of a CPA reviewed financial statement. The executive management of the O'Malley Sports Center and its "Gardens" continues to be the two individuals who founded the facility in 2001, Mr. Steve Agni and Mr. Sig Jokiel.
