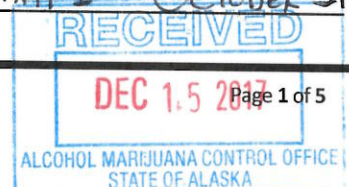

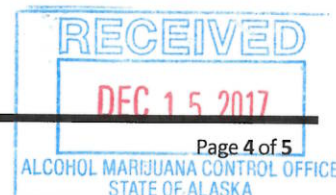

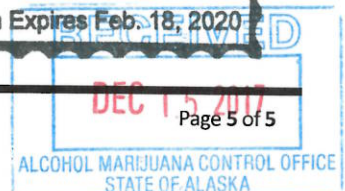

Tourism License Statement

The Point Lodge encourages tourism by advertising our services for lodging, restaurant & bar, and outdoor activities. Having a Liquor License available at the lodge has been important to most of our guests when they make their reservations.

The lodge was built in 1985 with the dining facility and the bar/lounge area adjacent to each other. There has been no new construction on the lodge over the past two years, but we are continually upgrading and improving our lodge property.

I, Patti Billman, manage the lodge and operate the bar. All licensees, agents, and employees that sell or serve alcoholic beverages or check identification of a patron have completed an alcohol server education course approved by the ABC Board and keep current, valid copies of their cards on the licensed premises during all working hours, as required under AS 04.21.025 and 3 AAC 304.465.

We have 13 rooms in the main lodge and 4 cabins that we rent to the traveling public. We do not offer kitchenettes and do not stock alcoholic beverages in our guest rooms or cabins. Coffee, teas, and water are available free of charge for our guests.

Additional amenities available to our guests are: Wifi, guided fishing trips, rental equipment, launching and parking boats, and providing information on other points of interest and activities in the area.
