Background: This beverage dispensary license is proposed to be transferred from no premises to a location in Fairbanks. The proposal is for the licensed premises to be a large warehouse, within which the bar will be located in an airstream trailer. The trailer will be taken out of the premises to cater events in other locations. Other areas within the warehouse include alcohol storage, restrooms, and storage for other equipment.

In a letter provided by the licensee, they state that their intent in holding a beverage dispensary license is to be a catering company, although they recognize they need to have a bar in order to provide catering.

Staff has concerns with this proposal, for the board to evaluate:

- Although it is not explicitly stated in statute or regulation, a fixed bar is implied at a beverage dispensary license.
- 3 AAC 304.185(c) states, "A licensee may not alter the functional floor plan...without the prior written approval of the director." Removing the refrigerator, tap system, and service counter (all within the airstream trailer) must be considered an alteration of the functional floor plan.

Dear Alcohol & Marijuana Control Office,

Nash Holland, LLC is submitting transfer paperwork for Beverage Dispensary License #2847 from No Premises to 659 5th Avenue, DBA Goldie's AK. Due to the ambiguity of our adherence to AS 4.11.430(b) we want to give some introductory points on our business model.

Nash Holland, LLC is a new company with three owners Kara Nash, Adam Nash and Christopher Ryan Holland. Kara is the owner of Event Alaska, relying heavily on the efforts of Ryan and Adam as logistics support for nearly 20 events a year, including the Midnight Sun Festival, Mayors' Charity Ball, Golden Days, Open North American Championship, and many others throughout Fairbanks. Due to the changing Alaskan economy, alcohol has played an important role in drawing attention to events and diversifying non profit fundraising efforts. Kara has experience administering catering permits and special event permits for both non-profit and beverage dispensary clients.

Our business model is based on the necessity of having alcohol at events and providing a safe, easy, legal option for doing so. We realized that in order to provide alcohol catering per AS 04.11.230 we would need a beverage dispensary license, and were eventually the recipients of a transfer last year. We also knew that because of AS 04.11.430 (b), we were required to have a licensed premises, and thus were required to own a bar in order to provide catering. We plan on using a 1956 Airstream as a tool for providing catering services to special events, weddings and private parties. ADEC will license our trailer as a 'mobile unit' which utilizes the premises as a commissary. Goldie's AK will have regularly scheduled hours where customers can come by, see the Airstream, and get a sense of what it could be like to have us cater their event. The Airstream will be 'the bar' when it is inside the premises. For this reason, we do not want duplicate the equipment (sinks, refrigerators etc.) inside and outside of the trailer. When we are at an event, the premises will be closed. It is possible in the future we will be able to sustain an operating beverage dispensary while we are occupied at an event, but our focus is to provide a streamlined alcohol catering option for Fairbanks.

AB-02 Premises Clarification

Many of the fixtures typically associated with a beverage dispensary are not permanent installations in the premises, but rather are attached to a mobile unit which will be approved and licensed as such by ADEC. While the mobile unit will be located in the south-east corner of the premises during operating hours, it is not permanently affixed to the structure. The diagrams show both the location of the mobile unit during operation, as well as a diagram of the interior of the mobile unit. The mobile unit will be used for vending both within the premises and at catered events (with separate permitting requirements). The premises will be used for consumption (with service from the mobile unit only), storage of alcohol and supplies, storage of the mobile unit, cleaning, restrooms, etc. When the mobile unit is not present, the premises will be closed.



AB-02 Outdoor Space Security Plan

- 1. The outdoor consumption area will be secured by walls and branded stanchion barrier device, approximately 30" tall along the perimeter of the area where there are no walls. The only areas, not surrounded by walls are to the North and a small portion to the West.
- 2. The stanchion barrier devices are non permanent and shall stay in place during operating hours, unless as noted below. The ground will be painted under where the stanchions sit, so that a border is clearly defined in the case of stanchion movement. The painting will ensure that barrier devices are consistently set in the same location. These are the situations where the barrier devices could be shifted:
 - a. During special events the stanchion barrier device may be replaced with a food truck or mobile unit. Staff shall ensure there is no ingress or egress between the food truck or mobile unit and the outlined outdoor consumption area. All signage will still apply.
 - b. Barrier device could be moved for mobile unit access reasons. If barriers are removed temporarily, staff will be on hand to supervise the area, and immediately replace the barriers.
 - c. There are other circumstances where the barrier stanchions may need to be moved including, snow removal, deliveries to the space, and other unforeseen circumstances. In these circumstances barrier device will be replaced before operating hours resume.
- 3. The barrier will be labeled and signed to differentiate the designated premises with 'Rules' of the consumption area. 'Rules' will be posted for customers to read as they enter the area. 'Rules' shall include unless otherwise required by the state the following:
 - a. Persons under 21 years of age are not allowed in the establishment except with a parent or legal guardian.
 - b. Be prepared to present id upon entering the establishment.
 - c. No outside alcohol permitted upon entering.
 - d. No alcohol will leave the area created by the stanchion barriers.
- 4. The barrier will be labeled and signed to differentiate the designated premises by 'No Alcohol Beyond this point' signs posted on the interior of the barriers in several locations at a minimum of 15' apart.
- 5. The area will be patrolled by staff regularly, with frequent rounds outdoors.
- 6. During any time at which a high occupancy or traffic-flow is expected, there will be a permanently stationed staff member at the perimeter boundary to assist in regulating the area, checking id's and ensuring alcohol is not permitted into the boundary and discarded before exiting the boundary.
