**Background:** This recreational site license appears to meet the statutory requirements of the license type:

Sec. 04.11.210. Recreational site license.

- (a) The holder of a recreational site license may sell beer and wine at a recreational site during and one hour before and after a recreational event that is not a school event, for consumption on designated areas at the site.
- (b) The biennial fee for a recreational site license is \$800.
- (c) In this section, "recreational site" includes a location where baseball games, car races, hockey games, dog sled racing events, or curling matches are regularly held during a season.

After the April 2018 meeting, the licensee submitted a revised recreational site license statement, assuring the board that alcohol is never for sale more than one hour before a game.

I am writing to correct my own error on our initial renewal application for this baseball season beginning with our first game June 5. This was my first attempt at a liquor license & I may have been confused when I described our game dates, times & hours of selling beer. I did not keep a copy of that description for my record so I have nothing to reference.

Our gates open at 6:00pm & beer is not generally for sale until 6:20-6:30pm. This is where I may have made my error. We have always been in compliance with laws set forth by the Alaska Alcoholic Beverage Control Board. Beer sales are ended well before the end of a game. We cease selling beer during the 7<sup>th</sup> inning of play. During a double header, which are two seven inning games we will cease selling beer during the fifth inning of the last game. Alcohol is never for sale more than one hour before a game.

I hope this explains my oversight & next season's application will be correct on the first filing.


