RE: Form to Request Removal from

Restricted Purchaser's List

3 AAC 304.645(l) states:

The board will, in its discretion, maintain a list of persons who, under AS 04.16.200, are convicted after 10/24/87 of a violation of AS 04.11.010, and will, in its discretion, provide this list to package store licensees. A licensee who receives the list may not sell alcoholic beverages by written order to a person whose name appears on it until the board gives written notice to the licensee that such sales are no longer prohibited.

Currently if a restricted purchaser wishes to be removed from the list, we instruct them to write to the board, but there is no guidance on what information the board wishes to know to evaluate whether or not to remove them. The minutes indicate that in the past, the board has denied the request of an individual to be removed from the list "based on recent drug activity." This shows that the board may be interested in the listed individual's criminal history since their conviction for violating AS 04.11.010.

The attached form is for board consideration to be used for individuals to request removal from the restricted purchaser's list.
