Requested Action:

Transfer of ownership

Statutory Authority:

AS 04.11.040(a): "A license issued under this title may not be transferred to another person except with the written consent of the board."

AS 04.11.360: "An application requesting approval of a transfer of a license to another person under this title shall be denied if...(4) the transferor has not paid all debts or taxes arising from the conduct of the business licensed under this title unless (A) the transferor gives security for the payment of the debts or taxes satisfactory to the creditor or taxing authority; or (B) the transfer is under a promise given as collateral by the transferor to the transferee in the course of an earlier transfer of the license under which promise the transferor is obliged to transfer the license back to the transferee in the event of default in payment for property conveyed as part of the earlier transfer of the license;"

AS 04.11.470: "A person may object to an application for issuance, renewal, transfer of location, or transfer to another person of a license, or for issuance of a permit, by serving upon the applicant and the board the reasons for the objection. The board shall consider the objections and testimony received at a hearing conducted under AS 04.11.510(b)(2) when it considers the application..."

AS 04.11.510(b)(2): "the board may, on its own initiative or in response to an objection or protest, hold a hearing to ascertain the reaction of the public or a local governing body to an application if a hearing is not required under this subsection; the board shall send notice of a hearing conducted under this paragraph 20 days in advance of the hearing to each community council established within the municipality and to each nonprofit community organization entitled to notification under AS 04.11.310(b);"

Staff Rec.: After public testimony, if the board determines that Ms. Nickerson agreed to assume

the debt of Paul Kopf, deny the transfer with 30 day abeyance.

After public testimony, if the board determines that Ms. Nickerson has no responsibility for the debt of Paul Kopf, approve the transfer with delegation.

Background: In 2012, this license was involuntarily retransferred from Paul Kopf to Vicki Nickerson, who had established a security interest in the license during a 2009 transfer. Ms. Nickerson has now applied to transfer the license to KJNM, Inc.

Objections to the transfer of this package store in Fairbanks were served by the Odom Corporation, Southern Glazer's Wine & Spirits of Alaska, and Coke, due to unsatisfied debts from 2010/2011 incurred by Paul Kopf. The Odom Corporation asserts that Ms. Nickerson agreed to assume some or all of the debt, but has provided no documentation of the agreement. Mention of the agreement exists in board files, but there is no indication of whether the agreement was signed.

The board is required by AS 04.11.510(b)(2) to hold a hearing to consider the objections and ascertain the reaction of the public.
