This is an application to transfer the ownership of a Beverage Dispensary – Tourism license in the Kenai Peninsula Borough. This license was first issued on June 21, 1967.

AS 04.11.400(d)(1)(F) requires 40 rental rooms if the population is 25,001 – 50,000. The Kenai Peninsula Borough has a certified population of 38,101.

The applicant offers 15 rental rooms, none of which include kitchenettes, as well as 18 RV spots. Alcohol is not stocked in the rental rooms, and the establishment has a restaurant.

The Place Tourist Statement

- 1. The Place Motel, Bar & Grill (The Place) provides tourist with a true "Alaskan" experience destination unlike many of the larger chain motel/hotels. Tourist are able to enjoy the spectacular ocean & mountain views as well as wildlife just outside the city of Kenai. Guest can take in stunning Mt Redoubt sunsets away from any city lights. The large property allows tourist that are traveling by RV to park in a private setting while still allowing them to enjoy the convenience of great food, drinks, and the warm hospitality of our staff. The Place Motel has 15 full equipped rooms, and 18 RV Spots, for tourist and travelers looking for a quality overnight or longer visit. While other motels charge substantially more during the busy summer months The Place maintains affordable rates in order to encourage tourist to come visit and stay with us. A liquor license is necessary for The Place to be competitive with other motels/hotels in the area, and to offer a well round variety of services so guest don't have to go elsewhere to drink and risk a DUI.
- 2. The Place has 15 rooms, and 18 RV spots available. Each room features 2 queen size beds, dresser, flat screen satellite TV, small table with 2 chairs, microwave, mini refrigerator, and a full private bath. The rooms and RV spots are available to the traveling public, tourist, and are especially popular with fishermen from all over the World.
- 3. The Place is owner operated by Grant & Rossana Gratrix. Grant oversees the bar operation, and property maintenance. Rossana operates the Grill and supervises all employees. Our manager assists with maintenance, and is in charge of security.
- 4. The Place offers room rental to the traveling public. Currently none of the 15 rooms have kitchen facilities, but do have a microwave & mini refrigerator. No alcohol is stocked in the rooms.
- 5. The Place Grill does have a dinning facility which is currently offering a limited menu, but in January 2018 lunch will be offered with a continental breakfast being add May 2018. Meals are not delivered to the rooms, but there is plenty of seating in the dinning area for guest & locals to enjoy a meal & beverage.
- 6. The Place doesn't currently directly book guest for local tourist activities, but is in the process of connecting with local fishing guides to offer their services to our guest. A bulletin board in the dinning area has info local guides have posted, and the staff are all longtime Alaska residences with a wealth of info gladly imparted upon all who inquire.




