This is an application to transfer the ownership of a Beverage Dispensary – Tourism license in the City of Whittier. This license was first issued on May 28, 2009.

AS 04.11.400(d)(1)(A) requires 10 rental rooms if the population is less than 1,501. The City of Whittier has a certified population of 244.

The applicant offers 25 rental rooms, none of which include kitchenettes. Alcohol is not stocked in the rental rooms, and the establishment has a full-service restaurant.



2018 Tourism Statement Whittier Lodging, LLC,

 Explain how the issuance of a liquor license at your establishment has/will encourage tourism.

The central focus of the business plan for the Inn at Whittier involves catering to out of town tourists, local, and regional guests. The licensee will continue to run advertising in travel/tourism publications and directories as well as through electronic methods, including an online presence via property specific website and other relevant platforms.

Explain how the facility was/will be constructed or improved in accordance with this application.

The hotel was built according to the building standards of hotels for the time period in which it was constructed. No major updates have been completed since the facility was built other then paint, new carpet, and general maintenance as and when needed, in accordance with hotel' best practices.

2. Who operates the facility for which a liquor license is being applied?

Whittier Lodging, LLC operates the liquor license. Mr. Todd Perez, and Sloane Unwin are the two Members of the entity. Mr. Todd Perez will be managing the daily operations of the business in Whittier.

- 3. Do you offer room rentals to the traveling public? Yes.
- 4. If so, how many of these rooms are available? Do any of the rental rooms have kitchen facilities (defined as: a separate sink for food preparation along with refrigeration and cooking appliance devices, including a microwave)? If yes, how many of the rental rooms have kitchen facilities that meet this definition? Do you stock alcoholic beverages in guest rooms?

There are 25 rooms for rent at the Inn at Whittier. None of the rooms are equipped with kitchen facilities. The two suites do have small refrigerators and a microwave, but no sink. No we do not stock alcoholic beverages in the rooms.

5. Does your establishment include a dining facility?

Yes. The Inn at Whittier offers breakfast, lunch, dinner, and snacks daily in a comfortable setting.

6. Are additional amenities available to your guests through your establishment (eg: guided tours or trips, rental equipment for guests, other activities that attract tourists)?

No, the Inn at Whittier does not provide any additional tourist type amenities to its guests. We do recommend tours, and have a list on our website of close by tours, trips, and rentals, for our guests. Inn at Whittier will continue to operate the facility as a tourist facility. In short, all of those things, which are routinely done by businesses in Alaska to encourage tourism, will continue to be done by the operators of the facility.
