Requested Action:

Transfer of ownership and DBA change; protest of 2016 renewal

Statutory Authority:

AS 04.11.040(a): "A license issued under this title may not be transferred to another

person except with the written consent of the board."

AS 04.11.480(a): "A local governing body may protest the issuance, renewal, relocation, or transfer to another person of a license by sending the board and the applicant a protest and the reasons for the protest within 60 days of receipt from the board of notice of filing of the application ... If an application or continued operation is protested, the board shall deny the application or continued operation unless the board finds that the protest is arbitrary, capricious, and unreasonable."

**Staff Rec.:** Uphold protest of 2016 renewal with 30-day abeyance; approve transfers with

delegation

**Background:** These licenses were up for renewal at the end of 2016. Renewal applications were timely submitted and the Municipality of Anchorage protested both renewals due to unpaid taxes. Staff also identified that the licenses had been transferred without approval of the board as required by AS 04.11.040. Due to staff errors, the protests were never brought to the board, and the licenses were renewed administratively and issued in May of 2017.

Transfer applications were received in the spring of 2017 but application errors were never corrected, so the applications were returned to the licensee in August of 2017. Transfer applications were again submitted in 2018.

Because the board never considered the local government protest of the 2016 renewal applications, the board should consider those at this time. I recommend upholding the protests with a 30-day abeyance, and approving the transfers with delegation. The approval of the transfers would be valid only if the taxes are paid and the renewal protests are lifted. The Municipality of Anchorage has not yet indicated whether or not they will protest the license transfers.
