I received a Notice of Violation through Certified Mail and E-mail, neither of which I opened because they were forwarded to Mr. Dan Coffey who was representing me at the time. Since I had provided my attorney with all the documents he requested, I fully expected the deadline, or rather the deadline he extended would be met. Unfortunately, Mr. Coffey failed to submit the information he had in hand in a timely manner so an NOV was issued.

Although I fully expected him to contend with the consequences of his actions it is obvious that he did not do that, so neither of my expectations were met. Mr. Coffey has been discharged so I am responding to the NOV.

In addition to this acknowledgement of having received the NOV and my explanation as to what happened, I have enclosed two additional documents. One is a copy of an e-mail I sent the day of the deadline to remind and urge Mr. Coffey to submit my material. Had he complied with my prompt, the material would have been in your offices on time. The second document is a note that Mr. Coffey passed to me during the June ABC Board meeting. The first two sentences were written by him and the two sentences at the bottom of the paper are mine. Although, he did not answer my question it's obvious that I was led to believe the NOV had been removed. Ms. McConnell told me at the August board meeting the NOV was in my file and would remain there indefinitely and that it should have been responded to. Because my calls were not returned, I went to the ABC enforcement offices and spoke with Mr. Rukes who said the response to an NOV should to be in writing.

Although I requested the return of my documents from Mr. Coffey, I have not received them, but I located the NOV that was originally e-mailed to me. There isn't a format for reply so consider this correspondence & the attached copies as an acknowledgement of, and a reply to the Notice of Violation.

I appeared before the ABC Board in Denali on the 14th of August where a resolution of this matter was offered by Director McConnell and approved by the Board. I trust this solution is acceptable to ABC enforcement as well.


I am writing this letter on behalf of our client Garcia's Birchwood Ltd Partnership who operates the local restaurant Garcia's Cantina in Eagle River. Please let this letter serve as my client's formal response to NOV AB18-0521 dated May 8, 2018 which they were apparently sent via email and which they state they did not receive. You and I spoke about this matter briefly when I met with you several weeks ago. My client did receive a copy of this NOV via certified mail on September 19, 2018.

The facts in this matter are relatively simple. In late 2017, my clients erroneously and without intention to violate the law, transferred/reallocated the amounts of stock held by the members of Garcia's Birchwood Partnership. This reallocation effectively resulted in more than 10% of stock in the licensed entity changing hands. As we know, Title 4 requires a stock transfer for any transfer of stock equal to or more than 10% in the licensed entity. Unfortunately, my client was not aware of this requirement at that time. Since retaining this firm, my clients and I have discussed in depth the requirements of Title 4 relative to changes in stock ownership. All members of the partnership have a clear understanding of the law and wish to comport with it. Garcia's is a long-standing operator with a strong record of compliance and wants nothing more than to make the entity compliant with the law.

As such, this Firm has been engaged to perform the stock transfer which should have been effectuated in 2017. We have just started the advertising process and expect to be completed shortly and to be filed with your offices within the next few weeks.

My client sincerely apologizes for the error and has used this opportunity to re-educate themselves on the technical aspects of Title 4. I am available at any time to discuss this matter with you further should you feel such a discussion is necessary. Thank you for your time and courtesy in this regard.

On 9-7-18, AMCO Enforcement received information that Tito's Discovery Cafe, also known as Creekbend Co., was serving alcohol outside of the hours permitted by a caterers permit. A check of their Facebook page depicted they were advertising the Gates/Bar open at 5pm. The permit allowed them to sell at 7pm. Attempts to contact the point of contact listed on the permit were met with negative results. An informant was able to purchase a beer prior to 7pm on 9-7-18. On 9-8-18, Inv. Hamilton arrived at the event and was able to purchase a beer at about 1630 hours. The caterer's permit for 9-7-18 allowed them to start selling at 1800 hours. While there, several other people were observed purchasing prior to 1800 hours. Also noted, required sign-age was not posted. A check of AMCO files also revealed that they have not submitted a name change to Creekbend Co., an issue that was brought to their attention several weeks ago.

Hello AMCO enforcement team,

I write you following up on both a message I sent in last week as well as a NOV we received.

My name is Steve Thomas and I the person taking over the New Discovery business from Gina Motoyama. Last weekend we had an investigator visit our property, check on things and meet with me. We together discussed how the timing issues on the permits occurred in error and I immediately wrote in to you all to explain what had happened as well as seek guidance for future reference. I want to reiterate several things from the previous message and ensure it is evident that the business will continue to take every step possible to ensuring a safe, legal, enjoyable experience for our visitors. Hopefully the fact we took the time to write a message to the office before we even received a NOV, is a clear indication as how serious we treat the beer/wine license. The message has been copy and pasted below.

First, The NOV mentioned the serving before the time listed on the permit. This was the first live music this summer in which our start time was earlier than the normal 7:00pm. When we sent in the permit last month, we did not know the band was bringing an opening musician. As this is our first summer learning the swing of things, we commit to that never happening again and the start times for the permit to be safely in advance, in the event anything like this happens in the future. I truly apologize for the time change not getting reported. I seek sympathy as this was the first situation in which this scenario came into play for us. It will absolutely be noted and addressed moving forward. Our standard operating procedures and event day game plans all incorporate these details. At a bare minimum, we were at least operating with our legal premise properly secured and had our security guards at their proper posts the entire time.

The NOV also mentioned the "required sign-age was not posted". We politely disagree with that statement as all required posted signs were posted both at the bar area and ample extra signage posted at the check in tent/gate to thoroughly communicate to our guests. Again, we understand the serious nature of having a beer and wine license and we take pride in our game day execution. Our Bar and Door staff are required to confirm the signs our posted before opening their booths.

Finally the NOV mentioned "they have not submitted a name change to Creekbend Co, an issue that was brought up several weeks ago". This statement really disappointed Gina and I as we feel we have done a very thorough job seeking guidance on the best way to proceed in our situation of the business transferring. We first attempted to address this in May when we first turned in the transfer application. With then the guidance of the amco folks that visited us earlier in the summer as well as Carrie, we were told to fill out a Management Agreement, to be utilized during the time period in which the transfer application was being reviewed. And that would take care of the fact that we were sandwiched between two business names. We filed and even made requested changes to our managerial agreement when requested to by amco staff.

As we have reached the end of the summer season, Gina and I would like to take this good time of year to clarify

exactly what is requested of us to have the Name we are operating under to be legal and correct. We live in the small town of Hope and all we want to do is know we are properly following your requests and providing a safe, enjoyable environment for our customers.

Thank you so much for the time in reading my responses to the past weekends mistake. Know that we take these measures very seriously and all procedures are being updating to ensure there is never a permit issue again.

Hello,

My name is Steve Thomas and I am the person taking over the New Discovery business from Gina Motoyama. I want to thank you for the guidance these past few months as we move through the transition. The folks in the amco office have been fantastic working through our transfer application as well our event permits.

Moments ago, I met Investigator Joe Hamilton at the property in Hope. Investigator Hamilton mentioned a few items regarding our event permits. This business is so important to many livelihoods and I understand the significance of permits being properly signed and filed. We wouldn't actively do anything to jeopardize this license. Thus, I stepped aside to write to you immediately.

First, Investigator Hamilton mentioned that our permit was for 6:00pm instead of 4:00pm tonight. We went back and confirmed that it was in fact for 6pm. This was the first live music this summer in which our start time was earlier than the normal 6 or 7:00pm. When we sent in the permit last month, we did not know the band was bringing a opening musician. As this is our first summer learning the swing of things, we commit to that never happening again and the start times for the permit to be safely in advance, in the event anything like this happens in the future. I truly apologize for the time change not getting reported. I seek sympathy as this was the first situation in which this scenario came into play for us. It will absolutely be noted and addressed moving forward.

Secondly, Investigator Hamilton mentioned to us verbally that although our permit says we can stay open until 12:00am, that we have to stop the event/serving at 11:00pm. He stated that our permits have been getting inadvertently signed off incorrectly by someone and that we should have been informed of this. It sounds like there is an additional sign off required if the entertainment goes after 11pm. Who would be the person to reach out to for this sign off aspect in the future?

I was disappointed to hear this on the day of our final event of the season, as we had not been informed of this detail in any of our previous 8-10 events this year. We will of course respect Investigator Hamilton's request and close sales at 11:00pm. The live music schedule has already been updated! As it is Saturday, I am unable to call in for guidance on whether the permit I was emailed is correct.

He also mentioned that I will notice on our previous event permits, the end time was in fact changed to 11:00pm on each. We went back and reviewed the final permits emailed from Campbell Anderson to check, and the times are still the times originally corrected. Was there a different document/location to look at for where the end times were changed?

Thus I was just seeking guidance as what to do in this situation in the future, so it is clear for all parties and no issues arise again. Thank you so much. The last thing I would want to do, is not have our events properly permitted.

I thank you so much for taking the time to read my explanation and questions from this evening. It means a lot to me and the rest of our team here. We appreciate your support as guidance as we set up this business for the future. We will be in touch this week.
