### **MEMORANDUM**

Requested Action:

Transfer of ownership and DBA change

Statutory Authority:

AS 04.11.040(c): "A person may not receive or transfer controlling interest in a liquor license issued to a partnership, including a limited partnership, a limited liability organization, or a corporation under this title, except with the written consent of the board."

AS 04.11.360: "An application requesting approval of a transfer of a license to another person under this title shall be denied if...(4) the transferor has not paid all debts or taxes arising from the conduct of the business licensed under this title unless (A) the transferor gives security for the payment of the debts or taxes satisfactory to the creditor or taxing authority; or (B) the transfer is under a promise given as collateral by the transferor to the transferee in the course of an earlier transfer of the license under which promise the transferor is obliged to transfer the license back to the transferee in the event of default in payment for property conveyed as part of the earlier transfer of the license;"

AS 04.11.470: "A person may object to an application for issuance, renewal, transfer of location, or transfer to another person of a license, or for issuance of a permit, by serving upon the applicant and the board the reasons for the objection. The board shall consider the objections and testimony received at a hearing conducted under AS 04.11.510(b)(2) when it considers the application..."

AS 04.11.510(b)(2): "the board may, on its own initiative or in response to an objection or protest, hold a hearing to ascertain the reaction of the public or a local governing body to an application if a hearing is not required under this subsection; the board shall send notice of a hearing conducted under this paragraph 20 days in advance of the hearing to each community council established within the

municipality and to each nonprofit community organization entitled to notification under AS 04.11.310(b);"

Staff Rec.: Absent compelling public testimony suggesting a different course of action, deny the

transfer with a 30-day abeyance; note for the record that other pending approvals

must be received before the transfer can be effectuated

**Background:** Objections to the transfer have been served by the Department of Labor – Employment Security, and by K&L Distributors due to an unsatisfied debt.
