Dear Alaska Travel Adventures Inc.,

At the February 1, 2017, meeting of the Alcoholic Beverage Control Board in Juneau, Alaska, the board voted to approve your **Recreational Site License** with delegation to the director. Delegation means that the board has authorized me to issue your license once all outstanding approvals are received and objections lifted.

Although you hold a recreational site license, the board has determined that your business does not fully meet the statutory definition of recreational site as currently defined by state law:

Sec. 04.11.210. Recreational site license.

(a) The holder of a recreational site license may sell beer and wine at a recreational site during and one hour before and after a recreational event that is not a school event, for consumption on designated areas at the site.(b) The biennial fee for a recreational site license is \$800.

(c) In this section, "recreational site" includes a location where baseball games, car races, hockey games, dog sled racing events, or curling matches are regularly held during a season.

The board recognizes the impact of this interpretation on your business and has agreed to allow this last renewal. Therefore, this will be the final recreational site license issued to this business under existing statute. We encourage you to review the different license types available under Alaska statute if you wish to serve alcohol after this license expires.

The following information reflects what is currently on file for your application:

Local governing body action:

If we are still awaiting a response from your local governing body, then you may continue to operate under the temporary license that was issued to you until the local governing body has waived its right to protest. If a timely protest has been received or is received, your application will need to go back in front of the board for consideration. If your local governing body has already waived its right to protest but you have not yet received your real license, one will be mailed to you shortly.
