The second and third advertisement violate pricing and marketing because they offer the beer at lowered price to a select group (Groupon Purchaser).

Your attention is directed to AS04.16.015: Pricing and marketing

Also noted on a walk through was your civil penalty sign is posted incorrectly. It should be posted so one can see it as they enter the establishment.

Your attention is directed to AS04.21.065: Posting of warning signs Not posting or posting your signs incorrectly could result in a \$110.00 fine a day.

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPREARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.
