



## **Tourism Statement – Denali Bluffs Hotel**

**1. Explain how issuance of a liquor license at your establishment has/will encourage tourism.**

The Denali Bluffs Hotel is a 176 Room, Seasonally Operated, Full-Service Hotel property located within a mile of the entry to Denali National Park, Alaska's premier Tourist Destination. Many Visitors to Alaska, and certainly to Denali, require both appropriate and desired Hotel accommodations and amenities as part of their itineraries, to include Food & Beverage services, including the opportunity to purchase adult style beverages. The Denali Bluffs Hotel provides such services to approximately 35,000 guests each Season.

**2. Explain how the facility was/will be constructed or improved in accordance with this application.**

The Mountaineer Grill & Bar, at the Denali Bluffs Hotel, is a 75 seat restaurant dining facility that includes a 20 seat full service Bar. As a very large percentage of our patrons at the Mountaineer are adults, on vacation, their ability to order adult style beverages to accompany their dining choices ensures a high level of service and satisfaction for their stay at the Hotel.

**3. Who operates the facility for which a liquor license is being applied?**

Grande Denali, LLC is the operators of the Denali Bluffs Hotel and the Mountaineer Grill & Bar.

**4. Do you offer room rentals to the traveling public?**

A. Yes --The Denali Bluffs Hotel includes 176 overnight guest accommodations, none with kitchen facilities. The Hotel does not stock alcoholic beverages in the guest rooms.

B. The Denali Bluffs Hotel is not located within an airport terminal.

**5. Does your establishment include a dining facility?**

Yes -- The Mountaineer Grill & Bar.

**6. Are additional amenities available to your guests through your establishment?**

Yes -- The Denali Bluffs Hotel offers assistance to guests who are interested in participating in local tours, trips and activities that attract tourists. Such help extends to providing information, promotional materials, and providing booking options and other assistance, through our agreements with a large number of attraction/activity vendors located in the Denali area.
