Background: This recreational site license appears to meet the statutory requirements of the license type:

Sec. 04.11.210. Recreational site license.

(a) The holder of a recreational site license may sell beer and wine at a recreational site during and one hour before and after a recreational event that is not a school event, for consumption on designated areas at the site.

(b) The biennial fee for a recreational site license is \$800.

(c) In this section, "recreational site" includes a location where baseball games, car races, hockey games, dog sled racing events, or curling matches are regularly held during a season.

Recreational Site Statement for Top End Inc. dba Alaska Raceway Park

In applying for a renewal of our recreational site license, I submit the following information:

- <u>Type of Events</u>-- Alaska Raceway Park has been holding automotive racing events at our park for 54 years (since 1964). The events include: drag racing (cars, bikes, trucks, snowmachines, funny cars, rails, junior dragsters, and others) oval or NASCAR racing (late model, street stock, legends, baby grands and mini-stock) and autocross (sportscars). Occasionally, car shows are held in conjunction with a racing event (Cool Cruze in May and Freedom Flag Run on the Saturday closest to 9/11).
- <u>Season Length</u>—Our race season is slightly variable but it runs May-October. Drag racing traditionally begins on Mother's Day and oval/NASCAR racing begins the Saturday before or after that day depending on how early in May that Mother's Day occurs. Drag and oval/NASCAR racing ends on Labor Day weekend unless we have to run an event to make-up for a rainout. September events also include the Freedom Flag Run and one or two autocross races, weather permitting.
- <u>Hours</u> We serve beer and wine from the start of races until one hour after the conclusion of the races because we present trophies at the conclusion of the race day. Beer and wine service begins at:

11 am for day drag races (Sundays and holidays)

3 pm for "evening" races (Fridays and Saturdays) with closing by 10 pm for Mat-Su Borough noise curfew.
