Staff Rec.: Deny the renewal

Background: This recreational site license does not appear to meet the statutory requirements of the license type at AS 04.11.210. AS 04.11.330(a)(6) states that a renewal shall be denied if "renewal of the license would violate the restrictions pertaining to the particular license under this title..."

The board denied the renewal of this license in February of 2016 due to not meeting the statutory requirements of the license type. The licensee appealed, and the board adopted a decision of an Administrative Law Judge which concluded that although the board did not err in determining that The Summit did not meet the requirements of the rec site statute, the board did err in examining (and denying) only one recreational site license at that time, which did not afford equal protection to the licensee. Thus The Summit was renewed for the 2017/2018 licensing period.

The Alaska Club Summit statement addressing meeting the requirements of AS 04.11.210 for 2019-2020 Recreational Site license.

- 1. The Summit at The Alaska Club has and will continue to sell beer and wine from the hours of 11:00am to 9pm or one hour after the last scheduled fitness activity.
- 2. While admittedly more of an activity based operation than an event based operation, the Club does offer the opportunity for competitive sports among members at the site.

It is the nature of our business that leads us to ask for the renewal under the recreational label. Without any question, the operations of the club foster fitness and good health while providing opportunities for social interaction, networking, and recreation. As to specific events, our group fitness schedule provides multiple scheduled classes daily that last for an hour or more. Classes begin as early as 5:30am and end at 8:00pm daily. While the classes may vary in style and format, they are offered year round and throughout the day.

3. The offering of our services and specifically our classes are year round.
