C. Approval of Agenda

9:04 am

Erika McConnell states that Tab 15, the appeal of denial of catering permits for license 4763 DBA Bobby's Downtown has been withdrawn. She states that items T, U, and Y under the Delegated Consent Agenda are Public Convenience licenses that are currently scheduled for consideration with the Delegated Consent Agenda. She requests that the applications for licenses 5737 DBA Mexi Co, 5738 DBA The Smokehouse, and 5746 DBA Allen Marine Tours be considered separately from the remainder of the Delegated Consent agenda. Tabs for each item are provided to the board on their laptops.

Erika McConnell states that there is a fact sheet that has been provided to the board members that she handed out to each legislator on Monday to summarize the work that AMCO does.

Glenn Brady moves to approve the agenda with the suggested amendments. Sara Erickson seconds.

None opposed, motion carries.

D. Selection of Board Chair

Bob Klein requests to be board chair.

No opposition is raised.

Glenn Brady offers to be vice chair

No opposition is raised.

E. Approval of the December 17, 2018 Meeting Minutes

TAB 1

Glenn Brady moves to approve the December 17, 2018, Meeting Minutes. Rex Leath seconds the motion. None opposed, motion carries.

BOARD GOVERNANCE

9:05 am

Glenn Brady states that he has financial interest in Tab 29 (consideration of the waiver of operations for license 3487 DBA Salchaket Roadhouse) and Tab 119 (consideration of renewal applications for license 3487 DBA Salchaket Roadhouse and 421 DBA Silver Gulch Brewing & Bottling). He offers to recuse himself if staff feels it is appropriate.

PUBLIC TESTIMONY

9:07 am

A. Public testimony is limited to issues not on this agenda and that are not proposed regulations. The call-in number is 1-800-315-6338, code 69173#.

Licensee, John Jackovich, 556 DBA International Hotel and Bar asks if he is able to speak at this time.

Harriet Milks discusses his testimony and confirms that he desires to speak regarding the NOV that is being brought before the board in Tab 96. She states that his testimony would be more appropriate at that time.

Paul Thomas, Alaska Cache liquor & Chairman of the Board for Alaska CHARR, states that he has some comments regarding minimum operating requirements, and references his comments being included in the mail tab (Tab 125, Alcohol Mailbox).

Bob Klein states that the mail tab is not an action or agenda item, and that testimony regarding matters brought up in the Alcohol Mailbox would be appropriate at this time.

Paul Thomas asks that, if the new license is issued in November/December, the board direct staff not to require a waiver of operation and/or the minimum operation of the license in the calendar year for which it is issued.

Bob Klein thanks him for his testimony.

Paul Thomas provides the board with a written statement of CHARRs position regarding the suggested repeal of the Alcoholic Beverage Control Board and the Marijuana Control Board.

Glenn Brady states that, as a licensee, he also supports the review of the administrative procedures and streamlining the onerous administrative penalties assessed that are out of proportion to the action on the part of the licensee.

Matt Tompter, licensee, via phone, asks that the board clarify through a directive to the director or a regulations project, that if a license is issued after November 20th, the minimum operating requirements be waived. He explains that staff notified him that, because his license was issued at the end of the 2018 calendar year and he would be unable to meet the minimum operating requirements, he was required to submit the waiver and associated waiver fee and late fee. He states that it was an inappropriate requirement and he finds it an unnecessary penalty.

Sarah Oates- President and CEO of Alaska CHARR is present via phone to provide testimony.

Phone line problems are encountered; the phone line is restarted.

Bobby Evans states that he finds this to be a time where comments are heard and that he feels that he understood what people said about the minimum operating requirements and unless Sarah Oates has additional comments, it may be appropriate to move on.

Bob Klein states that action may be taken by the board regarding things brought up in public testimony when appropriate.

Sarah Oates echoes the requests regarding the minimum operating requirements and adds that the only other option given to licensee (Matt Tompter) was to delay issuance of the license until January which would not allow the new licensee the opportunity to take advantage of the holiday money making opportunities which is important in this current economic climate. She asks that the board gives direction regarding this matter or start a regulations project. She states that CHARR is opposed to the dissolution of the boards and references the written comment already provided by Paul Thomas. She states that the fairs alternating premises request has not been addressed at this time.

Sarah Oates as individual thanks Bobby Evans for his service to the ABC Board.

Sara Erickson states that a restaurant in Kenai told her to tell the staff that staff is very helpful and says thank you to staff for their help.

DIRECTOR'S REPORT

9:23 am TAB 2

Erika McConnell summarizes the information provided in Tab 2. She provides an update on staffing and the ARMS/APSIN concerns from Enforcement staff. She states that the inability of enforcement to access the ARMS/APSIN database hamstrings the enforcement team. She answers board questions about difficulties that arise from not having ARMS/APSIN access, and operational ramifications.

Bob Klein thanks her for her clear summary of her concerns and expresses his confusion about why the ARMS/APSIN issue is occurring.

Erika McConnell states that Major Greenstreet signed the original memo removing AMCO enforcement and discusses with the board inviting Major Greenstreet to attend a board meeting in order to explain his concerns.

She discusses the executive order that consolidates investigators from multiple departments beginning in FY20, and the governor's stated intention to repeal the Alcoholic Beverage Control Board and Marijuana Control Board and transferring the boards' responsibilities to the Commissioner of Commerce as listed in his budget proposal.

Glenn Brady states that it is not in the public interest to regulate alcohol and marijuana in the same way as other commodities and he does not believe in repealing the boards.

Bob Klein states that the board should put together a resolution on the importance of the boards, and the board should look at the proposal and possibly put together a recommendation to the governor.

Glenn Brady moves that the ABC Board take a formal position that reaffirms the role with respect to public health and business interests in the state.

Sara Erickson seconds.

Bob Klein states that he is also in opposition to the abolishment of the boards, and that it is very telling that the industry is also against the abolition of the boards.

None opposed, motion carries.

Erika McConnell offers to call for a special meeting once the draft legislation regarding this matter has been published.

Bob Klein confirms that it would make sense for the board to hold a meeting to discuss the matter once draft legislation has been published.

Erika McConnell summarizes the remaining budget information and then discusses SB 16 that creates a fair license, theatre license, concert permits, and addresses tax concerns that are related to statutes that are not in Title 4. She states that SB 52 is the title four rewrite for this legislative session.

She reminds licensees and the public that April 12^{th} is the completion deadline for documents to be submitted for the board to consider at their April meeting.

BOARD INTERPRETATIONS

9:42 am

A. Controlling Interest

TAB 3

Erika McConnell summarizes the information in Tab 3 and states that AMCO has had push back on the current definition of controlling interest. She summarizes the history of the Controlling Interest definition and states that if a change occurs to the current definition of controlling interest, it should be done through a regulations project.

Rex Leath states that overall there don't seem to be a large amount of complaints regarding this matter and that there is no reason to rewrite the current interpretation.

Glenn Brady states that, regarding this administrative kerfuffle, subchapter C vs S corporation can get complicated and he would like to voice concern that a transfer of controlling interest is substantial

expense and work to complete and that there is a large administrative burden on the licensees and applicants but that there is no clean solution.

Bob Klein states that based on the statistics, there is no reason to rewrite the interpretation.

No further action is taken on this matter.

B. Shared Tasting Rooms

TAB 4

Erika McConnell summarizes the information presented in Tab 4 and the board's wish to discuss clarification on shared tasting rooms and combined tasting amounts.

The phone is opened to comment.

Sassan Mossanen, licensee with Denali Brewing, is present via phone to comment. He states that he is available for any questions. He asks that the board comes to a determination on this matter with sensitivity to the fact that they (Denali Brewing) have been operating with a shared tasting room for three years.

Bob Klein states that the issue is how much a customer can be served.

Glenn Brady states that he is curious about the current practices in place to track volume limits for tasting rooms for customers.

Sassan Mossanen discusses how his operation handles shared tasting room limits and tracking the limit amounts; the tasting amounts are combined, the bar tenders are responsible for preventing over service, there is an identification marker that is used for staff to identify customers, and audits are completed by having friends of the licensees come in and attempt to over purchase.

Glenn Brady states that his concern is less about overservice and more about maintaining legislative intent regarding the limits. He states that the legislative intent of the tasting room limits was to support small manufacturers and that with the evolution of the industry there is more incursion regarding retail and that the board must be mindful of the intrusion of manufacturers into retail. He encourages the brewers and distillers guilds to consider the tracking of these types of limits.

Bob Klein states that the consensus is that this matter needs more study.

Paul Thomas – Alaska Cache Liquor and CHARR Board Member– states that he believes that adding the limits together allows a manufacturer to function like a Beverage Dispensary License.

Sara Erickson asks why the limit would increase if you have several licenses.

Bob Klein states that the problem with the proposal to not have combined tasting limits is that the "three drinks" allowed currently varies and that the board would need to define "drinks" and that the question is how to limit a single customer.

Sassan Mossanen states that a manufacturer tasting room is substantially different from the operations of a Beverage Dispensary License even without the smaller limit. He states that sales from the tasting room only equal 3-4 % of sales for his manufacturing licenses. He asks that the board understand that they have been cleanly operating with the combined limits for 3 years already.

Bob Klein states that he would like to form a committee of 1, of which he will be the sole member and he will discuss this matter with the distilleries and breweries and then bring a possible solution to the board.

C. Fines For Violations TAB 5

Erika McConnell summarizes the history of a possible schedule of fines for violations as written in Tab 5.

Bob Klein states that there needs to be a fine for violations rather than only for accusation or court conviction due to the substantial amount of time and effort on staff's part needed to bring an accusation and impose a fine. He suggests that consideration this matter is held until the Title Four rewrite is either passed or denied.

Erika McConnell states that she is not suggesting action but providing the board information.

ENFORCEMENT REPORT

10:11 am TAB 6

Bob Klein asks James Hoelscher (present via phone) to discuss the possible changes to enforcement.

James Hoelscher (Chief Enforcement Officer) states that there is education and good occurring from enforcement. He summarizes the information in Tab 6 and discusses the number of alcohol suspensions in schools decreasing. He states that the changes to ARMS/APSIN access has decreased the efficacy of enforcement, and answers board questions regarding the impact of the removal of access.

Phone difficulty occurs and the phone line is restarted.

James Hoelscher answers board questions regarding the effect of the changes to ARMS/APSIN, travel budget cuts, and the possible effect on enforcement travel.

Phone issues continue and the meeting pauses to address the technical difficulties.

A. Notices of Violation Issued and Licensee Responses

TAB 7

James Hoelscher summarizes the most concerning NOVs for the board.

- 4526 Gold Miners lodge is an NOV for leasing the property and license since mid-2017, and the licensees no longer hold right, title or interest in the property.

Bob Klein asks if the Director wishes to speak to this matter due to the statement by the licensee that they are attempting to comply with the requirements.

Erika McConnell states that this matter is on the list of items to review more closely for possible accusations.

- Page 35 of Tab 7, license 5651 DBA Black Spruce Brewing Company received NOVs for minors on premises. Hoelscher states that essentially the brewery does not have an RDP and therefore may not employ individuals under 21 years old.
- Page 44 License 3759 DBA Airport Restaurant & Lounge received an NOV for Server Education for a server card that was expired for over a year.
- Page 48, 5613 DBA Alaska Proof (now Alaskan Spirits Distillery) received 3 NOVs, all within a short amount of time for pricing and marketing, DBA, and pricing and marketing again.

Bob Klein asks if accusations are being brought against all of the NOVs that have been highlighted.

Erika McConnell states that she would be bringing accusations as necessary, but that the board can also indicate which matters they find most important to bring accusations for.

Glenn Brady states that he sees a lot of administrative NOVs such as NOVs for unreported change of officials which is not a public safety concern, education should occur but accusations are not necessary. However, pricing and marketing and minors on premises are larger concerns and follow up and scrutiny should occur.

Bob Klein asks if there is a specific category of pricing and marketing that Glenn Brady has concerns over.

Glenn Brady states that more education needs to occur when pricing and marketing is not followed, he believes that there is a shortcoming in education rather than willful violation and that more education should occur. He states minors on premises should be addressed because it is a larger concern.

James Hoelscher states that enforcement does a large amount of education and reaches out through NOVs as a communication tool to licensees. He states that the NOVs stimulate communication with numerous licensees, but that there are situations where a licensee may be ignoring the provided information and policy or statute and these situations must be addressed.

Glenn Brady states that he agrees with Hoelscher, if the violation stems from willful disregard or blatant inability to control operations that the matter should be acted upon.

Erika McConnell states that IT has been contacted regarding the phone problems and asks if the Board wishes to hold the matter until the IT issue is sorted.

Break is called at 10:39 Meeting resumes at 11:00 am. Bobby Evans leaves the meeting.

A. 4965 Piccolino's: Piccolino's Restaurants, Inc.

Erika McConnell summarizes the information provided in Tab 8 and states that there is a typo in the accusation, the original issue date should read March 3, 2010.

Rex Leath asks if the violation for 4965 was intentional and the transfer requirement is discussed with Erika McConnell. Erika McConnell states that transfer has been submitted but not completed, and adds that there have been three transfer applications for 5390 submitted but not completed.

Bob Klein asks to take Tabs 9 and 10, license 4965 DBA Piccolino's and 5390 DBA Baked Alaska Alehouse, together.

B. 5390 Baked Alaska Alehouse: Baked Alaska Alehouse, Inc. 3048 Mountain View Drive, Suites 102 & 104, Anchorage

License: Restaurant or Eating Place

Erika McConnell summarizes the information provided in Tab 9. No one is present in person or via phone to testify for either tab.

Glenn Brady asks if the fines are consistent to similar circumstances.

Erika McConnell states that in 3AAC.304.540 a fine schedule was adopted for accusations. (She reads the regulation.)

Glenn Brady asks if the licensee has appeal rights if the recommendations are adopted.

Erika McConnell confirms that they could appeal.

Bob Klein asks for a motion for licenses 4965 and 5390.

Sara Erikson moves to adopt staff recommendation to suspend both licenses until transfer applications are submitted and effectuated and a transfer license is issued, and impose a \$10,000 civil fine for each license. Rex Leath seconds the motion None opposed, motion carries.

C. 5559 Piccolino's Restaurant: Piccolino's Restaurants, Inc. 12801 Old Glenn Highway, Fagle River

Erika McConnell summarizes the information provided in Tab 10 including the staff's recommendation. She answers board questions regarding where the Beverage Dispensary License previously located at this premises went, and the specifics of staff's recommendation.

Sara Erickson moves to adopt staff recommendation to suspend license 5559 for 30 days and impose a \$25,000 civil fine due by the end of the suspension.

Glenn Brady seconds the motion.

Sara Erickson discusses licensee accountability.

Bob Klein states that he is in favor of the motion.

Rex Leath asks Erika McConnell if the AMCO office has been diligent and timely in their responses and notifications in the accusation process. McConnell confirms that it has.

Sara Erickson and Erika McConnell discuss the number of months that passed after the protest was lifted by the municipality regrading this license. Erika McConnell clarifies that the fine must be paid by the 30 day suspension deadline, and that the fine would be required before the suspension is lifted.

None opposed, motion carries.

Mikal Milton summarizes the information presented in Tab 11, highlighting the information regarding the alcohol renewal season and the number of licenses that have renewed thus far (820), approximately 90% of

Glenn Brady states that based on the correspondence from staff it appears that they clearly state the requirements.

Sara Erickson states that there may have been someone on the phone for the previous item and that people should be allowed to speak.

None opposed, motion carries.

Glenn Brady asks Erika McConnell about the statement in the licensees written request that she was only given 24 hours' notice that she was going to be put on the agenda to be heard and that she was required to submit her request within that 24 hours.

Erika McConnell states that staff held the notices in order to provide the least amount of disruption to the business of these licenses as possible.

Sara Erickson and Erika McConnell discuss the 90 day deadline for transfer in the case of the death of a licensee.

Erika McConnell summarizes tab and provides information as to the fire that occurred at this establishment. She reminds the board that they could table the matter.

No applicant is present to speak in person or via phone.

Bob Klein asks to postpone to the next meeting with a new affidavit and that they must provide proof of their operations numbers.

Mikal Milton answers board questions regarding the process by which staff discusses the restaurants receipts affidavit with applicants. She confirms that staff does reach out to applicants to confirm that the numbers that they have listed are accurate.

Bob Klein asks that staff ask applicants to provide proof of operations.

Rex Leath states that the board must not assume people are getting this calculation wrong, they must not set the president that the number is assumed to be a mistake.

Bob Klein states that maybe the form can be re-worded.

Consideration of this matter is postponed.

F. 5726 CO-HO Imports AK: GFA Corporation 601 West 58th Avenue Unit #U28, Anchorage

License: Wholesale-General

Reconsideration of license approval; location is storage unit.

Erika McConnell summarizes Tab 17.

Dan Cho, applicant, is present in person to testify.

Dan Cho summarizes his local and international operations and states that he was forced to choose the personal storage unit. He says that they do have product and expense and he asks the board to allow the state of Alaska to access quality product.

Bob Klein clarifies that it is the premises that is the concern, not the product.

Bob Klein entertains a motion for reconsideration and denial of the application. Glenn Brady so moves.

Rex Leath seconds the motion.

Bobby Evans asks that staff work with the applicant to bring a compliant application to the board.

Rex Leath states that it is not just the fact that this is a storage unit, but that there are multiple licensees who have worked for years on a compliant premises and it is appropriate to consider that work.

Glenn Brady states that this requirement is in place for a reason.

None opposed, motion carries.

PUBLIC HEARINGS – PROTESTS

A. 156 In and Out Liquor #1; Dong K. Kang 3601 Arctic Blvd, Anchorage

License: Package Store

Renewal application.

Municipality of Anchorage protests pending public hearing regarding renewal.

Erika McConnell and Bob Klein summarize Tab 18.

Dan Coffey, as previous counsel for Mom and Pops, is present in person to testify and discusses the concerns regarding package stores in the Community Council area and the parameters regarding alcohol sales and states that the manner in which the Municipality of Anchorage is protesting the package store renewals in the community counsel area is a problem and urges the board to examine the manner in which the Municipality is handling the alcohol sales in package stores within that area.

Rex Leath states for the record that Coffey's comments will be considered and are appreciated and that the board must listen to this type of information.

Glenn Brady asks staff, when local governments place particular conditions on a license, if there is follow up with the local government.

Erika McConnell states that the ABC Board has not engaged with the Municipality on this matter at this time. The city has passed an area-wide condition on downtown but that at this time staff is not sure why the Municipality has not moved forward with a similar condition within this community counsel area. She states that the control that the state has over the local government is limited to the determination that a protest is arbitrary, capricious and unreasonable.

Glenn Brady states that it's not about the board exercising power over the local government but about communication with local government about their concerns regarding regulating licensees.

Dan Coffey states that the downtown conditions were supported by the industry and public and that the area-wide restriction was appropriate. He finds that to be appropriate but the Municipality has not moved forward on this matter of an area-wide restriction.

Sarah Oates- President and CEO of Alaska CHARR states via phone that the municipality is holding discussion of the ordinance until after the April election to wait until the new alcohol tax is considered. She urges the board to allow a 90 day abeyance rather than the 45 day abeyance in case of postponement by the Municipality to provide adequate time for the licensee to request an additional abeyance if necessary.

Erika McConnell states that she does not object to 90 days.

Bob Klein requests a motion to uphold the protest with 90 day abeyance. Glenn Brady so moves. Sara Erickson seconds.

Rex Leath asks if staff knows the reason for the protests.

Erika McConnell explains that the municipality stated "pending a public hearing and subsequent final action by

the municipality" and that she followed up and was told verbally that this protest had to do with the midtown community council conditions.

Rex Leath states that 04.11.480 requires reasoning for the protest.

Erika McConnell states that the reason has been provided, that the municipality's reason is that they are still considering the license, but it is up to the board to determine if that reason is sufficient.

Rex Leath states that he finds this insufficient information and that based on 04.11.480 the municipality must provide their reason.

Erika McConnell clarifies that there are multiple ways in which the board and local government communicate, that local governments have not been required by the board to attend meetings and defend their protests but that it is a requirement in statute. She states that it is fair for the board to allow the local government to state that they have a problem with the license. It is clear through her verbal communication with the municipality that the concern is regarding the possible community counsel conditions. She offers to communicate with the local government regarding protest requirements but she recommends upholding the protest.

Glenn Brady states that he agrees with Rex Leath's comments and that as part of a regulatory body, he feels that it should be insisted that protests be defended by the local governing body where appropriate. He is concerned about a situation where a single clerk or person impedes entrepreneurship through bureaucratic process and that local governing bodies should be held to the same high standard as licensees are held.

Bob Klein states that it has been a substantial effort to educate local governing bodies and that perhaps it is an overstep by the Municipality, but that the board should be careful about how it restricts the local governing bodies; it still must be considered.

Rex Leath states that he finds the provided reason to be an insufficient reason and he states that the 60 day deadline is passed.

Bob Klein states that this is not a stall, it is the municipality doing its due diligence.

Rex Leath clarifies that he does not find subsequent hearings to be good cause. All entities should be held accountable, including local governments.

Glenn Brady, Rex Leath, Sara Erickson, Bobby Evans and Bob Klein are against the motion. Motion fails 0-5.

Erika McConnell summarizes history and application in Tab 83, and staff's recommendation.

Jerome Hertel, with the Alaska State Fair testifies in person. He provides a history of the fair's recreational site license operation. Referencing AS 04.11.537, he states that he feels the fair meets the statute, and that the consideration of the renewal should not be held or changed based on the possibility of new legislation.

Sara Erickson states that the recreational site section is very vague. She states that the fair has events where alcohol is served one hour before and after the event.

Erika McConnell explains her interpretation of the recreational site statute as stated in Tab 83.

Sara Erickson states that there are lots of shows at the state fair, and asks if there is a way to find the right type of license.

Bob Klein states that approving the renewal would be the easiest thing to do.

Glenn Brady states that another option would be for the fair to be catered through the exercise of permits, McConnell states that catering permits are not number-limited.

Glenn Brady states that there are other options to licensure but that they are onerous and complicated.

Jerome Hertel states that there is another option but he argues against this option as the limit is 5/year, and that the license is exercised year-round.

Bobby Evans looks at the memo from the director, he looks at the remainder of the memo and states that "the grandstand" is the only area in the fair that meets the recreational site statute. He states that if the fair only wants to use the location that does apply, that renewing with conditions would be acceptable.

Bob Klein states that the director/staff MUST make the recommendation that they have made and it is the prerogative of the board to make determinations.

Glenn Brady moves to grant the renewal with the caveat that this will not set precedent for additional licenses to be approved.

Sara Erickson clarifies how long the license is granted for and what the motion is.

Sara Erickson seconds the motion.

ABC Board Meeting Minutes: February 19, 2019

Harriet Milks states that, for the record, the board has the authority to act in the public interest but that they do not have the authority to act based on aspirational legislation.

Rex Leath states that the adults in the room need to focus on the definition of the regulation, not about supporting the state fair serving alcohol. He states that the board must keep in mind that there are smaller businesses that need to be considered as well, and that the state fair should not be considered above other licensees.

Glenn Brady states that he hoped to encapsulate the intent stated by Rex Leath in his motion.

Sara Erickson adds that there is a difference between a waiver and renewing the license, and Arctic Valley was given a license and they should do the same for the State Fair, she says it is about the state fair being able to sell alcohol and the board supporting them.

Sarah Oates, Alaska CHARR, states that if SB 16 is out there and disregard only the application of the state fair, the board should renew the license. She summarizes the written statement that she made regarding this matter that was included with the tab. She states that other licenses have been given the "two year" warning, and they have not given that warning to the State Fair.

Bobby Evans asks if the fair sells beer and wine 1 hour before and 1 hour after the event(s)?

Bob Klein states that if there is an event that follows the rules it's an accident.

Bob Klein states that there is a motion to approve the licenses renewal and that the action is only applicable for 2 years, but that the matter will be considered

Roll call vote, none opposed, motion carries.

Jerome Hertel states that for the record he understands that it is not the intention of the board to shut down the state fair.

Erika McConnell states that she appreciated speaking with the applicant and that staff had recommended that the DBA name change be filed; she does not have additional suggestions on how to operate under "The Big I" without having a DBA of "The Big I".

Glenn Brady states that there are a couple of matters regarding the testimony- he states that he understands

from the bureaucratic perspective, but that there is no evil intended by the licensee and he understands the frustration. He states that the licensees response includes information that insurance carrier told him about the investigation before staff informed him. Erika McConnell summarizes the request for regulation change as listed in Tab 120 regarding how the requirement for "Duplicate Beverage Dispensary Licenses" is defined in AS 04.11.090(e), and answers board questions regarding the situations in which this type of question arises.

Bob Klein states that the general usage has been "if you cannot see and control alcohol from the original bar".

Glenn Brady states that the current bill SB 52 addresses many of these matters, and he feels that at this time a project is not necessary.

Bob Klein states that he agrees with Brady's assessment and, if there is a situation that arises when it is unclear, the board may address it at that time.

2. Board Requests

Glenn Brady asks if there is a way to track the use of catering permits by license and location to better understand the usage of catering permits. He states that additional guidance for catering permits may be required, particularly for REPL and BDL catering permits. He notices that there are beginnings of rumblings regarding the difficulty of permit applications.

Erika McConnell states that staff does not have a way to track permits by location and that a new database would assist in this matter. She states that Tab 122 is a project for permit applications and perhaps adding information in that tab to address Glenn Brady's concerns would be appropriate.

1. Definition of Moral Turpitude

TAB 121

Status: Initial draft for board consideration

Potential Board Actions: Amend and/or put out for public comment

Erika McConnell summarizes the information in the Memo for Tab 121; Regulations project "Definition of Moral Turpitude".

Harriet Milks states that the list is a closed list, and that the board can make a determination of they wish to be closed or open by the use of the word "includes".

Erika McConnell asks that the list remain closed so that the requirements are clear.

Glenn Brady asks if opening the list precludes the board from considering other information that may be brought to light during a background check.

Erika McConnell clarifies the intent of the regulation project, to clarify what matters must be brought to the board for consideration, and states that opening the list could make it a more ambiguous matter.

Glenn Brady states that the provided list may not include many items that may need to be considered by the board such as drug trafficking or money laundering.

Sara Erickson asks how the question is put forth in the application, and asks if there is a better way to phrase the question.

Glenn Brady asks if adding the entire laundry list would make the situation more difficult for staff.

Harriet Milks states that adding the entire list would require the project to go back out for public comment, but she feels that adding additional items would not make review more onerous on staff. She mentions that many boards struggle with the words "moral turpitude".

Erika McConnell reads the certification as listed on the AB-08a form. "I certify that I have never been convicted of an act that constitutes a crime involving moral turpitude".

Sara Erickson and Bob Klein discuss the requirements listed on the the moral turpitude form, and if the board should consider the matter when the conviction is over 10 years old.

Erika McConnell states that this is the purpose of the project, to differentiate between a robbery conviction and a murder conviction.

Glenn Brady moves to amend the list to add the list that was presented by McConnell (20 AAC 10.035) and he would like to add embezzlement, money laundering and drug trafficking.

Rex Leath states that it must be clarified that the applicant may not even be the one that is proximally managing operations, and there may be employees who have criminal convictions.

Glenn Brady clarifies the difference between conviction of a crime and commission of a violation.

Harriet Milks confirms that it must be a criminal conviction, not just a charge, to be brought to the board.

Erika McConnell states that it must be a conviction rather than being charged, and discusses board questions regarding the board's consideration of certain criminal histories, and if it is in the public interest to allow them to hold a license.

The board discusses the types of convictions that are relevant that the board wishes to see that is older than 10 years.

Bob Klein states that he does not support expanding the list of qualifying convictions.

Glenn Brady allows his motion to die.

Glenn Brady moves to send regulations project "Definition of Moral Turpitude" out for public comment. Sara Erickson seconds the motion.
Roll call vote, none opposed, motion carries.

2. Permits TAB 122

Erika McConnell summarizes the memo attached to Tab 122, and requests that the board particularly look at the "Banquet or Dinner Event" clarification. She states that the Caterers permit section is proposed to be repealed because all relevant requirements were covered in the earlier proposed section about permits generally, but that if the Board wishes to clarify any requirements for this type of permit, the board may add it back in.

Glenn Brady states that he wishes more time to think about this matter, particularly regarding the five location limit for each art exhibit event date, he asks if there is a compelling reason not to limit the number of locations to one.

Bob Klein and McConnell discuss if this is a limit to the number of applications for the organization and if this puts an undue burden on the applicants.

Sara Erickson states she is not in favor of rural communities being able to take online classes. She would like to see a tightening of the requirements.

Erika McConnell states that there is not currently a way for AMCO to determine how the applicant received their card. She answers board questions regarding training access and the nature of the related NOVs.

Bob Klein states that he wishes to see the online courses be more comprehensive.

Erika McConnell discusses the qualifications for class requirements, frequency of review of courses, and if the board wishes to review the courses currently in place.

Bob Klein states that he wishes to see the course documentation for the current approved courses.
