Recommendation:

Background: On the renewal application for the O.K. Restaurant, a restaurant or eating place license issued to Dae J. Chung, the licensee indicated that in 2017, 20% of the gross receipts were from food sales, and in 2018, 15% of the gross receipts were from food sales.

AS 04.11.100(e) states, "A license may be renewed under this section only if the licensee provides evidence to the board's satisfaction that gross receipts from the sale of food upon the licensed premises constitute no less than 50 percent of the gross receipts of the licensed premises for each of the two preceding calendar years."

At the February 2019 meeting, the board tabled the renewal of this license and requested the applicant to submit a revised statement regarding gross receipts along with supporting documentation. Information submitted by the licensee's accountant indicates 85% of gross sales in 2018 was from food, and 80% of gross sales in 2017 was from food. The supporting profit and loss statements are in the board's confidential folder on the laptop.

To Whom it May Concern:

I, Kang Cho, am writing on behalf of Dae J Chung & Grace Chung in regard to the letter we received about the postponing of O.K. restaurant's liquor license renewal. Because the alcohol renewal form changed in recent years and I was on vacation during the period, Grace Chung had to fill out the form by herself. Because of h/er difficulty with English, she incorrectly indicated sales of 85% alcohol and 15% food for 2018 and sales of 80% alcohol and 20% food for 2017. The correct ratio was 15% alcohol and 85% food and 20% alcohol and 80% food, respectably. It is impossible to sell more than 80% alcohol in Chinese restaurant other than a mistake.

I've attached a profit and loss statements listing their total sales for food and alcohol which clearly represents the above indicated correct distribution. If you need more documentation for proof, then we can provide bank statements at your request. If you have any questions you may contact myself or my client at 907-561-0101.
