Requested Action:

License renewal

Statutory Authority:

AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.480(a): "A local governing body may protest the issuance, renewal, relocation, or transfer to another person of a license by sending the board and the applicant a protest and the reasons for the protest within 60 days of receipt from the board of notice of filing of the application... The board shall consider a protest and testimony received at a hearing conducted under AS 04.11.510(b)(2) or (4) when it considers the application... If an application or continued operation is protested, the board shall deny the application or continued operation unless the board finds that the protest is arbitrary, capricious, and unreasonable."

AS 04.11.510(b)(2): "The board may review an application for the issuance, renewal, transfer of location, or transfer to another person of a license without affording the applicant notice or hearing, except...(2) the board may, on its own initiative or in response to an objection or protest, hold a hearing to ascertain the reaction of the public or a local governing body to an application if a hearing is not required under this subsection;"

Staff Rec.: Hold a public hearing; deny the application with a 180-day abeyance

Background: The City of Ketchikan protests the renewal of this club license due to outstanding taxes owed and the lack of required correction of sewer code violations.

The licensee should be notified that under 3 AAC 304.145(h), this abeyance period may not be extended or renewed.

PROTEST OF BEVERAGE DISPENSARY LICENSE RENEWAL

Ketchikan Loyal Order of Moose Lodge #224

Pursuant to Alaska Statutes 04.11.480, the City Council of the City of Ketchikan, Alaska, hereby protests the renewal of the following license for the sale of alcoholic beverages:

Club Liquor License Number 743 Ketchikan Loyal Order of Moose Lodge #224 744 Water Street, Ketchikan, AK 99901

This protest is based upon each and all of the following facts and conclusions:

- 1. The business operated under this license for the sale of alcoholic beverages is known as Ketchikan Loyal Order of Moose Lodge #224 operating at 744 Water Street, Ketchikan, Alaska 99901;
- 2. Pursuant to the Ketchikan Municipal Code Chapter 3.20 and the Ketchikan Gateway Borough Code Chapter 4.45, Ketchikan Loyal Order of Moose Lodge #224 is required to pay the entire taxes imposed by these chapters on or before the due date as set by ordinance. In the event the tax is not paid on or before the due date, the tax shall become delinquent, a penalty as set forth hereinafter shall be added to all delinquent taxes, and interest accrue on the amount of unpaid tax, not including penalty, from the due date until paid in full;
- 3. Sales taxes are owed by the property owner to the City of Ketchikan and Ketchikan Gateway Borough. Such taxes due have become delinquent and continue to accrue penalties and interest;

4. Ketchikan Loyal Order of the Moose Lodge #224 is delinquent on City and Borough sales taxes in the amounts represented below as of March 22, 2019:

with interest and penalties continuing to accumulate;

- 5. Correction of existing sewer code violations as set for in the building inspector's report.
 - 1. Plumbing fixtures are not connected to the municipal sewer system. Notices to the establishment were sent on numerous occasions beginning July 17, 2018. On February 21, 2019 a physical inspection was done, and there was no change in the conditions of the drains.
- 6. Under KMC 5.20.050(b) the City Council may protest the renewal of a license for the sale of alcoholic beverages if the business operated under that license is delinquent in the payment of any taxes arising out of the operation of the licensed premises, and under KMC 5.20.050(a)(8) whether the premises complies with local, state and federal fire, health and other safety codes.
- 7. On April 4, 2019 the City Council of the City of Ketchikan conducted a hearing on whether to protest the renewal of this license. The minutes of all the Council meetings are attached for your review;

For each and all of the above reasons, the City Council hereby protests the renewal of the Beverage Dispensary license for the sale of alcoholic beverages issued to Ketchikan Loyal Order of Moose Lodge #224, 744 Water Street, Ketchikan, AK 99901

5.20.050 City council review of issuance, renewal or transfer of licenses.

- (a) Upon receipt of notification from the Alcoholic Beverage Control Board or the Marijuana Control Board that the Board has before it an application for the issuance, renewal or transfer of an alcoholic beverage license or marijuana establishment license, the council shall determine whether to protest the proposed action and shall consider such of the following facts as the council believes are pertinent:
 - (1) The character and public interests of the surrounding neighborhood;
 - (2) The actual and potential law enforcement problems, including the proximity of the premises to law enforcement stations and patrols;
 - (3) The concentration of other licenses of the same and other types in the area;
 - (4) In respect to an alcoholic beverage license whether the surrounding area experiences an unacceptable rate of alcohol abuse, or of crime or accidents in which alcohol is involved as a cause or in respect to a marijuana establishment license whether the surrounding area experiences an unacceptable rate of marijuana abuse, or of crime or accidents in which marijuana is involved as a cause;
 - (5) The comments and objections, if any, of the residents, owners, and inhabitants of the surrounding area;
 - (6) The adequacy of parking facilities;
 - (7) Unsafe conditions at the licensed premises, including, but not limited to, the safety of ingress to and/or egress from the premises;
 - (8) Whether the applicant has timely permitted the inspection provided for under KMC 5.20.040 and whether the premises complies with local, state, and federal fire, health and other safety codes;
 - (9) The degree of control the licensee has, or proposes to have, over the conduct of the licensed business;
 - (10) The history of convictions of the applicants and affiliates of the applicants for:
 - (A) Any felony,
 - (B) Any criminal violation of state or local statute or regulation involving use or abuse of alcohol, marijuana or a controlled substance,
 - (C) In respect to an alcoholic beverage license any violation of AS Title 4 or regulations adopted by the Alcoholic Beverage Control Board, or in respect to a marijuana establishment any violation of AS Title 17 or regulations adopted by the

- (D) In respect to an alcoholic beverage license any violation of the alcoholic beverage control laws of another state as a licensee of that state or in respect to marijuana establishment license any violation of the marijuana control laws of another state as a licensee of that state;
- (11) Whether the applicant or the applicant's affiliates are untrustworthy, unfit to conduct a licensed business, or constitute a potential source of harm to the public;
- (12) The business operated under the license is, on the date the council considers the application, delinquent in the payment of any sales tax or penalty or interest on sales tax arising out of the operation of the licensed premises;
- (13) Whether there are delinquent property taxes or local improvement district assessments or penalties or interest thereon arising out of real or personal property taxes or local improvement district assessments or penalties or interest thereon arising out of real or personal property owned in whole or in part by any person named in the application as an applicant where such property is used, or is to be used, in whole or in part in the business conducted or to be conducted under the license;
- (14) Whether there are any delinquent charges or assessments owing the city by the licensee for a municipal service provided for the benefit of the business conducted under the license or for a service or an activity provided for the benefit of the business conducted under the license or for a service or an activity provided or conducted by the city at the request of or arising out of an activity of the business conducted under the license:
- (15) Whether the business to be opened under the license would violate the zoning code of the borough;
- (16) If an application is for a tourism license under AS 04.11.400(d), then:
 - (A) The city will protest any application based on construction of a new tourist facility unless the construction will include at least 30 rooms,
 - (B) The council will protest any application for a new tourism beverage dispensary license based on an improvement to an existing tourist facility of at least 30 rooms unless the improvements will result in at least a 50 percent increase in the assessed or appraised valuation compared to the value of the original tourist facility,
 - (C) The council, in addition to the requirements of subsections (a)(16)(A) and (B) of this section, as applicable, will require the applicant to show by convincing evidence that issuance of an additional beverage dispensary license to a tourist facility will, in fact, encourage tourism in the city. The applicant must prove that

tourism will constitute a majority of the business of the beverage dispensary license;

- (17) The numerical limitation on retail marijuana stores under KMC 5.20.015.
- (18) Any other factors the council determines are generally relevant or relevant to a particular application or to the public interest.
- (b) If council decides to protest the issuance, renewal or transfer of a license it shall state the basis of the protest and the applicant shall be notified of such decision and shall be afforded an abbreviated and informal hearing before the council to defend the application. At the conclusion of the hearing the council decision to protest the application shall stand unless a majority of the council votes to withdraw the protest. 5.20.040 Premises to be inspected.

Upon receipt of notification from the Alcoholic Beverage Control Board or the Marijuana Control Board that the Board has before it an application for the issuance, renewal or transfer of an alcoholic beverage license or marijuana establishment license, the city clerk shall notify the city fire inspector who shall inspect the proposed licensed premises and report the findings to the council. The applicant or other person in control of the premises shall permit such inspection at a reasonable time and upon reasonable notice. Until the report has been received by the council, the council will take no action which will waive its right to protest the application. (Ord. 1812 § 1, 2016; Ord. 1782 § 12, 2014; Ord. 1431, 2000. March 7, 2019

Mayor Sivertsen informed the City is working through the SEAPA organization and looking into wind generation and more hydro power. He said the current situation is a shortage of water storage in our facilities. He informed with the drought Ketchikan is having, the lack of water inflow and the rise in demands, the City has had to use diesel generation to provide electricity to the community for some time now.

Agnes Moran said she was here tonight to thank the Council for moving forward with the Community Development Block Grant. She said the block grant went through, and was impressed with the Public Works Department for putting together all the required documents. She indicated they were very excited to get moving on this project.

Landon Morgan, representing the Ketchikan Loyal Order of the Moose Lodge No. 224, said he thought the building code violation had been fixed. He indicated it was a misunderstanding with the contractor and the building will be ready for inspection next week. He stated they know this isn't the first time they have fallen behind in their taxes, but they are looking into alternate funding sources to bring their delinquent taxes current. He encouraged the Council to consider giving the club an extension until the next Council meeting to come into compliance.

Norman Arriola said he was here tonight to address the cruise ship discharge from last summer and had not heard anything else about it. He indicated the coastal seaweed is dead and is seems to be dead in all the areas where the cruise ships go. He stated we should cut our ties with Canada due to their abandoned mines that have dumped waste into the ocean and has flowed into Southeast waters. He said it was very disturbing that the king salmon have disappeared in our area and what is going on within our waters. He felt if things keep going the way they are, the entire fisheries will soon be wiped out. He thanked the Council for their time.

Mayor Sivertsen called for the public hearing on the liquor license protest of the Ketchikan Loyal Order of the Moose Lodge #224 to order at 7:02 p.m. and requested public testimony.

Bill Meck, representing the Ketchikan Loyal Order of the Moose Lodge #224, said the Lodge is working on clearing their tax debt with the Borough tax office, and resolving the broken pipes by

refinancing their building. He said the Lodge ran into a delay, but should have everything taken care of within the next couple of weeks.

Mayor Sivertsen declared the public hearing closed at 7:06 p.m.

COMMUNICATIONS

Mayor Sivertsen read Resolution No. 19-2733 honoring the Kayhi Cheer Team and Kayhi Kings Boys' Basketball team for taking home the 2019 State championships in Anchorage, Alaska.

Jaylyn Merrill, Head Coach for the Kayhi Cheer Team, said it was fabulous growing up in Ketchikan as a youth and that is why she chose to raise her kids here. She indicated this community is consistently supportive of our youth. She thanked the Council for this recognition and support of these young people and their programs.

Eric Stockhausen, Head Coach for the Kayhi Kings Boys' Basketball Team, echoed Coach Merrill's comments. He indicated this was the best basketball community in the State. He stated he was honored to be a part of what many others before him did to make Ketchikan a great place to live. He thanked the Council for this recognition.

Mayor Sivertsen said there was a laid on the table regarding Berth III and Berth III parking lot reconfiguration project which would be addressed during manager reports.

PERSONS TO BE HEARD

Nate Easterly said he was here tonight to ask the Council to reconsider the number of marijuana retail stores within the City limits. He summarized his experience as a grower and store owner. He said most of the products sold in Ketchikan come from Anchorage and most of the money goes back to Anchorage. He stated he would like to have the opportunity to open a business in the City that showcases local products. He cited statistics of other Southeast cities and the number of shops they have and felt Ketchikan has more to offer in a professional and ethical manner. He said he would like to know the legal process of how to reverse the number of retail shops in the downtown area previously set by the City Council. He informed he would be available to answer any questions the Council might have.

Charles Edwardson summarized his reasons for his request to purchase the property located on Carlanna Lake Road that is adjacent to his property. He felt the property was overvalued, non-conforming and unusable to anyone else as there were no other property owners that adjoin the property. He indicated it would add value to the property he owns. He summarized his plans for the property and benefits to the City. He informed he would be here to answer any questions the Council may have.

Terrance Robbins said he is currently working under a State of Alaska tobacco prevention and control grant for residential youth care. He spoke regarding the use of e-cigs by our youths in Ketchikan, which is currently considered an epidemic nationwide. He stated according to the Surgeon General and the FDA they have never seen any substance increase in use at the rate that e-cigs have, and last year alone there was a 78% increase. He summarized the national and local statistics. He reported a new product called "JUUL" which is extracted with pure nicotine and


Form AB-17: 2019/2020 Renewal License Application

What is this form?

This renewal license application form is required for all individuals or entities seeking to apply for renewal of an existing liquor license that will expire on December 31, 2018. All fields of this form must be complete and correct, or the application will be returned to you in the manner in which it was received, per AS 04.11.270 and 3 AAC 304.105. The Community Council field only should be verified/completed by licensees whose establishments are located within the Municipality of Anchorage or outside of city limits within the Matanuska-Susitna Borough.

This form must be completed correctly and submitted to the Alcohol & Marijuana Control Office (AMCO)'s main office, along with all other required documents and fees, before any renewal license application will be considered complete. Receipt and/or processing of renewal payments by AMCO staff neither indicates nor guarantees that an application will be considered complete, or that a license will be renewed.
