Dear ABC Board members,

This comment is in response and to provide clarification to statements in Ms. McConnell's email regarding record requests from AMCO to Alaska CHARR.

On December 14, Craig Douglas sent me an email (attached) requesting a list of <u>all</u> server education classes CHARR has provided over the last two years, including locations and number of attendees. Our registration logs are all paper, so this could take a substantial amount of time to compile.

On December 17, I visited Mr. Douglas in person during a short break of the ABC Board meeting. I told him that compiling a list would require dozens of man hours that I could not afford, and offered to have AMCO staff review the paper records and compile a list themselves. Alternatively, I asked what his deadline was for the request, and he said that it wasn't urgent and not to worry about it. I told him to send me a reminder email when it became urgent.

On February 6, Jed Smith called and said he was following up on Mr. Douglas's request, and clarified that AMCO only wanted dates and locations of scheduled classes that had been cancelled over the last year or two. I asked him to send me an email so that I would not forget to send him the requested records. 14 minutes after receiving Mr. Smith's email request, I forwarded the email (attached) as "High Importance" to our Training Director who was in the middle of teaching a class.

On February 7, another staff member reminded me that our Training Director was teaching a two-day (February 7-8) ServSafe class at Hiland Mountain Correctional Center as part of a recidivism project that Alaska CHARR has been working on with the State's prisons and correctional facilities. I immediately sent an update to Mr. Smith (attached).

Our staff worked the entire weekend (February 8-10, 7:00am-5:00pm) at UAA for the Alaska ProStart Invitational – a prestigious high school culinary and restaurant management competition put on by the Alaska CHARR Future Hospitality Leaders Program. Our office was closed on Monday, February 11, to give staff a day off after the busy weekend.

On February 12, I was reminded that our Training Director had scheduled two weeks of personal leave, so I emailed an update to Mr. Smith (attached).

On February 13, I sent a text to our Training Director, asking if he could recall the information, even though he was out of state and did not have access to his records – cancellations would have been noted in his emails (to which only he has access). He provided me with the following information:

- We have never cancelled an alcohol server (TAP) class in Anchorage during the 3+ years of his employment with Alaska CHARR.
- On September 24 of last year, a Fairbanks class was cancelled this was during a period of time when Alaska CHARR was without an executive, and the entire Board was attending an annual meeting and convention in Sitka.
- In 2017, a couple of classes provided in Ketchikan had dates changed from those published in our bimonthly magazine because a training venue was unavailable.
- In 2017, the Seward instructor was going to cancel a class, but our Anchorage-based Training Director drove down to cover.

To answer AMCO's request, there has only been one TAP class that has been cancelled during the preceding two years.

I am happy to answer any additional questions that you or the AMCO team may have.

Dear Members of the Alcoholic Beverage Control (ABC) Board,

The Alaska Cabaret, Hotel, Restaurant, and Retailers Association (CHARR) strongly opposes the repeal of the ABC and Marijuana Control Boards, as proposed in the Governor's amended budget, released February 13, 2019.

Placing alcohol regulation under the sole control of an individual, rather than a diverse group, would put businesses and the Alaskan public at risk. Under the existing structure, a balanced board - composed of two very-experienced industry members, a public safety member, a rural member, and a member of the general public - makes decisions on proposed regulatory changes, issuance of licenses, and alcohol enforcement. Members of this diverse group are able to provide valuable insight from their unique experiences, leading to effective problem solving and compromise.

Under the proposed changes (as generally stated, sans legislation), a single individual, whose experience and interaction with the alcohol industry could vary drastically from person to person, would be responsible for determining the regulatory climate. This will lead to further inconsistencies in interpretation and enforcement, as well as uncertainty and confusion within the highly-regulated industry.

Having the balance and expertise of the quasi-judicial is vital to the success of industry members, and to the health and safety of the public as a whole. Alaska CHARR understands and appreciates that the ABC Board is the appropriate regulatory authority for the alcohol industry, and sincerely hopes that that will not change.

Under what legal authority are you requiring Mr. Jackovich to delete that Facebook account?


