There are no glass windows or walls in the designated area at this time.

The "Doing Business As" in the licensing file shows Gavora's Liquor #1. However, signage on the exterior of the establishment shows the name has been changed to Gavora's Fine Wine.

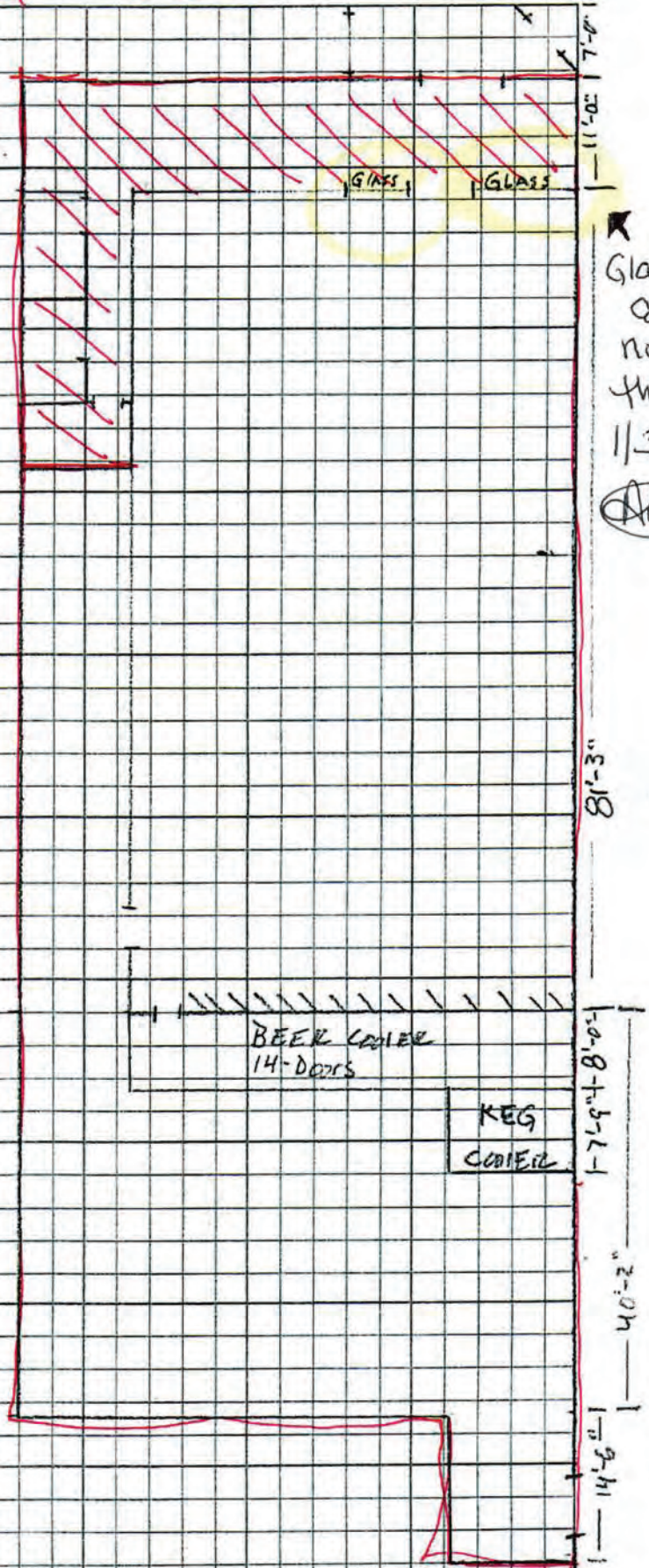



We hire only 16 yr olds and up as Hostesses. No hostess takes any Beverage orders. No one under the age of 21 takes beverage orders or handles Alcoholic beverages.

I have been in this business at the same location for over 29 years and have always filed the proper paperwork. The 4 names mentioned were employed back in 2018 and they were brought on in preparations for the busy summer season. I was in and out of town last year several times, working on another business project.


I apologize for this oversight on my part. It has NEVER happened before and I will take extra precautions to make sure it will not happen again.

On the complaint that one of them was under the age of 15, that is not a true statement. Savannah Eberhard ( DOB [REDACTED] ) was almost 17 yrs old at the time we hired her, according to her application. She quit after a very short time, [REDACTED]

[REDACTED] that I would need the work permit signed before she could come back. The Grandmother called AMCO [REDACTED]

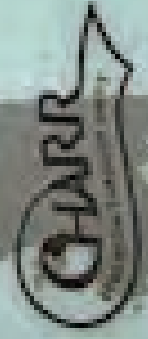

Per 3 AAC 304.525(1)(B), attached and below please find Sullivan of Alaska, Inc.'s (license no. 3412) formal, written response to the attached NOV, which was received and signed for on February 21, 2019.

Best of Alaska Event – Sullivan's Narrative of Event

Shannon Markley, the Marketing and Events Coordinator at the Anchorage Daily News ("ADN") contacted Sullivan's Steakhouse ("Sullivan's") in November 2018 and asked Sullivan's to take part in The Best of Alaska event ("the event"), to be held in the Dena'ina Center at the end of January 2019. Shannon requested that Sullivan's be a sponsor of the event. Sullivan's had taken part in the event the prior year without incident. The event was intended to be a charitable gathering to encourage community spirit, entrepreneurship, and involvement by Alaska businesses in the greater civic community. Sullivan's agreed to be a sponsor, but no specifics were discussed at that time about what exactly Sullivan's would do as a "sponsor" of the event. After this initial conversation, all communications took place between Jerrod Erdmann, Sullivan's General Manager, and Sarah James, an Advertising Account Manager at the Anchorage Daily News. Ms. James was, and is, a former employee of Sullivan's.

Approximately thirty days prior to the event, Ms. James and Mr. Erdmann discussed Sullivan's "sponsorship," and what Sullivan's might donate to the event. Mr. Erdmann suggested Sullivan's cheesesteak eggrolls and Ms. James, being familiar with the Sullivan's menu as a former employee, asked Mr. Erdmann about serving some of Sullivan's alcohol product ("the product" or "alcohol product"). Mr. Erdmann informed Ms. James that Sullivan's did not have an offsite liquor license and serving any alcohol product would not be permissible. Ms. James told Mr. Erdmann: "We have our own permit, and the Dena'ina Center has its own alcohol license, so don't worry about it." Mr. Erdmann did not confirm or agree at that time that Sullivan's would serve any alcohol product. As food had to be "pre-approved" by ADN staff prior to the event, and because no further mention was made of alcohol by the ADN or Ms. James, Mr. Erdmann understood in the weeks leading up to the event that Sullivan's would not be serving alcohol.

The day prior to the event, Tammy Gondliewski, the Sales and Event Planner at Sullivan's, set up the Sullivan's booth at the Dena'ina Center. At the time, no one at ADN discussed with Ms. Gondliewski that Sullivan's would be offering alcohol at the event, and Ms. Gondliewski understood that she was to serve food at the event only, from 1:00 – 3:00 pm on January 26, 2019. Ms. Gondliewski understood that this food would be donated by Sullivan's.

On the day of the event, Monica Moss, a Server and Hostess at Sullivan's, joined Ms. Gondliewski at the Sullivan's booth just prior to their designated start time at 1:00. Ms. Moss pointed out to Ms. Gondliewski that the Sullivan's booth was actually located in a dedicated "Beer Garden". Ms. Moss



and Ms. Gondliewski thought this was odd, since Sullivan's had no plans to serve beer. Just prior to their start time, Sarah James of the ADN approached Ms. Moss and informed her: "You all are supposed to have alcohol product here to serve." Ms. Moss was flustered and confused by this request, thinking that she had not properly packed all the items she needed to cater the event. Ms. Moss called Mr. Erdmann at the restaurant to inform him that she needed to come pick up alcohol product for the event at the request of the event organizer. Not wanting to cause an issue with the organizers due to a misunderstanding, Mr. Erdmann instructed Ms. Moss to come back to the restaurant and pick up the product, and asked Ms. Moss if both she and Ms. Gondliewski had their TAPS cards with them for service at the site. Both Ms. Moss and Ms. Gondliewski confirmed that they always kept their TAPS cards on their person in their wallets. Mr. Erdmann quickly packed the product and Ms. Moss picked it up and returned to the Dena'ina Center.

Both Ms. Moss and Ms. Gondliewski observed that the event organizers checked IDs, provided their own security, and gave out the following tickets to participants: (1) children's or food tickets were blue; (2) drink tickets were orange. Along with food, both Ms. Moss and Ms. Gondliewski served less than 2 ounces of Sullivan's alcohol product to each event participant who presented an orange ticket. Both Ms. Moss and Ms. Gondliewski confirmed that they did not serve any visibly intoxicated persons, in accordance with their TAPS training. Over the two hours that Sullivan's took part in the event, less than 12 cups/3 quarts of the product was served to event participants. When Ms. Moss and Ms. Gondliewski began to pack up at 2:45 pm, they were accosted by Sarah James of the ADN, who informed them that they "were not done yet." Ms. Moss and Ms. Gondliewski informed Ms. James that they were under strict orders from Mr. Erdmann that their serving time was 1:00 – 3:00 pm. Ms. Moss and Ms. Gondliewski left the Dena'ina Center premises by 3:15 pm. Ms. Moss and Ms. Gondliewski both understood that their food and alcohol service was donated to the event. Ms. Moss and Ms. Gondliewski did not receive payment or tips from their two hours of service at the event from either event organizers or participants. They were compensated for their time solely by Sullivan's.

#### What Sullivan's Did to Ensure Compliance with Title IV

As described above, Mr. Erdmann was aware that Sullivan's is the holder of a AS 04.11.090 Beverage Dispensary license, which "authorizes the holder to sell or serve on the licensed premises alcoholic beverages for consumption on the licensed premises only." In compliance with AS 04.11.090, Mr. Erdmann correctly informed the event organizer's agent, Ms. James, that Sullivan's could not serve alcohol at the event. Ms. James informed Mr. Erdmann that the ADN has secured the appropriate permit, and that the Dena'ina Center had its own alcohol license. Sullivan's had taken part in this event the prior year, and Ms. James was a former employee, so there was no reason for Mr. Erdmann to doubt her veracity. Still, Mr. Erdmann did not agree to provide alcohol at the event. It was not until the day of the event, at the insistence of Ms. James, that Sullivan's staff were essentially bullied into providing 2-ounce samples of alcohol product, for free, to event participants with the appropriate ticket. This was done for a limited period of time and Ms. Moss and Ms. Gondliewski did so in compliance with all applicable regulations governing service of alcohol 3 AAC 304.425 (determining age of patron), 3 AAC 304.465 (alcohol server course, TAPS card). Sullivan's understood that all food and drink samples were being donated to the event organizers to assist them in hosting a successful event for the public.

It was not Sullivan's intention to run afoul of Title 4 or 3 AAC 304. Mr. Erdmann was not aware that a charitable arm working with the ADN had secured a Special Events permit, as provided by AS 04.11.240, which requires "all profits derived from the sale of beer or wine [to be] paid to the organization[.]" Sullivan's would have directly donated any permitted alcohol product to the charity prior to service of the product if it had been instructed to do so by the permit holder. Sullivan's took all appropriate steps to ensure its servers were serving in compliance with Alaska law, assuming the presence of the appropriate permit. Still, Sullivan's recognizes that its General Manager and staff would benefit from additional training on the alcohol licensing laws governing a Beverage Dispensary license. Sullivan's therefore commits itself to holding a re-training on this subject at the soonest possible time, to ensure that all staff are kept current of the requirements of the Title 4 or 3 AAC 304.

Sullivan's understands that, as a licensee, it has an independent legal obligation ensure its and its agents' compliance with all alcohol licensing laws in Alaska. Sullivan's understands that it should have undertaken its own due diligence and secured its own Caterer's permit, per AS 04.11.230, if it had any reason to doubt the representations of the event organizer. Sullivan's was attempting to be a charitable and supportive member of the Alaska business community by taking part in this event. Sullivan's sincerely regrets the role it played and assures you it will not happen again.

#### Steps Sullivan's Has Taken to Prevent Re-Occurrence of this Violation

Sullivan's has conducted an internal investigation into this violation and spoken with its management and staff about what occurred, and the applicable laws at issue. Sullivan's has cooperated with Investigator Joe Hamilton and provided names of other licensee participants at the Event. Sullivan's has also contacted AMCO Enforcement, specifically Investigator Hamilton and Criminal Justice Tech Jason Davies, about hosting Investigator Hamilton for a one-day training with Sullivan's all staff, to take place at the end of March. It is Sullivan's intention to have all of its staff properly briefed and trained by AMCO on what led to this violation, so that it will not occur again.




In order to ensure this never happens again we have implemented a new system in place to be signed off by the event coordinator and the general manager. We attached a copy of the new checklist.

It was brought to our attention that your establishment was issued a Notice of Violation for your participation in the Best of Alaska event. We do understand the seriousness of the situation and I apologize for putting your license at risk. We understand that this honest mistake carries massive implications for our vendors. This was in no way our intention and I hope you know that we do understand the severity of the situation and that we are working on processes so that this does *NOT* happen in the future.

Here is what happened, and the plan we have put into motion to prevent this from happening in the future:

ADN obtained a special event permit with our charity partner. When the permit was approved, we filed it and continued planning the event. It wasn't until after the event, that we realized the oversight on our part, that it was a 'beer/wine' only event permit.

After conversations with AMCO we have a better understanding on how this permit works, and which type of permit we need to use for events when serving spirits in addition to beer/wine. We know who to contact for questions and plan on having a meeting with an AMCO representative, our licensee partner with all vendors (either collectively or individually, if needed) prior to the event. In future years, we will share the permit with all vendors, and in the event they need something additional, we can work together to assure everyone is operating within the correct regulations.

On behalf of the Best of Alaska Event and ADN, I would like to apologize that this mistake happened. Please let us know if there is anything that we can do to assist in this process.

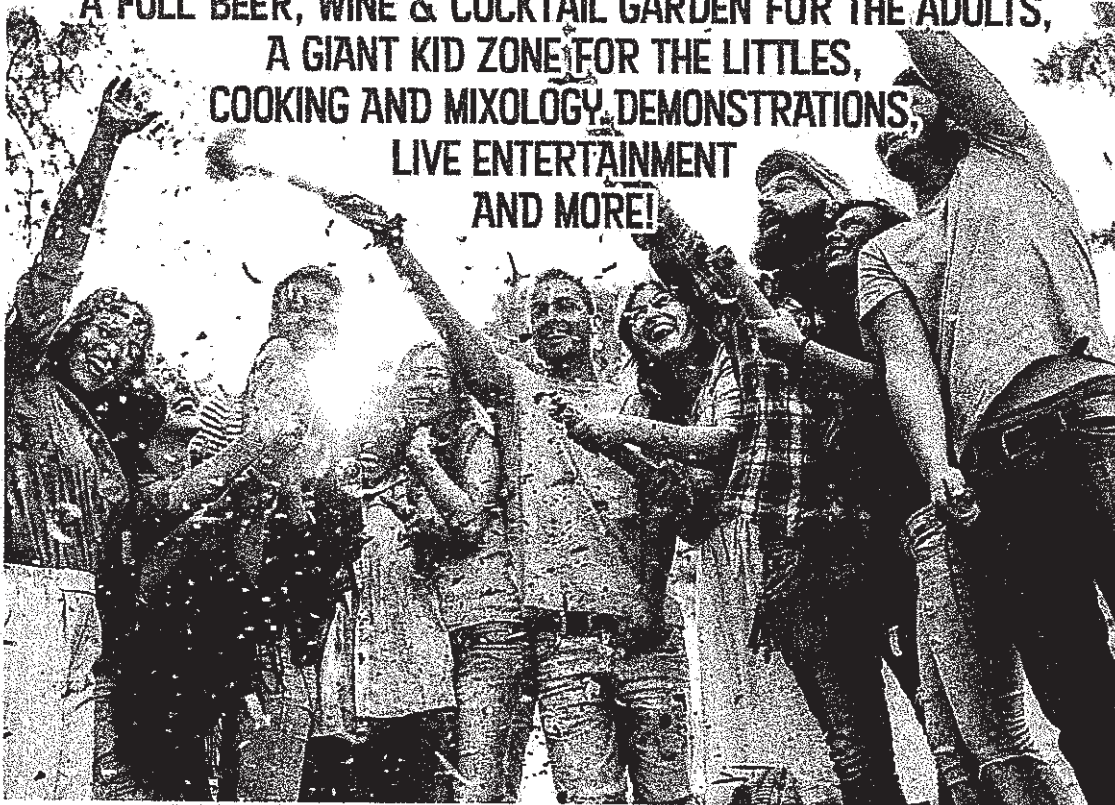

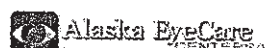



Per my telephone call on 12/5/18 you had asked me to put in writing what we had discussed per our conversation and forward it to you.

On October 1, 2017 Gold Miners Lodge Restaurant and Motel LLC entered into a lease with option to buy agreement with John & Inthira Zavacky. You had asked if we had a "Manager's Agreement" with the Zavacky's. Mr. & Mrs. Zavacky do not have a financial business interest in Goldminers Lodge Restaurant and Motel but only the property and will be starting their own business under a different business name and License or LLC. Mr. & Mrs. Zavacky have been performing a major renovation of the restaurant and motel buildings. In our original agreement with Mr. & Mrs. Zavacky we were not intending to apply for a waiver. They originally planned to be able to open in 2018 after applying to transfer the liquor licenses into their new business name prior to opening a new restaurant/bar & motel. It has taken them much longer on the renovation and they have not opened yet! Since speaking with Mr. & Mrs. Zavacky the first week in November 2018 they agreed the waiver option would be necessary according to the handbook and assured us that they would turn in their necessary paperwork and applications to transfer and renew the liquor licenses into their new business name before the deadline date of December 31, 2018.

Prior to moving out of Alaska on October 1, 2017 Brian and I were communicating with Sarah Oates via telephone and email in the month of September 2017. I had come into the AMCO Anchorage Office at least 4 times prior to leaving because we were not having our calls returned. I repeatedly communicated with Sarah at the office regarding the process of the transferring of the liquor licenses and before leaving we turned in our necessary paperwork with her.

Two months later on December 22, 2017, I received an email from Jacqlene Drulis. The letter dated December 22, 2017 stated "At this time, your application is considered incomplete for the following

reason: AB-01 Transfer License Application - We have not received the remainder of the Transfer Application Forms." Jacqlene Drulis had returned our transfer license paperwork that we had turned in prior to leaving Alaska. I called Jacqlene Drulis and talked with her to get accurate instructions on how to proceed. She suggested that we send our completed paperwork to Mr. & Mrs. Zavacky so that when they turned in their applications they would have everything AMCO needed. On 1/30/18 I sent them our necessary completed portion of paperwork for the transfer applications.

On November 5, 2018, I began to inquire via an email to AMCO regarding the waiver application process. I received a response email from Carrie Craig on November 6, 2018. I sent another email to Carrie on November 13, 2018 asking her a few more questions regarding the transfer and renewal applications, and asked her if she would email us when John Zavacky turned in his applications as it is sometimes hard to get ahold of him. I also asked if she would please let me know if someone else was taking care of his application if she would let me know their name and email address since the deadline was drawing near. I received a response email from Carrie November 13, 2018. I sent another email to Carrie on November 14, 2018 asking her a question regarding the Notary Public. I did not get a response email from Carrie so I called AMCO and she was the one who answered the phone so I was able to get my answer with that phone call.

I mailed the waivers for License #4526 Beverage Dispensary - Tourism and License # 4380 - Restaurant or Eating Place to AMCO and the City of Houston on November 14, 2018 via certified mail with return receipt. The signed return receipts received by AMCO and the City of Houston states the waivers were received on November 19, 2018 and the checks were cashed on November 20, 2018 per my bank account.

I believe this latest misunderstanding stems from a phone call I made on October 11, 2018, I called AMCO asking to talk to with Jacqlene Drulis and talked to a Mr. Campbell as he asked if he help. I explained some details regarding our lease with option to buy agreement and asked if Mr. & Mrs. Zavacky's transfer application was turned in. He checked and said that "no transfer application had been turned in." I also told him that Mr. Zavacky was in the process of a major renovation. I had some questions regarding applying for a waiver for the first time. He explained the fees and to also send a copy of the waivers to the Local governing body the City of Houston AK.

Soon after that phone call on October 11, 2018 on November 29, 2018, we received an email from Jason Davies to our [goldminerslodgealaska@gmail.com](mailto:goldminerslodgealaska@gmail.com) showing a Notice of Violation for failure to communicate. That next evening Brian called to find out what the Notice of Violation was pertaining to and talked to John Hamilton. The next day we received another email from Jason Davies again on November 30, 2018 stating he had talked with Mr. Hamilton and found his original letter was never received in the mail because it was sent to our physical address and not our mailing address and apparently was not sent as certified mail. That is what prompted my call to you on December 5, 2018.

We have continually been trying to comply with all AMCO requirements and as you can see with all the above communication, I have been in contact with AMCO before and after we moved from Alaska in 2017 extensively. With regards to the violations listed in the Notice of Violation letter sent via email we believe there was a misunderstanding. John & Inthira Zavacky have never used or been

offered temporarily to use our liquor licenses and they have not yet even opened their new business. Mr. Zavacky has been trying to complete a major renovation of the restaurant and motel and have assured us they will not open until all required applications are granted by and through the AMCO authorization.

We received the attached Notice of Violation (the "**Notice**") this Monday, March 25, 2019, via certified mail, and this letter is our required response to the Notice.

In order to prevent the reoccurrence of any violation like the violation referenced in the Notice, we have taken the following actions:

1. We have put a new sign on the door that exits out to the partially enclosed smoking area (please see attached photo). Please also note that we had similar signage on that door from the beginning of our operating this location. However, we had a series of ongoing renovations at this location (now virtually complete) and our best guess is that prior signs may have gotten damaged (there were some roof leaks and water penetration) and at some point either the old sign or a new sign did not get put back up. The new sign in the photo is a sticker that is very hard to remove and we're having another one made that will be a vinyl sticker that will be impervious to water damage and will be next to impossible to remove.

2. We have retrained all staff to make sure that they enforce what the new sign says and that they do everything in their power to prevent anyone from taking any alcoholic beverages out into the partially enclosed smoking area. Staff has also been instructed that if anything happens to the sign, they are to replace it right away with a new sign.

Please note that we are also open to taking any other actions you might recommend as we consider this to be a very important matter.
