Transfer of location

Action:

Statutory AS 04.06.090(b): "The board shall review all applications for licenses made under **Authority:** 

this title and may order the director to issue, renew, revoke, transfer, or suspend

licenses and permits authorized under this title."

**Background:** This package store license is being transferred to a new location in an area with no local government (Tok).

At issue is the interpretation of AS 04.11.460, Prior Public Approval, which states:

- (a) A new license or the transfer of location of an existing license may not be approved by the board in an area outside but within 50 miles of the boundaries of a municipality unless a petition asking that the license be issued or transferred within the area containing signatures of a majority of the permanent residents residing within one mile of the proposed premises is filed with the board.
- (b) A license may not be issued in an area that is 50 miles or more from the boundaries of a municipality unless a petition asking that the license be issued within the area containing the signatures of two-thirds of the permanent residents residing within a radius of five miles of the United States post office station nearest to the proposed licensed premises, is filed with the board. If there are two or more United States post office stations in the vicinity of the proposed licensed premises, the nearest to the premises constitutes the point of beginning under this subsection. If there is no United States post office station within a radius of five miles of the proposed licensed premises, the applicant must obtain the signatures of twothirds of the permanent residents residing within a five mile radius of the proposed licensed premises. A petition is not required for the renewal of a license issued in accordance with this subsection unless specifically required by the board.
- (c) In this section, "permanent resident" means a person 21 years of age or older who has established a permanent place of abode.

Should the transfer application for this license include a petition as indicated in subsection (b)? (The proposed new location of the license is not within 50 miles of the boundaries of a municipality, so subsection (a) does not apply.)

While subsection (a) very clearly applies to "a new license or the transfer of location of an existing license," subsection (b) does not provide that clarity. This license was first issued at the location from which it is transferring in 1956—I do not know if there was a petition requirement at that time.

Because the language at the beginning of subsection (b) states "a license may not be issued," but the language in the last sentence of the subsection exempts the renewal of a license from needing a petition (except when required by the board), the implication is that <u>all</u> issuances of a license, except for a renewal, would require a petition. However, that interpretation would include transfers of ownership, which makes less sense than just new licenses and transfers of location.

In a spot check of licenses that are in locations with no local government, many transfers of ownership were noted, not one of which included a petition. One license was identified that had transferred location twice: records from a transfer in 1999 include a petition and records from a transfer in 2009 do not include a petition.

If the board determines this section to require a petition for this transfer of location, I recommend the board approve the transfer with delegation, and that the submittal of a qualifying petition be part of the delegation.
