Requested New license application **Action:**

Statutory AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.480(a): "A local governing body may protest the issuance, renewal, relocation, or transfer to another person of a license by sending the board and the applicant a protest and the reasons for the protest within 60 days of receipt from the board of notice of filing of the application... The board shall consider a protest and testimony received at a hearing conducted under AS 04.11.510(b)(2) or (4) when it considers the application... If an application or continued operation is protested, the board shall deny the application or continued operation is the board finds that the protest is arbitrary, capricious, and unreasonable."

AS 04.11.510(b)(2): "The board may review an application for the issuance, renewal, transfer of location, or transfer to another person of a license without affording the applicant notice or hearing, except...(2) the board may, on its own initiative or in response to an objection or protest, hold a hearing to ascertain the reaction of the public or a local governing body to an application if a hearing is not required under this subsection;"

Staff Rec.: Hold a public hearing; rescind previous approval and deny the application with a 30 day abeyance

Background: At the last meeting, the board approved this restaurant or eating place license with delegation. After the meeting, staff received a timely protest from the Matanuska Susitna Borough due to fees owed.

The licensee should be notified that under 3 AAC 304.145(h), this abeyance period may not be extended or renewed.



Rebels Roost Lodge Security Plan

Rebels Roost Lodge is a small business, as such the security plan is very basic.

All on site non-chilled alcohol inventory with be stored in staff area in a locked storage cabinet. Chilled alcohol inventory will be stored in the kitchen area in a designated beverage cooler under constant supervision during business hours.

During business hours anyone ordering alcohol will be asked for government issued identification. Any attempt from minor patrons attempting to violate this law will have their identification confiscated and the attempt will immediately be reported to the Alaska State Troopers.

All on site consumption will be delivered to patrons chosen seating assignment, to be consumed inside Rebels Roost Lodge.

When Rebels Roost Lodge is closed a "Closed" sign(s) will be clearly displayed, all entrances will be securely locked.

In case of any emergency, staff will respond appropriately and contact MAT COMM Dispatch located in Wasilla Alaska and will convey and follow Emergency personnel instructions.
