Requested Action: New license application

Statutory Authority: AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.400(d): "The board may approve

(1) the issuance of a new beverage dispensary or restaurant or eating place license without regard to (a) of this section if it appears that the issuance will encourage the tourist trade by encouraging the construction or improvement of

(A) a hotel, motel, resort, or similar business relating to the tourist trade with a dining facility or having kitchen facilities in a majority of its rental rooms and at least a minimum number of rental rooms required according to the population of the incorporated city, unified municipality, or population area established under (a) of this section in which the facility will be located, as follows:

- (i) 10 rental rooms if the population is less than 1,501;
- (ii) 20 rental rooms if the population is 1,501 — 2,500;
- (iii) 25 rental rooms if the population is 2,501 — 5,000;
- (iv) 30 rental rooms if the population is 5,001 — 15,000;
- (v) 35 rental rooms if the population is 15,001 — 25,000;
- (vi) 40 rental rooms if the population is 25,001 — 50,000; and
- (vii) 50 rental rooms if the population is greater than 50,000; or

(B) an airport terminal; and"

Staff Rec.: Approve the new license, with local government approval required before alcohol is served on the outdoor patio/deck

Background: This is an application for a new beverage dispensary – tourism license in the Municipality of Anchorage.

AS 04.11.400(d)(1)(A) requires 50 rental rooms if the population is greater than 50,000. The Municipality of Anchorage has a certified population of 294,205.

The applicant offers 150 rental rooms, none of which include kitchenettes. Alcohol is not stocked in the rental rooms, and the establishment has a full-service restaurant.

A temporary license was issued. A last minute adjustment to the licensed premises diagram following the inspection has led to the need for additional local government approval before the outdoor patio/deck may be used as licensed premises. Temporary approval for the outdoor area was rescinded.

1. Explain how the issuance of a liquor license at your establishment has/will encourage tourism.

The central focus of the business plan for the Hyatt Place Anchorage involves catering to out of town tourists, local, and regional guests. The licensees will continue to run advertising in travel/tourism publications and directories as well as through electronic methods, including an online presence via property specific website and other relevant platforms.

Explain how the facility was/will be constructed or improved in accordance with this application.

This facility is located at 101 E. Tudor Road, Anchorage. As such it is ideal for travelers who want a comfortable overnight stay in a clean, comfortable, location conveniently located in midtown Anchorage.

2. Who operates the facility for which a liquor license is being applied?

Cameron Gunter, and Michael Bingham are the managers and members of Midtown Hotel Investors, LLC along with additional members of Blue Anchorage Group, LLC, Bingham Family Alaska, LLC, and CEBFA Storage 1, LLC and they all operate the business.

3. Do you offer room rentals to the traveling public? Yes.

4. If so, how many of these rooms are available? Do any of the rental rooms have kitchen facilities (defined as: a separate sink for food preparation along with refrigeration and cooking appliance devices, including a microwave)? If yes, how many of the rental rooms have kitchen facilities that meet this definition? Do you stock alcoholic beverages in guest rooms?

There are 150 rooms for rent at the Hyatt Place Anchorage. None of the rooms are equipped with kitchen facilities. No, we do not stock alcoholic beverages in the rooms.

5. Does your establishment include a dining facility?

Yes. The Hyatt Place Anchorage offers a light menu for breakfast, lunch, dinner, and snacks daily in a comfortable setting.

6. Are additional amenities available to your guests through your establishment (eg: guided tours or trips, rental equipment for guests, other activities that attract tourists)?

Yes, Hyatt Place Anchorage does provide tourist type amenities to its guests. We recommend other tours, and have a list on our website of close by tours, trips, and rentals, for our guests. The Hyatt Place Anchorage will continue to operate the facility as a tourist facility. We also hope to partner with local vendors to sell their goods out of the check-in area of the hotel.

In short, all of those things, which are routinely done by businesses in Alaska to encourage tourism, will continue to be done by the operators of the facility.

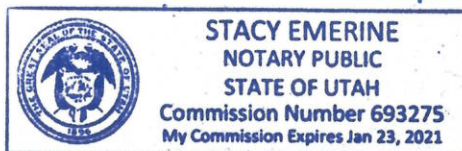

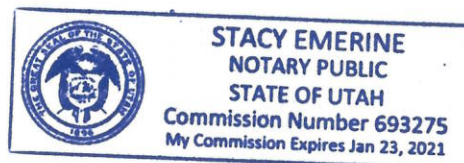
