Requested Transfer of controlling interest **Action:**

Statutory AS 04.11.040(c): "A person may not receive or transfer controlling interest in a liquor Authority: license issued to a partnership, including a limited partnership, a limited liability organization, or a corporation under this title, except with the written consent of the board."

AS 04.11.480(a): "A local governing body may protest the issuance, renewal, relocation, or transfer to another person of a license by sending the board and the applicant a protest and the reasons for the protest within 60 days of receipt from the board of notice of filing of the application... The board shall consider a protest and testimony received at a hearing conducted under AS 04.11.510(b)(2) or (4) when it considers the application... If an application or continued operation is protested, the board shall deny the application or continued operation unless the board finds that the protest is arbitrary, capricious, and unreasonable."

AS 04.11.510(b)(2): "The board may review an application for the issuance, renewal, transfer of location, or transfer to another person of a license without affording the applicant notice or hearing, except...(2) the board may, on its own initiative or in response to an objection or protest, hold a hearing to ascertain the reaction of the public or a local governing body to an application if a hearing is not required under this subsection;"

Staff Rec.: Hold a public hearing; deny the application with a 180 day abeyance

Background: The Municipality of Anchorage protests the transfer of this beverage dispensary - tourism license pending payment of delinquent taxes in the amount of \$2,773.73, and pending certification from the Fire Department and the Department of Health and Human Services.

The licensee should be notified that under 3 AAC 304.145(h), this abeyance period may not be extended or renewed.

AS 04.11.400(d)(2)(A)(ii) requires that the facility must maintain at least the minimum number of

rental rooms required at original licensure. This license was first issued in 1964. Staff has determined that the license was compliant with the room number requirements when originally issued in 1964.

The applicant offers 90 rental rooms, none of which includes a kitchenette. Alcohol is not stocked in the rental rooms, and the establishment has a full-service restaurant.

TOURISM STATEMENT IN SUPPORT OF TRANSFER OF OWNERSHIP INTEREST IN THE NORTHERN LODGING, LLC, DBA SLIPPERY SALMON BAR & GRILL LICENSE NO. 1036

This Tourism Statement is submitted pursuant to 13 AAC 104.325, and in support of Northern Lodging, LLC's Liquor License Transfer Application due to a Change in Control. Kress Properties, Inc. has recently acquired 100% of the membership interest in Northern Lodging, LLC.

The Slippery Salmon Bar & Grill (the "Grill") is located within the Ramada hotel in downtown Anchorage, just above Ship Creek. The Ramada is owned by Northern Lodging, LLC, and is operated by its sole member, Kress Properties, Inc., through its authorized officer, Scott Chun, as president, and an onsite general manager and staff.

The current owner has been operating the license since 2006. The Grill is well known by tourists and locals alike, and both the Ramada and the Grill offer an affordable option for tourists wanting to visit the state. The convenience of an onsite restaurant and bar enhances the experience for tourists. The Grill has been substantially upgraded over the last several years.

The Ramada is a 90 room - two star facility. AS 04.11.400(d), provides for the issuance of a tourism license to a facility offering a minimum room count of 50 within the Municipality of Anchorage. None of the rooms have kitchen facilities and no liquor is stocked in the rooms. All dining and alcohol service is provided through the Grill.







SECURITY PLAN FOR DECK AT SLIPPERY SALMON BAR & GRILL, LICENSE #1036

Primary access to the deck at the Slippery Salmon Bar & Grill is through the restaurant where all guests are monitored. Staff also monitors it via frequent service appearances and a viewing window located adjacent to the deck. The deck is elevated to approximately 30 inches above ground with 40 inch walls on all sides. Secondary access could be obtained through the exit only stairwell, though it is easily visible from the viewing window. Proper signage required by AS 04.21.065 is in place on the door to the deck and by the exit only stairwell, as well as any other required signage, and frequent staff appearances ensure that no unaccompanied minors are allowed on the deck.
