FROM: Erika McConnell, Director RE: 4109 Fu Do Restaurant

Requested Action: Reinstatement; renewal; 1st, 2nd, and 3rd waivers of operation; transfer of controlling interest and location

Statutory and Regulatory Authority: AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.540: "Notwithstanding AS 04.11.680, an application for renewal of a license issued for the two calendar years ending December 31 or of a seasonal license issued for parts of those calendar years may be submitted up until the next February 28. If a complete application for renewal has not been filed by February 28 or the required fees and the penalty fees have not been paid by that date, the license expires at 12:00 midnight February 28. A new license may not be issued to the holder of an expired license for the same premises except on proof satisfactory to the board of good cause for the failure to file and pay."

3 AAC 304.160(e): "For the purposes of AS 04.11.540, if a license has expired for failure to file a complete application for renewal by February 28 or for failure to pay the required fees and penalty fees by that date, the board will consider a written request to reinstate the license if the request is accompanied by

- (1) a complete application;
- (2) a reinstatement fee of \$1,000;
- (3) all other required fees and penalty fees; and
- (4) proof of good cause for the failure to file and pay by February 28."

3 AAC 304.160(f): "The board will deny a request for reinstatement submitted under (e) of this section if

- (1) the license became available in accordance with 3 AAC 304.100(2) and was issued to a different applicant, unless the limit of licenses under AS 04.11.400 has not been reached; or
- (2) the board finds that the failure to timely file or pay was caused by
 - (A) the licensee's failure to notify the board of a change of the licensee's mailing address;
 - (B) a transfer of ownership of the business for which the license was issued without written approval of the board in violation of AS 04.11.040;

(C) a lease of the licensed business to another person in violation of AS 04.11.450(c); or

(D) any other action of the licensee whether active or tacit that the board finds constitutes a failure to lawfully operate the business for which the license was issued.”

3 AAC 304.170(b): “A licensee may apply to the board, requesting that the board waive the operating requirement of AS 04.11.330 (a)(3) or (d). Under AS 04.11.330(a)(3), the board will determine whether, through no fault of the licensee or because the premises are under construction, the licensed premises could not be operated for the required time during the preceding calendar year.”

AS 04.11.040(b): “A license or permit issued under this title may not be transferred to a new location except with the written consent of the board.”

AS 04.11.040(c): “A person may not receive or transfer controlling interest in a liquor license issued to a partnership, including a limited partnership, a limited liability organization, or a corporation under this title, except with the written consent of the board.”

Staff Rec.: Deny reinstatement and renewal as applicant does not have right to licensed premises

Background: License #4109 for Fu Do Restaurant, a beverage dispensary license in Anchorage held by Mong Chen, Inc., did not submit a renewal application for the 2019/2020 licensing period. The expiration warning letter required by AS 04.11.550 was mailed to the address on file on February 8, 2019. A notice of license expiration was mailed to the same address on March 18, 2019.

AMCO was first alerted to the potential for a reinstatement request for this license in early August. On August 22, 2019, we received information that Dana Yu Shiang Ma, sole owner of Mong Chen, Inc., died on March 1, 2017, and that the license was not operated in 2017 or 2018. The personal representatives of Ms. Ma’s estate, her two children, are seeking to reinstate the license in order to sell it. In addition they have filed for renewal for 2019/2020, for waivers of operation for the 2017, 2018, and 2019 operating years, a transfer of controlling interest of Mong Chen, Inc., from Ms. Ma to themselves (Edward Hsu and Stephanie Hsu), and a transfer of location to No Premises.

At issue is the fact that the premises that was previously licensed, at 2600 E. Tudor Road, is no longer under the control of the entity that held the license (Mong Chen, Inc.) or the personal representatives of Ms. Ma. The property at 2600 E. Tudor Road was formerly owned by Ms. Ma and her husband and was leased to Mong Chen Inc. Now the property is owned by 2600 LLC and is leased to Great Northern Retail Stores, Inc. which is opening a marijuana retail store at the premises. The marijuana retail store has received approval with delegation from the Marijuana Control Board.

AS 04.11.260(a)(2) requires that an application must include “a description of the premises for which the license or permit is desired, giving the address by street and number, or other information, so that the location of the premises can be definitely determined.” 3 AAC 304.105(b) states, “An application for a new license or for renewal, relocation, or transfer of an existing license, must contain the information required by AS 04.11.260 - 04.11.290. In addition, as appropriate, the application must contain the following:...(6) copies of deeds, lease agreements, or other documents

that show right or title to, or interest in, land and buildings at the location of the business to be licensed.” Even though the applicants intend to transfer the license to No Premises immediately after reinstatement and renewal, how can the license be reinstated and renewed even for a brief period, when the applicants don’t have a right to the location of the license?

Certainly the circumstances are unfortunate, but AS 04.11.660 states that a “license issued under this title is a personal privilege, not a property right.” It is clear that liquor licenses are not meant to be commodities, but to be operated for the benefit of the public. To reinstate a license at a location that is no longer possible to be a licensed premises, in order for the license to be sold as a commodity, goes against the intent of Title 4. Additionally, this would set a precedent that a licensee who lost right or title to, or interest in their premises and allowed their license to expire, could reinstate the license essentially at a different location, which again, does not appear to be consistent with the intent and structure of Title 4 and 3 AAC 304. How is reinstatement at a different location functionally different from an application for a new license?

INTRODUCTION:

Coffey Consulting represents Mong-Chen, Incorporated, an Alaskan Corporation, which is the owner of an expired beverage dispensary liquor license, # 4109.

Ms. Ma died on March 1, 2017. Prior to her death, she was the sole shareholder of Mong-Chen. (Certificate of Death attached).

Our clients are Ms. Ma's two children, Eddie and Stephanie Hsu. They are asking the Board to reinstate and renew the beverage dispensary liquor license and grant three (3) operating waivers (2017, 2018 & 2019).

All of the required forms and related documents were filed with the staff of the ABC Board prior to the October 25th deadline for the Board meeting on November 12, 2019.

All of the fees associated with these three (3) requests, the sum of FOURTEEN THOUSAND, SIX HUNDRED FORTY-SIX DOLLARS & 50 Cents (\$14,646.50) were paid current with the filing of the required forms and related documents for reinstatement, renewal and waivers.

FACTS:

Ms. Ma's children were not involved in any way, shape or form in their mother's business. At the time of Ms. Ma's death, they were totally unaware of the requirements of the statutes and regulations of the ABC Board.

Ms. Ma's husband, Thomas Hsu, suffered a stroke prior the Ms. Ma's death. As a result, he lost his ability to speak English (Korean is his native language) and suffers other stroke related disabilities. As a result of his stroke and the resulting physical and mental disabilities, Mr. Hsu was not involved in Ms. Ma's business

nor is he actively involved in Ms. Ma's probate case. That role falls on Stephanie and Eddie Hsu.

The Law Firm of Foley, Foley & Person, provides legal services for its clients that are limited to estate planning and probate. The Foley Law Firm does not have any experience in or knowledge of ABC Board matters. The Firm was totally unaware of AS 04.11.030 "Death of Licensee" and the 90-day "forfeiture" provision in subsection (b) of that statute. (See attached copy of AS 04.11.030).

As a result of the foregoing circumstances, when Letters of Administration were issued by the Probate Dated on March 13, 2017, Ms. Ma's two children were appointed Co-Personal Representatives of the estate. (See attached Letters of Administration). At the time of their appointment both Edward and Stephanie were in their twenties and totally unfamiliar with their Mother's numerous businesses.

Prior to Dana Ma's death, the liquor license was renewed for 2017-2018, but did not operate in either of those two years due to Ms. Ma's death in March of 2017. That is the reason for the first 2 requested waivers.

On February 8, 2019, the staff of the ABC Board sent a notice to 2440 East Tudor Road #1116, Anchorage, Alaska 99507, advising Mong Chen that its "LIQUOR LICENSE EXPIRES FEBRUARY 28, 2019" (See attached letter).

Subsequently, on March 18, 2019 the staff of the ABC Board sent a second notice to Mong Chen, Inc. at 2440 East Tudor Road #1116, Anchorage, Alaska 99507 advising Mong Chen that "YOUR LIQUOR LICENSE HAS EXPIRED" (see attached letter).

Neither letter was seen by either Stephanie or Eddie. Copies were subsequently obtained from the staff of the ABC Board after the Law Firm was retained by Stephanie and Eddie.

Our Law firm was first contacted by the Eddie and Stephanie in late March, 2019. The Firm immediately began the process of fact gathering so as to reinstate and renew the Beverage Dispensary License and obtain the necessary operating waivers.

THE FORFEITURE STATUTE: AS 04.11.030:

It is hard to imagine a State Statute that is a bigger "trap for the unwary" than this section of the Alaska law. This is particularly true in circumstances when the Licensee/Corporate shareholder, is "a sole licensee".

Envision two young people whose mother, the sole shareholder of Mong Chen, has just died, and whose father who is disabled. None of these individuals knew anything about the statutory and regulatory requirements of the ABC Board.

To preserve a license in these circumstances, all appointed “executors or administrators of the estate...” are required to seek an extension of time from the ABC Board as provided in subsection (c) of this statute within 90 days of the death of a sole licensee. Failure to file an application for transfer or to request the Board to grant an extension of time result in forfeiture of the license. (see AS 04.11.030 (b)).

In late March, 2017, the heirs had just hired legal counsel and were in the process of being appointed the Co-Personal representatives of their deceased mother’s estate. Having no knowledge of the forfeiture provisions, no request for an extension was requested of the Board.

NOTICE OF FAILURE TO RENEW:

In addition to the forfeiture issue, there is a renewal issue for the years 2019-2020.

The Board’s staff sent two notices to Mong Chen in February and March 2019.

The first notice, dated February 8, 2019, advised that the “liquor license will expire at midnight February 28, 2019.

The second notice, dated March 18, 2019 stated that “Your liquor license has expired”.

The notices were sent to the licensed premises at the address on record with the ABC Board (2440 E Tudor #1116, Anchorage which was the location at which Mong Chen operated the licensed business.

Stephanie and Eddie did not know that these notices had been sent and only discovered their existence of these notices in late March when, for the first time, they contacted the ABC Board only to learn that the license was both “forfeited” and had “expired”. (See the two notice letters and the provisions of AS 04.11.030)

AFFIDAVIT OF ATTORNEY RICHARD FOLEY

Added to the problems that these young heirs faced, the Board should also consider the difficulties outlined in the affidavit of Richard Foley, the attorney representing the estate. (Copy Attached)

Without repeating what attorney Foley states in his affidavit, the Board should understand that Ms. Ma was, at the time of her death, involved in multiple business deals, real estate investments and related and unrelated business transactions. The initial focus of the Law Firm was to gather information necessary to secure the appoint of the personal representatives and to gather information as to the assets of the Estate. Little did they know that the license has been forfeited.

RELATED FILING AND PROCESS ISSUES:

There are several inter-related licensing issues with regard to this license that need to be addressed at the Board's meeting in November in order to enable the Board to make a decision on the requested reinstatement, the renewal for 2019-2020 and the 3 requested operating waivers.

These issues have been identified and are set out below:

1) Waivers of the 2017, 2018 and 2019 Operating Requirements.

Waiver applications have been prepared and are filed with staff ~~(see attached)~~

2) Renewal of the liquor license for 2019-2020.

A renewal application for 2019-2020 has been prepared and filed with staff. ~~(see attached)~~

3) Reinstatement of the Corporation.

The Corporation is in the process of being reinstated. (see attached).

4) Transfer of Ownership.

Because of the death of Ms. Ma, the license should be transferred to her heirs who are the Co-Personal Representatives. An application to transfer ownership of Mong-Chen, Incorporated to the two Co-Personal representatives has been prepared and filed with the State of Alaska ~~(see attached)~~.

5) Required Fees.

The fees required by the ABC Board for these issues **(\$14,646.50)** have been paid (~~see attached copy of the Check~~).

6) A Contingent Contract of Purchase and Sale

A Contract for the sale of the Beverage Dispensary has been prepared and signed by the Buyer. Once the ABC Board approves the reinstatement, renewal and waivers that are being requested we will proceed with a transfer of ownership and location for this license which will operate in 2020. (See attached Contract).

CONCLUSION:

The two (2) heirs of Ms. Ma are asking that the very valuable liquor license be reinstated and renewed and that operating waivers be granted so that they can sell the license and move on with their lives. Every issue related to reinstatement, renewal and waivers has been addressed. All fees and all costs due the Board have been paid.

Thank you for your consideration of these requests.

AFFIDAVIT OF RICHARD H. FOLEY, JR.

I, Richard H. Foley, Jr. being first duly sworn, depose and say as follows:

- 1) I am an attorney with the law firm of Foley, Foley & Pearson, P.C. and I am licensed to practice law in the State of Alaska.
- 2) Our legal practice is limited to estate and business planning, probate and trust administration. We do not provide legal services outside of these areas. We have never practiced before the alcohol and marijuana control board and consider such legal work to be highly specialized.
- 3) Foley, Foley & Pearson, P.C. represents the Estate of Dana Yu Shiang Ma (Dana Ma) who died on March 1, 2017. Mrs. Ma was survived by her husband, Thomas Tao Cheng Hsu, and her two children, Eddie Hsu and Stephanie Hsu. Thomas Hsu is the sole beneficiary of the estate.
- 4) Eddie Hsu and Stephanie Hsu were appointed as Co-Personal Representatives of the Estate because Thomas Hsu had previously suffered a stroke and did not have a proficient command of the English language.
- 5) The initial legal work on the estate, including Appointment of Representatives, Letters of Administration, Notice to Creditors, and Notice to Heirs was commenced and accomplished by the end of March 2017.
- 6) Notice to creditors was first published on March 26, 2017. By law, creditors have four (4) months to file claims from the date of publication. Other than the statutory \$55,000 statutory allowances to the spouse, creditors and the IRS have a priority to be paid from estate assets. Our practice is to avoid the transfer of any assets until after the creditor claim period runs and after the IRS has accepted the estate tax return.
- 7) At the time of her death, Mrs. Ma was involved in multiple business deals, real estate investments and related transactions. It was a very complex and leveraged estate with substantial debt. There were potential federal estate tax issues, and we determined that an estate tax return should be filed.
- 8) Mrs. Ma did not share the management duties or knowledge of her financial dealings with other family members. Given the way in which Mrs. Ma ran her numerous and often complex businesses, the Personal Representatives had a very difficult time obtaining a clear inventory of the assets of the estate. We spent a substantial amount of time locating and valuing assets, evaluating debts and creditor claims, and trying to figure out the cash necessary to service debt. Cash flow was a problem from the outset and it

was clear that it would be necessary to liquidate real estate. It was a challenge to liquidate the real estate in an orderly fashion and to protect equity and value to the greatest extent possible.

- 9) Due to the complexity of the estate and ignorance of family members regarding the financial dealings of the decedent, we obtained an extension of time to file the estate tax return which was eventually filed 15 months after the date of death.
- 10) Typically, Personal Representatives are required to take over the business operations of the decedent. This is a challenge for any Personal Representative who has their own job and family. It was a particular challenge for Eddie and Stephanie, who are young and inexperienced in matters of business and finance and were never educated by their mother about her financial operations. Eddie and Stephanie did their best to take over the many business dealings and ongoing real estate transactions necessary to keep the estate afloat.
- 11) As a firm, we relied upon Eddie and Stephanie to work with realtors to negotiate sales of business and real estate assets, service existing debts, pay for the expenses of administration, and protect estate assets. We expected them to alert us to any problems that might arise as property was inventoried, valued, protected and liquidated
- 12) Our firm does not practice in the area of liquor control. We were unaware of A.S. 04.11.030 and the requirements to transfer a liquor license within 90 days of the date of death. Since we were focused on the IRS and creditors, we were not planning to transfer assets of the estate early in the administration. Our understanding is the IRS and creditors have a lien on estate assets and a Personal Representative may not transfer assets until all valid creditor claims are resolved.
- 13) Our firm first learned of the problems with regard to the expiration of the liquor license and the dissolution of Mong Chen in April 2019. When Eddie Hsu went to the ABC Board to renew the liquor license in late March or early April, 2019, he learned that the license had expired. Eddie contacted me and I assisted him in engaging attorney Dan Coffey to assist them in the reinstatement of the license.
