Statutory Authority:

AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend

licenses and permits authorized under this title."

AS 04.11.225(c): "In this section, "outdoor recreation lodge" means a licensed business that provides overnight accommodations and meals, is primarily involved in offering opportunities for persons to engage in outdoor recreation activities, and

has a minimum of two guest rooms."

**Staff Rec.:** Approve the new license application

**Background:** This is a new license application for an Outdoor Recreation Lodge license in the Fairbanks North Star Borough. The applicant proposes to offer Aurora Viewing, ATV Tours, Dog Kart, Dog Mushing, Snowmobiling, Outdoor Photography, and Sightseeing. They have 15 rooms available for rent and provide meals to their overnight guests.
