#### **Background:**

This is an application to transfer the ownership of a Beverage Dispensary – Tourism license in the City of Nome. This license was first issued on October 27, 2014.

AS 04.11.400(d)(2)(A)(ii) requires that the facility must maintain at least the minimum number of rental rooms required at original licensure. Staff has determined that the license was compliant with the room number requirements when originally issued in 2014.

The applicant offers 47 rental rooms, none of which includes a kitchenette. Alcohol is not stocked in the rental rooms, and the establishment has a full-service restaurant.

## Tourism Statement per AS 04.11.400 )d) for Transfer of Tourism Beverage Dispensary License # 5334 for Nome Nugget Inn

The Nome Nugget Inn is a historic Nome hotel with 47 rooms. It is the oldest hotel in Nome. The hotel sits across from the finish line of the world famous annual Iditarod Sled dog race. The hotel is the official hotel of the Iditarod staff and volunteers when they are in town and provides accommodations for numerous tourists that come to Nome to experience the end of the Iditarod and the week long festivities that surround the finish of the race.

Nome has a very active birding season with tourists from around the world coming to Nome for "birding." Many of the "birding" tourists stay in the Nugget Inn when in town and while traveling the area outside of the City of Nome.

The small bar located on the first floor of the hotel is operated by the owners of the hotel and is a well-known and used meeting place for tourists and locals alike. The bar is next door to a restaurant owed by the same owners and has food from the restaurant available in the bar.

The hotel assists its guests with arranging tours with local tour groups, rental car facilities, birding trips, as well as putting them in contact with the local visitors center.




