AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.540: "Notwithstanding AS 04.11.680, an application for renewal of a license issued for the two calendar years ending December 31 or of a seasonal license issued for parts of those calendar years may be submitted up until the next February 28. If a complete application for renewal has not been filed by February 28 or the required fees and the penalty fees have not been paid by that date, the license expires at 12:00 midnight February 28. A new license may not be issued to the holder of an expired license for the same premises except on proof satisfactory to the board of good cause for the failure to file and pay."

Staff Rec.: Expire the license.

Background:

This restaurant or eating place license in the Municipality of Anchorage is held solely by Rong Jia Chen as a sole proprietor. This license will expire naturally February 28, 2020 and AMCO has not received a completed renewal application to date.

On May 16, 2019, AMCO staff discovered that the Rice Bowl was no longer operating and lost right, title and interest in the premises. Immediately staff sent a written notice to the licensee requesting that the licensee is surrendered and provides additional options for the licensee to resolve the matter. The licensee was given a 30-day deadline to contact our office.

On November 27, 2019 AMCO staff sent an additional written notice stating that the office had not received a response. This notice was returned by the postal service, labeled as "unclaimed, unable to forward" on December 12, 2019.
