Main Street Hotel Tap & Grill has 31 rental rooms all of which are equipped with a refrigerator, microwave, coffee pot, cable TV and free wi-fi, which satisfies the room requirement based on population. Last year we began listing our rooms on Booking.com and have consistently offered the most competitive rates in town all year long. New windows have been installed in all the hotel rooms. Alcoholic beverages are not stocked in rental rooms. Plentiful parking is available for hotel and bar & grill guests. We are located two minutes away from the Kenai Airport. The hotel lobby has been remodeled and is staffed 24 hours a day to assist guests. Assistance is available for travelers booking tours and fishing charters, as well as, directing guests to local tourist attractions. Freezer storage is available for departing guests.

Main Street Tap & Grill will continue to encourage tourism as it has, advertising in local hotel directories and on our Facebook business page with daily special updates and professional ads, event ads in the Peninsula Clarion, as well as advertising at the Kenai Oiler's baseball field and the Kenai hockey rink, Soldotna Sports Center and by supporting local non-profits. We have a 10' x 4' fixed business sign at the corner of Main Street Loop and Kenai Spur Highway. We are a member of the Kenai Chamber of Commerce and the Kenai Peninsula Tourism Industry. We offer entertainment five nights a week with World Tavern Poker on Mondays and Thursdays, local acoustic acts every Wednesday and Live Music or a D.J. on Friday and Saturday Nights.

This is a smoke-free facility. A heated patio is enjoyed by guests all year long. It has a large stage and dance floor with a superior sound and lighting system for the enjoyment of our guests. We have created an environment pleasing to all age groups. Booth, bar or table seating is available for small or large parties. The booths and chairs have been reupholstered and the table tops refinished. Future projects include a new draught tap system to accommodate 20 to 24 tap handles, of which 50% will serve Alaskan brews, new flooring and a digital business sign.


