Sassan Mossanen with Denali Brewing Company in Talkeetna, on the phone, speaks about "3 AAC 304.365 Package Store License Repackaging: The holder of a package store license issued under AS 04.11.150 may on the licensed premises repackage beer from kegs into other containers for sale on the licensed premises and consumption off the licensed premises, if the other containers are of a size permitted under AS 04.16.100." This regulation was put into place July 1, 2012 – would ask that the board consider a modernization of the administrative code regarding the repacking of beer, wine and spirits (Bob asks Sassan to repeat due to the phone breaking up)...to permit the consumer to purchase a single unit. Bob Klein suggests that staff opens a regulation project to look into it.

Elizabeth O'Malley, resident of Hope and on the phone, begins to speak about the renewal application of Creekbend Company #1381. Bob Klein says it is on the agenda and not the appropriate time to discuss.

Another caller, no name given, wishes to discuss Creekbend Company #1381. Bob Klein explains that is an agenda item and he advises her to keep listening.

James Hoelscher, Enforcement Supervisor, is present via phone and summarizes his report. He is available for questions or concerns.

Sara Erickson mentions his statement "certified as police officers but treated as inspectors" and asks for James to expand on his meaning.

James responds that she should look at the numbers and the outcomes of the investigations. It is very clear that the majority of what the investigators are doing is not beneficial to their capabilities. If there is no enforcement, there are no repercussions and if there are no repercussions people continue to break the law. They need the checks and balances in place and they need the tools to do that.

Sara Erickson says his explanation does not answer her question. She asks is there not enough investigators? James answers, No. It is the removal of APSIN the inability for investigators to safely conduct compliance checks and shoulder taps, the need to piggy back on other departments who do not have the time or resources to give to them to do things. It is a hindrance to the industry and the boards. James has to balance the safety of the investigators to the outcomes. Do not have under age purchasers available or MOU with any other agency/entity. Enforcement does employ enough trained investigators.

Director Klinkhart says the things James identifies in his report are symptoms that are fixable. Once the new deputy directors come on he will have time to spend with Enforcement and help them and the board to develop policies and procedures.

Carrie Craig summarizes her report.

Sara Erickson asks if licensees are penalized with late fees if the applications were submitted on time but determined to be incomplete. Carrie answers that applications that are turned in on time will not be deemed late and hit with late fees, regardless of their completeness.

Glenn Brady addresses the Director regarding moving the licensing function to CBPL. He appreciates all the hard work and plans to utilize technology.

Director Klinkhart says there are no changes the way we handle licensing and will not be changing staff however he is looking at how to leverage doing things online like credit card payments, agendas on an app, etc. How can we make the board's job and the licensee's job easier? Glen is open to suggestions, comments and questions.

Director Klinkhart provides the background information with the AG's opinion regarding two licenses operating in the same location.

Mike, the current president of the lodge is on the phone. He states they have held both licenses for 23 years and never violated the statutes. Never used both licenses at the same time, always one or the other. Why is this an issue now after 23 years? The diagram has not changed. He thanks Anchorage staff for their assistance.

Bob Klein states that club licenses are very restrictive of who can take advantage of that versus the flexibility of the beverage dispensary is something they wanted to take a look at.

Glenn Brady says he appreciates the confusion as a licensee and that things have been allowed in the past that should not have been at no fault of the licensee. The board and staff are trying to rectify the problem – trying to find a way to get the licensee out of this situation which should not have been allowed to exist over time. He asks is there anything with the club activities that they could not do without the beverage dispensary. Why the need to alternate the licenses?

Mike answers that he was not part of the original purchase and that they have complied with the law – diagrams are the same – 30 days (the phone cuts out through this portion). The two licenses are not operated at the same time.

Bob Klein cuts in and states that he has not answered Mr. Brady's question. If you have a dispensary license, why do you need a club license?

Mike begins to answer (the phone breaks up again) the club license handles the day – to – day operations and the beverage dispensary is strictly used for the general public like a wedding – not the club. They do not pay IRS taxes under the club license.

Bob asks how practical is it to keep both licenses but have separate premises? There are two different rooms with entrances. The licensee answers that the second option would work.

Charlie Cross asks the Director if he was able to get more research regarding the board's response to the AG's opinion. Glen Klinkhart answers no and it is suggested that staff looks further into the referenced case.

Bob Klein and the director requests that staff work with the licensee and research this further to bring back to the board to consider the renewal applications.

## • LEGISLATION UPDATE - AMCO

2:15 pm

A. Sara Chambers - Division Director; Commerce, Community & Economic Development

2:10 pm Sara Chambers, director of CBPL, is present. The administration is proposing to move AMCO into CBPL. This proposal is an administrative change. It will add to the resources at the board's disposal – access to the division's resources and expertise. This will do away with the Director's position and institute an Executive Administrator (EA) position – one for ABC and one for MCB. Admin, Licensing and Enforcement will be maintained as is. Streamlining at the top and giving the board more resources while maintaining existing assets. Sara provides a handout and provides an overview of the division.

Sara Erickson likes the proposal.

Sara Chambers says that this is a big deal for staff but at the end of the day it's business as usual with the core functions that you're doing. They are not coming into this with ulterior motives or design. It's about sharing resources. They will maintain physical records to make sure that they can account for what AMCO staff is doing and what is CBPL staff is doing and how are we helping each other out without inordinately effecting each other's budgets and/or work loads.

Bob Klein states that personally his comfort level is high.

Director Klinkhart says that if we get to the point where we do not need him, then we are doing a good thing. But the devil is in the details. We need to get there but we need to do it slowly. Go as fast as you can but as slow as you must to do it right. Is there legislation that needs to be heard before this goes through?

Sara Chambers says yes, no date yet but the legislation is forthcoming, sooner than later and she asks the board votes to support the bill on the record.

Joan Wilson, counsel speaks to her experience with representing licensing and that she has never seen any difference in service. This seems like an approach that accomplishes the board's aims.

Bob Klein reminds the board that they report to the Department of Commerce for administrative purposes. Bob states the motion to support the concept.

Glenn Brady moves to support the bill.

Sara Erickson seconds. None opposed, motion carries.

## The board requested additional consideration of this license regarding NOV and consideration of 2020/2021 renewal.

Stephen Thomas, licensee and Jana Weltzin, licensee's counsel are present.

Director Klinkhart provides background information.

Bob Klein says he has a problem finding where the violation is – operating outside of Title, outside of the law. Jana agrees. Her client was told to complete the permit application one way and it was also recommended to him to complete the AB-14. She does not see the actual citation for the violation.

Bob asks if the prior director was the one to suggest the AB-14. Jana confirms. Stephen thanks the board and the new director then outlines the history of his license and permit issues. The interpretation of the dinner permits, Form AB-06, changed with no communication. The partnering with a beverage dispensary was a short term solution. Erika McConnell encouraged the licensee to complete the AB-14 and since it had been submitted this past July 2019, the licensee has not received communication regarding the approval of the AB-14.

Bob Klein asks Mr. Thomas about the issues with his neighbors that does not involve the violation of Title 4. He had hoped that between the previous meeting and this meeting there would have been some community effort going on and that would come back to the board but they have not seen any information.

Jana Weltzin talks about Hope Inc. which created Hope Solutions Committee where they put two pro-Creekbend people and two anti-Creekbend people and one neutral individual. The neutral person investigated, took decimal readings and brought it back to the group. There were irreconcilable differences within the group. On 10/26/2019 Hope Inc. disbanded the solution group because it was not working and are going to revive the Advisory Planning Committee (APC) which is recognized by the Borough. To their knowledge, that group has not met yet. All of the public comments received came from 7 households and only 1 of those households are year round. They will begin to actively engage with the APC group.

Bob Klein says these issues do not belong with this board, they belong with the community and he hasn't seen any violations. He sees no reason to come down like a hammer on the licensee. He feels for both sides of the issue.

Jana Weltzin states the best way to keep everyone accountable is by getting the AB-14 approved. She is hoping to get some resolution regarding the AB-14 and Bob Klein says not today. Carrie Craig indicates that staff will get to work on it.

Glenn Brady says that he appreciates what Mr. Thomas is trying to do as a licensee and points out that the license types referenced in Mr. Thomas's letter are beverage dispensaries, not restaurant/eating place licenses.

Sara Erickson asks if we are just going to throw away the NOV. Bob confirms.

Phones are open for public comment.

- Josh, a caller, speaks in favor of Creekbend Company and appreciates Stephen's professionalism and business year round.
- A property owner a half mile away from the licensed premises states they want
   Creekbend to be a better neighbor. Excessively loud. Crowds with not enough facilities.
   Bob Klein responds that everyone has valid issues but these are not ABC issues it
   belongs in another environment, he appreciates the communication and has read all of
   the emails. The board can only adjudicate specific violations to Title 4.
- Jim Hockstead has lived in Hope for 25 years and about 1000 feet from Creekbend. He says Stephen Thomas misrepresents himself to AMCO and the community. The problem is the troopers are in Seward and Soldotna a very long turnaround time. There are parking issues 200 to 300 cars for a music event. Mr. Thomas is trying to turn Hope into a music fest for the Peninsula. Advertises in Anchorage and the more people he can get at \$20 to \$30 a head, the more money he makes. Mr. Hockstead says Mr. Thomas does not care about Hope, in it only for the money. Cash only after partnering with the beverage dispensary. He does not think that AMCO should issue any permits until they (the community) is sure that he is willing to work with the community. Bob Klein steps in and repeats the comment that these are issues that do not fall under the board's purview.

Sara Erickson motions that public comment be closed. Motion seconded.

Glenn Brady says they should keep public comment open for only valid comments.

Charlie Cross speaks about public safety issues. Not hearing anything about Title 4.

None opposed, motion carries.

<u>Tourism License Discussion</u>: Bob Klein asks the board if they still wish to see the Tourism applications separately. Glenn Brady says it would be nice to see them in a more condensed format but it is worthwhile for the board to see the licenses – just more streamlined. Sara Erickson agrees. Glenn Brady suggests a spreadsheet. Tourism license renewals are unique and can be streamlined and grouped and make a mass decision.

Bob Klein reminds the board that the previous administration suspected that the tourism licenses did not meet the room requirements and so they were split out to be reviewed and what was discovered was that statement regarding the room requirements was misinterpreted. They did meet the requirement when the license was issued, they just didn't keep adding rooms as the population expanded. Bob Klein will go over the need to separate the tourism licenses with staff and get back with the board with an approach.

Sara Erickson assumes that staff has already checked those requirements. Bob Klein concurs by pointing out the level of research and details provided in the memos.
