
Please find enclosed the Renewal License Application for my license #3637.

This is a notice to you as licensee that an alleged violation has occurred. On 7-22-19, I observed a male drinking an alcoholic beverage (beer) on the front porch of your establishment. After reviewing your licensed premises diagram, this area is not designated as part of your licensed premises.

Your attention is directed to AS 04.16.120: Removal or introduction of alcoholic beverages

You are directed to respond in writing to this Notice of Viciation within 16 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.

3 AAC 304.525 (B) provides that upon receipt of a Notice of Violation, a licensee may request to appear before the Director and be heard regarding the Notice of Violation. The request must be made within ten days after receipt of the Notice and the Director must grant an appearance within ten days after receipt of a request. A Licensee shall respond, either orally or in writing, to the Notice.
