To Whom It May Concern:

In response to the Notice of Violation that Black Spruce Brewing Company, LLC received on January 2, 2019 (AMCO Case # AM18-1535), the owners of Black Spruce Brewing Company have spoken directly with Randy Bezdek, owner of The Hungry Robot LLC, regarding the minimum age required to be present within Black Spruce Brewing Company's premises. Following the incident referenced in the Notice of Violation, which occurred on December 19, 2018, Mr. Bezdek staffed the indoor/on-premise register for his business either himself or with someone else over 21 years of age (age was verified by the owners of Black Spruce Brewing Company). Today, Mr. Bezdek informed the owners of Black Spruce Brewing Company that he has hired someone new and over 21 years of age to man Hungry Robot's indoor/on-premise presence full-time moving forward; again, this person's age will be verified by the owners of Black Spruce Brewing Company. In the event that the new hire is unavailable to work, the owners of Black Spruce Brewing Company have made clear to Mr. Bezdek that he will need to find someone else over 21 to work that station, work it himself or not sell his products at Black Spruce Brewing Company that day. The owners and employees of Black Spruce Brewing Company are diligent about checking customers' identifications and verifying ages. Since day one, we have refused service to and asked to leave our premise those who are not 21 or older unless accompanied by a parent, legal guardian or spouse or whose age we are unable to verify. We will continue to do so now and in the future.
