Requested Action:

Reinstatement and renewal

Statutory and Regulatory Authority: AS 04.06.090(b): "The board shall review all applications for licenses made under this title and may order the director to issue, renew, revoke, transfer, or suspend licenses and permits authorized under this title."

AS 04.11.540: "...If a complete application for renewal has not been filed by February 28 or the required fees and the penalty fees have not been paid by that date, the license expires at 12:00 midnight February 28."

- 3 AAC 304.160(f): "The board will deny a request for reinstatement submitted under (e) of this section if
  - (1) the license became available in accordance with 3 AAC 304.100(2) and was issued to a different applicant, unless the limit of licenses under AS 04.11.400 has not been reached; or
  - (2) the board finds that the failure to timely file or pay was caused by
    - (A) the licensee's failure to notify the board of a change of the licensee's mailing address;
    - (B) a transfer of ownership of the business for which the license was issued without written approval of the board in violation of AS 04.11.040;
    - (C) a lease of the licensed business to another person in violation of AS 04.11.450(c); or
    - (D) any other action of the licensee whether active or tacit that the board finds constitutes a failure to lawfully operate the business for which the license was issued."

**Staff Rec.:** Evaluate reinstatement request in accordance with 3 AAC 304.160(f)

**Background:** During the 2020/2021 licensing period, a renewal application was not submitted. The licensee was sent an expiration warning letter by mail on 2/10/2020. An expiration and cessation of operations letter was sent on March 9, 2019.

The licensee has submitted a request for reinstatement, request for a refund of the reinstatement fees and complete renewal application, and all required fees on 3/13/2020.

Dear Board Members,

Hello! My name is Rebecca Klauss. My husband, Adam Stout, and I own the Black Bear Coffee House in Denali Park. We missed our payment of the renewal of our liquor license and have submitted a restaurant renewal license application in an attempt to reinstate it.

Back in the winter of 2017/2018, we accidentally missed the renewal of our liquor license. It was a matter of a mail forwarding snafu, and just plain forgetting. Honest mistake. And you very graciously reinstated it for us. Thank you for that.

I mistakenly thought that since we had no use of our liquor license in 2018, due to the long process of reinstatement, and had submitted a Waiver of Operation Application for 2018, that our new license would be covering 2019 and 2020. I failed to realize that it covered 2018 and 2019. We have been traveling outside of Alaska and did not receive the renewal letters. I also was unable to reference our physical license since we are not in Alaska. It is my error that I did not contact the Alaska Alcoholic Beverage Control Board directly to check. But I felt sure that since we had not had it in 2018 and it was valid for two years, that it would be valid for 2019 and 2020. And so it slipped my mind.

In addition (going back to 2018) we were not made aware that our license had indeed *been* renewed, or of any board action that happened after the Aug 14, 2018 board meeting, until we inquired about it in the spring of 2019. The last communication we had was from Mikal Milton, after much correspondence, the evening of August 20, 2018:

The Reinstatement and Renewal of this license were considered at the August 14<sup>th</sup> board meeting. Documents and actions that occurred at this meeting are currently being processed. We thought that since we had not been notified of any board action, or been mailed a liquor license, that we were still in limbo, and closed for the season mid-September as usual.

Lastly, I am quite disappointed that we must still pay so much in fees, and not have been able to use our license in 2018 at all, been informed that it was valid, or even have received it in the mail after it was issued in 2018.

I am hereby requesting that we be issued our liquor license once again. I am also requesting that we please be waived the fees for late renewal and for reinstatement. I have already paid the \$2100 in cumulative fees.

I very much appreciate your consideration. Truly.
