Form AB-29: Waiver of Operation Application

What is this form?

This form is the means by which a licensee may request that the Alcoholic Beverage Control (ABC) Board waive the operating requirement of AS 04.11.330(a)(3) or (d). If a recreational site license has not been operated at least once in a calendar year, or if a license of any other type has not been operated for at least 240 hours in a calendar year, then a complete copy of this form and the corresponding fees must be submitted for that calendar year, per 3 AAC 304.170.

This application must be accompanied by a non-refundable waiver application fee of:

- for a 1<sup>st</sup> request, an amount equal to 1/2 the applicable biennial license fee; or
- for a 2<sup>nd</sup> or subsequent request, double the amount of the fee paid for the previous waiver application.

The ABC Board will determine whether, through no fault of the licensee or because the premises are under construction, the licensed premises could not be operated for the required time during the calendar year. The ABC Board may impose conditions along with the approval of an application for waiver, and it may deny a third or subsequent application for waiver. If an application for waiver is denied, an application for license renewal for the succeeding license period will be denied by the Board. In addition to the waiver application fee, the applicant must pay a late fee of \$1,000 for an application that is received too late for Board consideration at its meeting before November 30 of the year for which the waiver is requested. Please check AMCO's website for meeting agenda deadlines.

Please note that a licensee must submit a separate completed copy of this form and pay a separate corresponding fee for each license and for each calendar year during which a license was not operated in compliance with AS 04.11.330.

### Section 3 – Reason for Non-operation

Provide an explanation as to why the licensed premises were not operated:

For decades Henri Hawaii, Inc., was managed and operated under the direction of the late James W.Y. Wong. even though he appointed his sons Darryl and Warren Wong as officers of Henri Hawaii, Inc. Even at the age of 95 Mr. James Wong managed the operations of Henri Hawaii, in addition to the multitude of other businesses he ran in Alaska, Idaho, California, Nevada, and Washington. The current president of Henri Hawaii, Inc., Darryl Wong, son of James Wong, supported his father in his business operations and management, but the day to day over seeing of operations and ensuring the businesses were by and large operating smoothly rested upon Mr. James W.Y. Wong's shoulders. James W.Y. Wong's health started to decline in 2017, and he ultimately passed on November 22nd, 2017, the day before Thanksgiving, at the age of 95. Up until his death, James Wong handled all the business operational affairs. Mr. Darryl Wong, James' son, was appointed as his father's trustee and therefore tasked with managing and transitioning his father's entire estate, including his businesses, real property holdings, the issues that surround those types of interests, and of course wrapping up his father's personal affairs. On top of everything, the staff members that worked under James Wong's direct supervision left the company to pursue their own professional aspirations. However, before they left, but sometime after James W.Y. Wong's passing, they informed Darryl Wong that the license was in good standing for the last two years, but after further review and engaging new staff, Darryl Wong learned that the business was not meeting the minimal operational requirements. 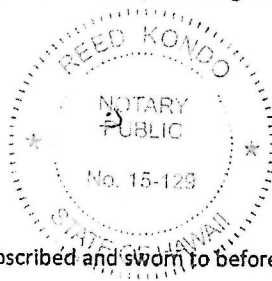

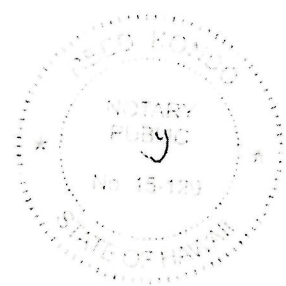

Due to the fact Darryl Wong is learning how to manage and operate the multiple other businesses and real estate holdings in his father's estate, the Wong family determined it would be in the corporation's best interest to transfer this license to an existing restaurant operator who current holds a beer and wine license to operate and own the Henri Hawaii license. This waiver is accompanied not only by the license renewal application, but also by a transfer application. The license will be operated by the new owner - who currently operates a restaurant or eating place license at the location - as soon as the transfer of this license is approved by the board. Therefore, in order to ensure the license was operated for the number of hours required for the year of 2019, Henri Hawaii was operated for 240 hours in the year of 2019. Additional, at the ABC meeting in September held in 2019, the ABC approved the waiver request for 2017, and explained in the third waiver application that the company was actively in negotiations with a party to take over the license. The ABC board approved the waiver and did not indicate or state on the record, as it usually would if it was inclined to deny a 4<sup>th</sup> waiver, that a 4<sup>th</sup> waiver would not be granted by the ABC board.

On 2/25/20 I was provided an AB-30 proof of minimum operating hours form with supporting documentation for Henri Hawaii. Earlier this fall I performed an inspection on Henri Hawaii. I noted that they had alcohol stocked in the business and it looked ready to operate. The manager was knowledgeable and was aware of the minimum operating requirements.

Reviewing the supporting documentation it appears as though they were open on 41 days. They operated a minimum of 6 hours on those days. They were open 9 hours on Saturdays. They operated a minimum of 246 hours in October and November of 2019. Invoices from Specialty Imports shows that they ordered alcohol in September and October.
