



#### Hey John,

I just called but you were out for the afternoon. I spoke with another lady that was super helpful and very nice.

Wherever you see the red line going outside of the border of the actual property walls, this is where we plan to have some patio areas.

The security plan for the patio areas that you see illustrated outside of the actual structure diagram shall be:

We will have a dividing area between the patio and the parking lot and that would include probably some  $6 \times 6$  posts buried in the ground with chains or ropes in between them. 3 foot high.

Staff will be regularly monitoring my walking in and out, but also will be able to observe through multiple windows in these locations and garage doors in the summertime that will also be open. There will be only one entrance into this patio area from inside of the building and one exit from the patio area to the parking lot.

There will also be security cameras on the outside of the building.
