This is a notice to you as licensee that an alleged violation has occurred. If the Alcoholic Beverage Control Board decides to act against your license, under the provisions of AS 44.62.330 - AS 44.62.630 (Administrative Procedures Act) you will receive an Accusation and Notice of your right to an Administrative Hearing.

Note: This is not an accusation or a criminal complaint.

On 4-30-19, a walk through was conducted at the "Houston Lodge", now named "Triple J Roadhouse". The building is separated and advertised as two different businesses, The "Houston Lodge" for the lodge portion and "Triple J Roadhouse" for the beverage dispensary licensed premises/restaurant. The BDL is advertising their license premises as "Triple J Roadhouse"(Photos provided), when their DBA on file is "Houston Lodge".

Inv. Hamilton spoke with Jessica Briles who identified herself as the owner along with her husband, James Briles. AMCO records indicate the establishments dba is Houston Lodge and is owned by Doris Jane Incorporated. Briles is listed as being an 8% share owner of Doris Jane.

Please review attachment as proof the establishment has been renamed Triple J Roadhouse

Your attention is referred to 3AAC 304.185: Licensed premises

You are directed to respond in writing to this Notice of Violation within 10 days of receipt to explain what action you have taken to prevent a re-occurrence of this violation. FAILURE TO RESPOND TO THIS NOTICE OF VIOLATION WITHIN 10 DAYS WILL RESULT IN YOUR APPEARANCE, EITHER IN PERSON OR TELEPHONICALLY, BEFORE THE ABC BOARD AT THEIR NEXT REGULARLY SCHEDULED BOARD MEETING.

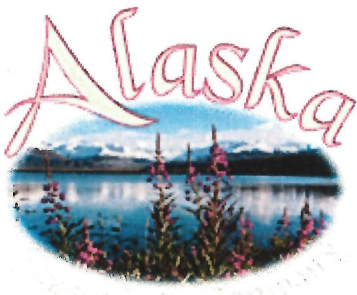

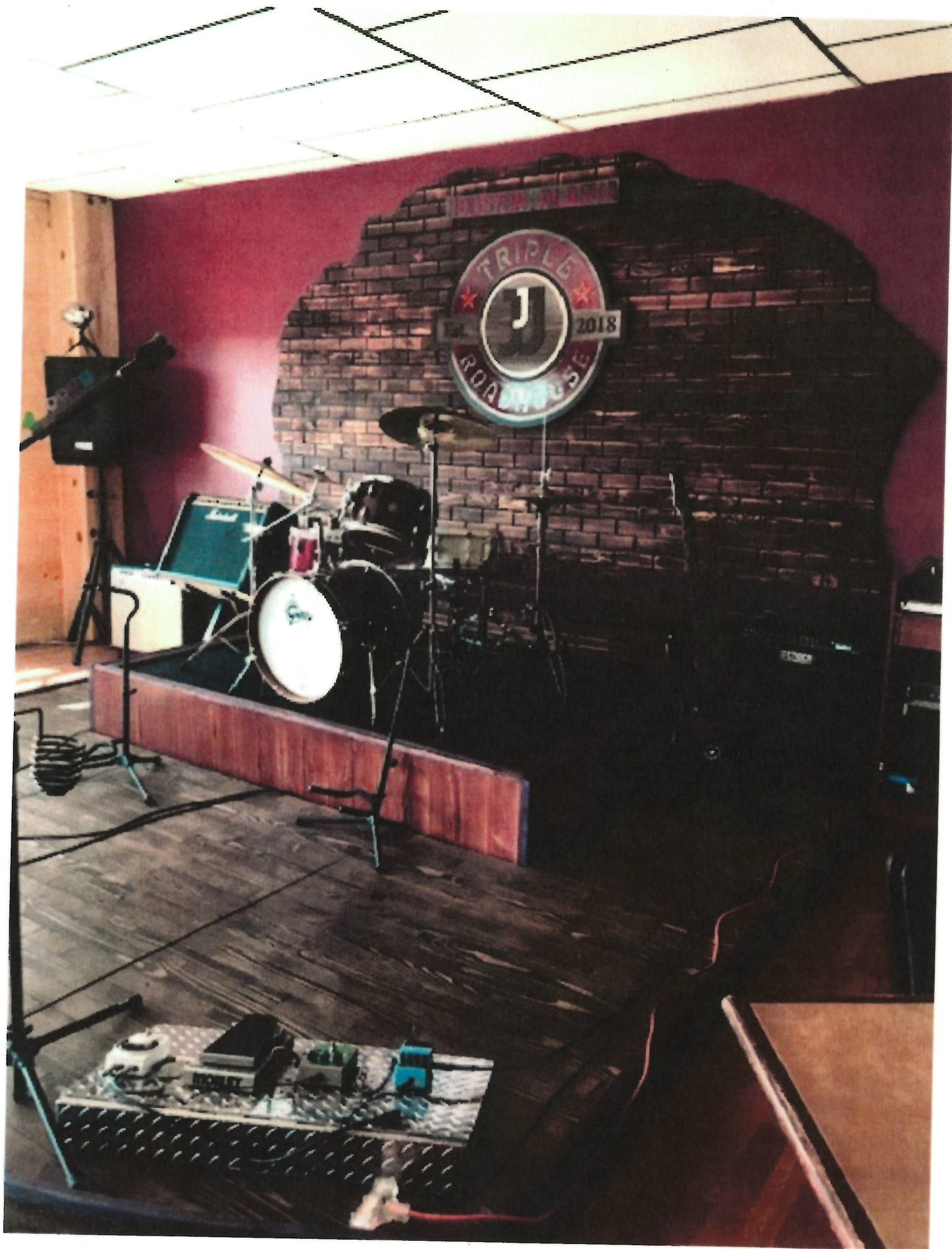
